Terms and Conditions

Who is the organiser?

 The organiser of the Contest is On AG (company no. CHE-115.332.641), whose registered office is at Förrlibuckstrasse 190, 8005 Zürich, Switzerland (hereinafter referred to as the "Contest" or "Raffle" and "On" or "we" respectively).

Who may participate?

- 2. Employees of On, their close relatives and anyone otherwise connected with the organisation of the Raffle, are excluded from participation.
- 3. By participating in the Contest in accordance with the provisions as outlined below, you are indicating your agreement to be bound by these Terms and Conditions.

What is the Raffle?
