EVENT# 01141 IN SUMMARY R/O'S RESPONDED TO A PERSON SHOT AT ABOVE ADDRESS. UPON ARRIVAL R/O'S OBSERVED ROBERT ALLEN (VICTIM) LAYING ON THE GROUND FACE DOWN WITH A GSW TO THE LEFTSIDE AND UNRESPONSIVE. CFD TRUCK#20 AND AMBO #14 WERE ON SCENE AND TRANSPORTED ROBERT ALLEN (VICTIM) TO COOK COUNTY HOSPITAL AND WAS PRONOUNCED DEAD AT 0322 HOURS. R/O'S SPOKE TO [REDACTED] (WITNESS) AND [REDACTED] (WITNESS) WHILE ONSCENE WHO STATED THAT THEY SAW ROBERT ALLEN (VICTIM) EXIT HIS VEHICLE WHICH WAS PARKED IN FRONT OF [REDACTED] (WITNESS) [REDACTED], ACROSS THE STREET FROM HIS RESIDENCE. ROBERT ALLEN (VICTIM) WAS WALKING TOWARD THE REAR OF THE HOUSE ON THE SOUTHSIDE. WHEN A TAN CAMRY PULLED UP AND THEY HEARD 3-4 SHOTS. [REDACTED] (PERSON DISCOVERING) HEARD THE SHOTS, WENT OUTSIDE AND SAW ROBERT ALLEN (VICTIM) LAYING IN THE LOT NEXT TO THE RESIDENCE AND CALL 911. NO SHELL CASINGS WERE FOUND ON SCENE AND OFFENDING VEHICLE DROVE OFF IN AN UNKNOWN DIRECTION.
