# JURY FOR THE **CSR HEALTH IMPACT AWARDS**



- The applicant organization must be a company or CSR foundation/trust or an implementing partner for CSR project and the project must have been supported by a company/CSR Foundation under its CSR initiative.
- The applicant entity must have legal status as company/NGO/trust and be registered in India.
- All Indian companies and foreign firms with registered business operations in India can apply.





## Award Entry Process



# Option 1

**If you'd like to make an online payment through our website**

## **Step 1 – Payment**

- Decide on how many awards you would like to submit entries for.

- The total size of the documents should not be above 20 MB.

- **Project duration** - the nominated initiative has to have completed at least 13 months on-the-ground by March 31st 2017.

- A participating organization/individual can send entries in more than one award category/apply multiple times in the same category provided it is for a separate innovation/project/initiative.
- A separate form should be used for each application entry.
- The Awards focuses solely on the particular project / initiative that the organization has taken.
- You, as a participant, declare that the information provided in this entry form is correct and accurate to the best of your knowledge and that you agree to abide by the rules and regulations of participation.
