“A Resolution Declaring LIG Nex1 Co. Ltd., as Post-Qualified and the Single Calculated Responsive Offeror (SCRO), and Recommending the Issuance of Notice of Award in its Favor, for the Frigate Acquisition Project Lot 3A (Torpedoes) of the Philippine Navy”

WHEREAS, on 01 February 2020, the Secretary of National Defense issued Acquisition Decision Memorandum (ADM) No. 2020-005 directing the immediate implementation of the Frigate Acquisition Project Lot 3 (Torpedoes, Chaffs and Acoustic Decoys) of the Philippine Navy (PN) with an Approved Budget for the Contract (ABC) amounting to PhP1,700,000,000.00, delineated as follows:

WHEREAS, on 17 July 2020, SND approved the recommendations of the DND Bids and Awards Committee 1 (Committee, for brevity) under DND BAC Resolution No. DND/PN-FAP3A-20-01 dated 23 June 2020, (1) to undertake the project through, Direct Contracting pursuant to Section 50(c) of the RIRR of R.A9184, (2) to approve the Terms of Reference (TOR) for the project, (3) to approve the proposed project timelines, and (4) to designate the Committee to sit En Banc as the Negotiating Committee for the project;

WHEREAS, the Committee conducted the Pre-Negotiation and Negotiation Proper Conferences for the project on 10 December 2020, where LIG Nex1 Co. Ltd. (“LIGNEX”, for brevity) was found to be compliant with all legal, technical and financial requirements of the project, with a price proposal in the amount of **USD15,936,900.00 (PhP766,262,088.90)** and was declared as the Single Calculated Offeror (SCO), subject to the conduct of Post-Qualification (PQ);

WHEREAS, pursuant to the guidelines set by DC12 s.2020, the PQ Team conducted the post-qualification on LIGNEX on January 26-28, 2021, via video-teleconferencing and with the assistance from the Philippine Defense and Armed Forces Attachè (PhilDAFA) in South Korea;

WHEREAS, on 04 February 2021, the PQ Team presented the results of the post-qualification on LIGNEX and recommended that LIGNEX be declared as post-qualified and the Single Calculated Responsive Offeror (SCRO), and that the Notice of Award be issued in its favor;

WHEREAS, the Committee after due deliberation, resolved to approve the recommendations of the TWG to declare LIGNEX as Post-Qualified and the Single Calculated Responsive Offeror (SCRO) for the project, and to recommend to the SND, as the Head of the Procuring Entity (HoPE), the issuance of Notice of Award in its favor;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, resolve, as it is hereby **RESOLVED**, to approve the following:

- a. to declare LIG Nex1 Co. Ltd. as post-qualified and the Single Calculated Responsive Offeror for the Frigate Acquisition Project Lot 3A (Torpedoes) of the Philippine Navy; and
- b. to recommend to the SND, as the HOPE, the issuance of Notice of Award in favor of LIG Nex1 Co. Ltd.
