Be guided accordingly.

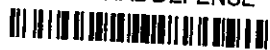

“A Resolution Declaring Naval Group as Post-Qualified and the Single Calculated Responsive Bidder (SCRB) and Recommending to the HoPE the Issuance of Notice of Award in its Favor, for the Frigate Acquisition Project Lot 3C (Acoustic Decoys) of the Philippine Navy”

WHEREAS, on 10 February 2020, the Secretary of National Defense issued Acquisition Decision Memorandum (ADM) No. 2020-005 directing the immediate implementation of the Frigate Acquisition Project Lot 3 (Torpedoes, Chaffs and Acoustic Decoys) of the Philippine Navy (PN) with an Approved Budget for the Contract (ABC) amounting to PhP1,700,000,000, delineated as follows:

WHEREAS, on 27 November 2020, the SND approved, among others, the recommendations of the DND Bids and Awards Committee 1 (Committee, for brevity) through DND BAC Resolution No. DND/PN-FAP3C-20-01 dated 05 November 2020, to undertake the project through Limited Source Bidding pursuant to Section 49 of the RIRR of Republic Act 9184;

WHEREAS, after the conduct of Submission and Opening of Bid Envelopes (SOBE) on 16 February 2021, Naval Group was declared as the Single Calculated Bidder (SCB) for the project with a price proposal in the amount of 6,336,000.00 Euros or equivalent to **PhP368,538,508.80**, with the BSP exchange rate of 1 Euro=PhP58.1658, vis-à-vis the ABC for Lot 3C in the amount of PhP450,000,000.00. Subsequently, the Committee directed the conduct of post-qualification (PQ) to determine the responsiveness of the SCB's proposal pursuant to R.A 9184 and its RIRR (Rule X on Post Qualification), through DND BAC Resolution No. DND/PN-FAP3A-20-02 dated 10 December 2020;

WHEREAS, pursuant to Section 3.5 of Department Circular No. 12 dated 02 July 2020, the PQ Team conducted the post-qualification on Naval Group on 15-16 March 2021, via video conferencing with the assistance of the Philippine Defense and Armed Forces Attaché (PhilDAFA) in Spain;

WHEREAS, on 15 April 2021, the PQ Team presented the results of the post-qualification on Naval Group and recommended that it be declared as Post-Qualified and the Single Calculated Responsive Bidder (SCRB), and for the


