A/O MCMAHON #17102 ASKED DRIVER FOR DRIVERS LICENSE AND INSURANCE. DRIVER WAS UNABLE TO PRODUCE A VALID DRIVERS LICENSE AND WAS PLACED IN CUSTODY. A/O'S ASKED ALL OCCUPANTS TO EXIT VEHICLE. AFTER A/O MCMAHON WAS ABLE TO REMOVE THE DRIVER AND THE REAR DRIVERS PASSENGER, A/O'S HIGGINS #11727 ASKED FRONT SEAT PASSENGER, (DWAYNE TIMBERLAKE (ARRESTEE) TO EXIT VEHICLE.
