#### Industrial performance of Woolworths Ltd





The trend of sum of Australian Food for Year.



# BigW sales




BigW also exhibits increased sales during 2016-2020. The sale was less during 2017 and 2018.

### **Endeavour Drinks**





Declining sales of home improvement products were remarkably observed during 2019 and fell as nil sales during 2020 in the Covid19 pandemic scenario.


# New Zealand food product sales 2016-2020



The trend of sum of New Zealand Food for Year.


New Zealand food sales shows high sales during 2016 to 2020. The peak sales was observed during 2020.

### Other product sales 2016 - 2020




The sale of other uncategorized products were extremely low during 2018 and high sales were observed during 2019 to 2020.

### Petrol sales during 2016 – 2020





# $Total\ product\ sales\ 2016-2020$




The overall food product sales of Woolworths show steady decline during 2016 – 2020.




The observed gross sale shows slight increase during 2016 - 2020.

### **Gross Profit**




The gross profit of the company showed steady increase during 2016 - 2020 Net profit




The declining net profit during 2016 - 2020 is due to the net decline of sales from different retail products sold by the company especially petrol.

### **Total Profit**




The total profit before taxes were quite high during 2017 to 2019. It was declining during last year due to sales decline.

#### Cost of sale vs Total sales




The cost of sales and total sales comparison revealed that cost of the sales reduced during 2016 – 2020. Sales of total products of Woolworths are higher.

# Average 95% CI of EBIT to sales




The average EBIT is 3140 and achieved during 2018.
