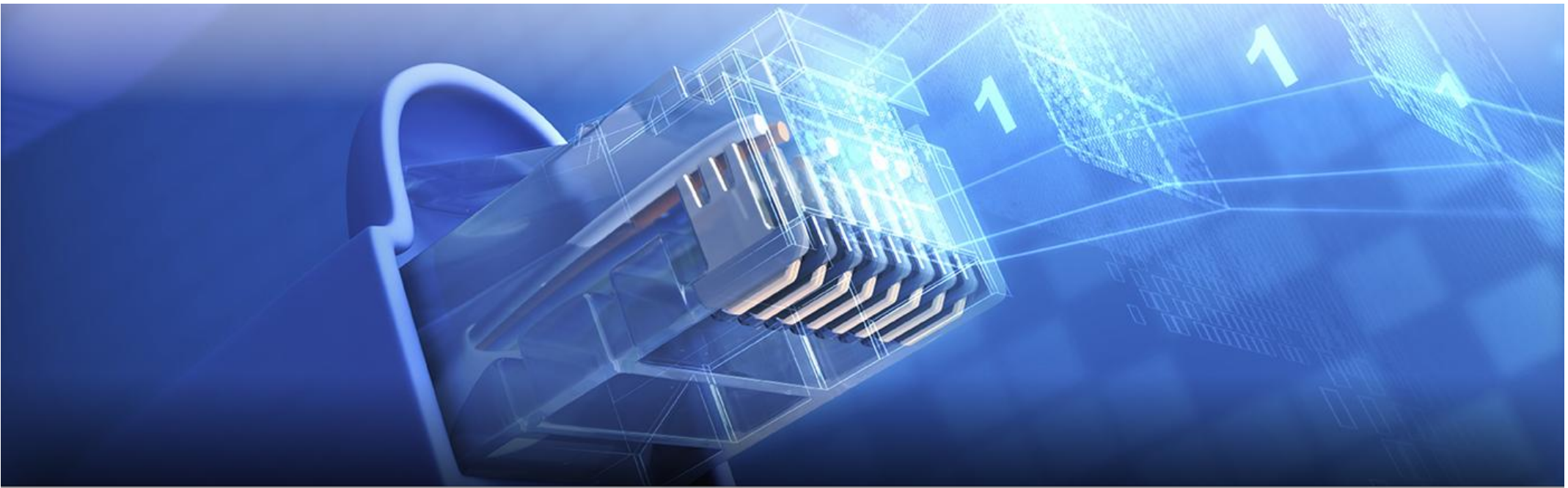
Board of Directors' words

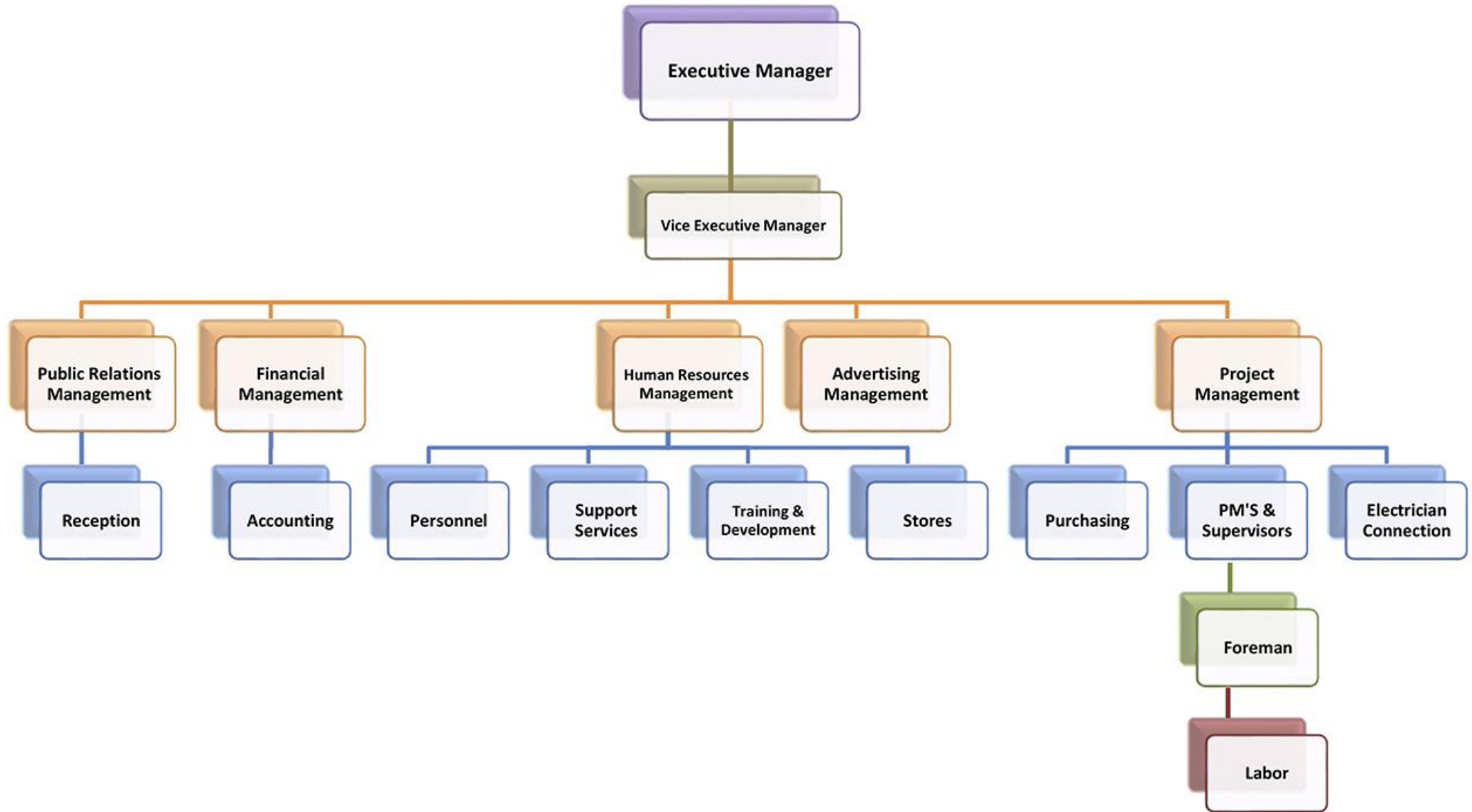

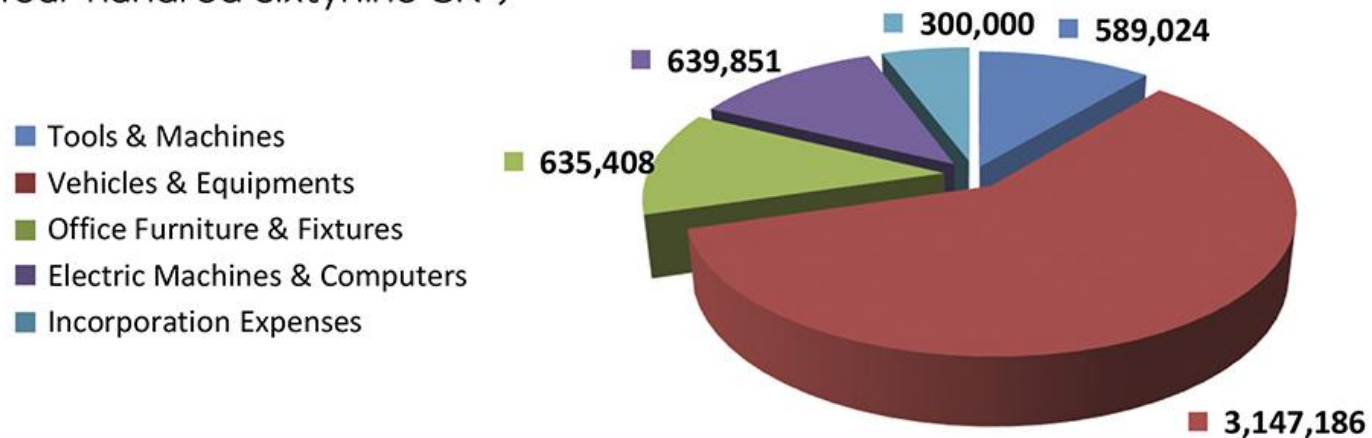

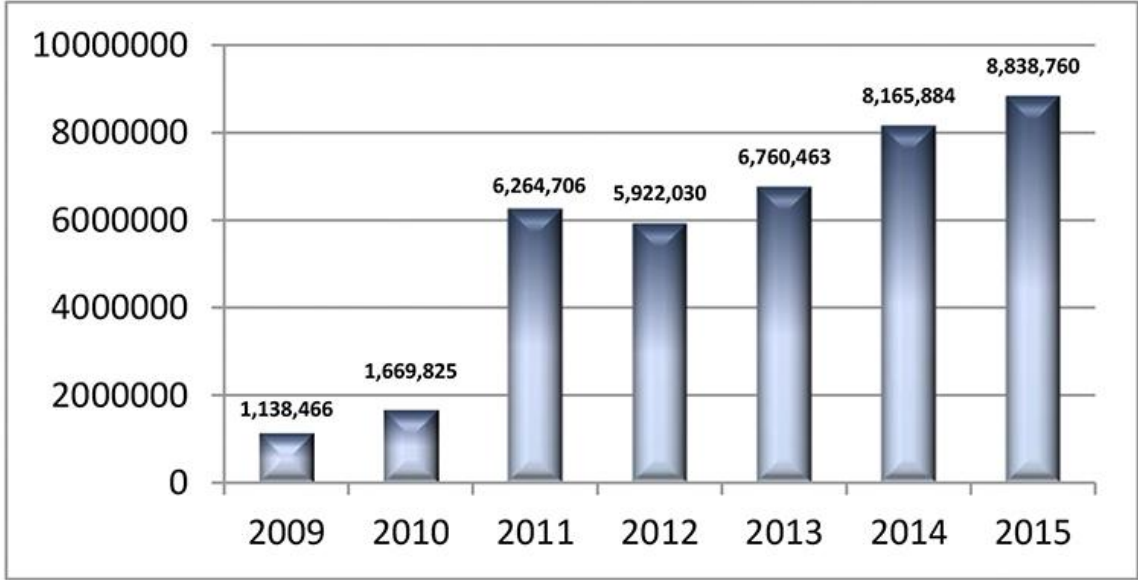
Fixed Assets

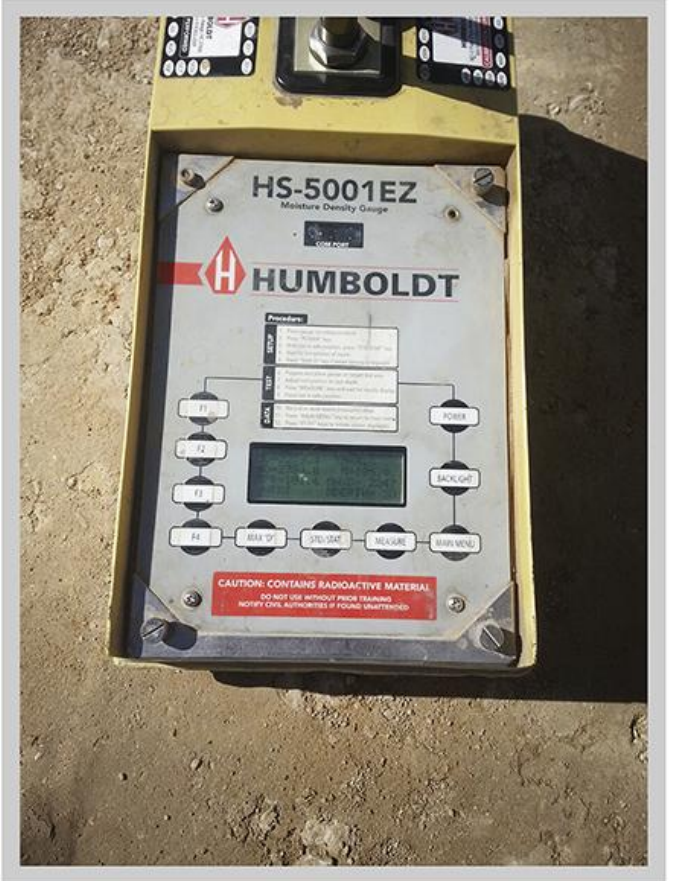
