AFFIDAVIT IN SUPPORT OF AND  
PETITION FOR SEARCH WARRANT

Personally appeared before me this 13th day of August, 1949, the affiant,  
WILLIAM C. GLEASON a peace officer,

who, on oath, makes complaint, and deposes and says that he has and there is probable and  
reasonable cause to believe, and that he does believe, that there is now on the premises located at  
and also described as 12000 Santa Susana Road, Chatsworth, commonly known  
as Spahn Movie Ranch, consisting of approximately 200 acres of open  
ranch land, including all buildings, storage rooms, vehicles, garages  
and outbuildings of any kind located thereon,

~~and in (or) vehicle(s) described as~~

and on the person(s) of Charles Filles Fanson, aka Charles Filles Summers,  
5'7" in height, weighing 140 pounds, brown hair, brown eyes, DOB  
11-11-34, with a tattoo of a woman's head on each arm, and a one

inch scar over his left eye,  
the following personal property, to wit: stolen automobile parts, including but  
not limited to VW frames, engines, transmissions and parts thereof,  
and rifles, automatic pistols and revolvers.



1 Your affiant says that there is probable and reasonable cause to believe and that he does  
2 believe that the said property constitutes: (CHECK THE APPROPRIATE BOX, OR BOXES)

3 (  ) — stolen or embezzled property;

4 (  ) — property or things used as the means of committing a felony;

5 ( ) — property or things in the possession of a person with the intent to use it as a

12 Your affiant says that the facts in support of the issuance of the search warrant are as  
13 follows:

14 Your affiant has been a Deputy Sheriff for the past  
15 10 1/2 years, employed in such capacity by the Los Angeles Sheriff's  
16 Department, and has acted and  
17 received the information set forth in this affidavit in that capacity.

18 Your affiant is now and has been for the past 15 months ~~years~~ assigned  
19 to the Technical Services Division ~~ISD~~ thereof.

20 On the date of August 9, 1969, 196 ~~9~~, ~~approximately~~ ~~at~~  
21 your affiant ~~and Sergeant Douglas at~~  
22 Palms Sheriff's Station, contacted Officer Ted Leigh, #1907, Los  
23 Angeles Police Department, Devonshire Division, Juvenile Bureau.  
24 Leigh stated that he flew over the Spahn Foyie Ranch approximately  
25 August 1, 1969, and at that time he observed a 1969 Volkswagen laying  
26 in a ditch South-West of the main ranch complex. Since that date,  
27 Leigh has determined the Volkswagen to be a stolen vehicle. It is  
28 a Volkswagen that was taken from the Dick Joyce Volkswagen Agency in  
29 Van Nuys, reported stolen July 15, 1969, under file #DR 69-052 838.  
30 The vehicle was unregistered at the time, but bore identification  
31 #119 766 O41. Leigh stated that the vehicle was further identified  
32 by officers Slawson and Despain, Los Angeles Police Department,

1 ~~XX~~

3 Devonshire Division-Patrol, who walked into location, checked vehicle,  
4 but did not impound it. Devonshire Division Detective Noeller is  
5 handling that investigation.

6 Officer Leigh also stated he was at the Spahn Ranch on approxi-  
7 mately July 21, 1969, with Homicide Bureau Sergeants Sholund and De La  
8 Fuente who were conducting the murder investigation of Mark Watts,  
9 male caucasian, 16, whose body was found in Malibu Station area  
10 recently.

11 Officer Leigh observed a new gasoline tank for a Volkswagen in  
12 the corral at this location. He also observed a gray Volkswagen  
13 microbus on the property. This bus is equipped with a two-way radio.

14 Officer Leigh has received three loaded "Banana" clips for a  
15 .30-caliber carbine which were found on or about July 29, 1969, by  
16 Devonshire Division Patrol officers. The clips apparently fell from  
17 a dune buggy while on the highway. Officer Leigh has been contacted  
18 by the person known as Charles Hanson, mentioned in prior memos. ~~Mr.~~  
19 Hanson told Leigh that the clips belonged to him, but as yet has not  
20 picked up the clips from Officer Leigh.

21 Sergeant Douglas and your affiant also contacted Officer Williams,  
22 #13814, LAPD, Devonshire Division. Officer Williams stated that  
23 within the last two weeks he and his partner were on duty at the  
24 Spahn Ranch in a marked police vehicle. The officers were talking  
25 with Charles Hanson, and Mr. Hanson was bragging to the officers  
26 about the weapons available to him and his friends at the ranch. Mr.  
27 Hanson told the officers that while he was talking to the officers  
28 that his friends had rifles trained on the officers; also, Hanson  
29 indicated this is standard procedure whenever officers approach the  
30 ranch.

31 On August 10, 1969, your affiant proceeded to Devonshire Division  
32 Detective Bureau and checked a recent arrest package of the above-

1 ~~Nothing is being reported in this matter, or stated in this memorandum.~~  
2 ~~Additional thereto, you will find enclosed the following for the independent investigation file with~~  
3 mentioned Charles Hanson. He was booked June 4, 1969, on a rape  
4 charge. This arrest was the outgrowth of a rape that occurred at the  
5 Spain Ranch, and it is being handled by Palms Station. Hanson was  
6 booked and Devonshire Division Case #DR 69-469 997 assigned. During  
7 the interview by the investigators, Hanson told the officers he was  
8 on Federal Parole for Grand Theft Auto, and he stated he has served  
9 time in Terminal Island and San Redil Island Federal Prisons.

10 On August 10, 1969, your affiant contacted the owners of the  
11 above-mentioned Dune Buggy Shop at 10202 Topanga Canyon, Chatsworth.  
12 The business is named "Butler's Dune Shop," phone 633-2012. It is  
13 owned by Phil and Dale Butler. Phil Butler is a Los Angeles Police  
14 Officer assigned to Valley Services Division Jail—AM shift.

15 Dale Butler is the manager of location and knows Charles Hanson.  
16 Dale Butler said he has always conducted business with Charles  
17 Hanson on a cash basis. Charles Hanson recently purchased two dune  
18 buggies from location, paying for both in the amount of \$2,300.00 in  
19 \$100 bills. Dale Butler said Hanson normally carries large sums of  
20 money. Hanson recently purchased a dune buggy without an engine from  
21 Dale Butler.

22 Dale Butler stated that he recently purchased a 1966 Volkswagen  
23 from a friend of Charles Hanson identified as Patricia Joan Baldwin,  
24 21019 Graham Street, Canoga Park. After the purchase, the engine  
25 was removed from the vehicle and placed in one of the dune buggies  
26 owned by Hanson. The engine placed in the dune buggy bore #F0392021.  
27 On April 9, 1969, Dale Butler learned that the rest of the above-  
28 mentioned 1966 Volkswagen purchased from Miss Baldwin was stolen from  
29 Butler's rear storage yard. This was reported to Devonshire Division  
30 under file #DR 69-027 543. Since that theft, Dale Butler received  
31 information from Los Angeles County Fireman Witt, Engine Company  
32 #75, that Fireman Witt observed the Volkswagen and other parts stolen



1 ~~Acting on the information your affiant has received, he stated in this affidavit, and in~~  
2 ~~addition thereto, your affiant has conducted the following further independent investigation:~~  
3 into the ranch Walker observed two guys and two gals shooting in a  
4 car behind the ranch and when "Jack" was asked if he knew about the  
5 shooting going on, Jack said, "Oh, yea. They are some of our people."  
6 Walker told him he thought perhaps they were shooting at the ranch  
7 and on the people there and Jack then said, "No, we have a guard at  
8 each road in with a rifle and a telephone so if anyone comes in  
9 we'll know they're coming."

10 On the same day or before, Walker saw a VW bus white and red  
11 parked up the canyon from the ranch somewhat hidden in the bushes, a  
12 grubby, raunchy looking hippie type vehicle (possibly a hot car).

13 On August 1, 1969, your affiant received information from  
14 Deputy Samuel J. Olmstead, #2504, LASO, that at approximately 1:10  
15 AM on July 28, 1969, he had received a call from LAPD dispatcher  
16 reporting one of their units requests a Sheriff's unit on Topanga  
17 Canyon just north of Chatsworth Street regarding possible stolen  
18 vehicles. At approximately 2:30 AM, Car 102 EM requested assistance  
19 from 100-S, 101 EM, and CIP units in the area. He arrived at location  
20 at approximately 3:15 AM, and Deputy E. A. Loobey, #2585, advised me  
21 that LAPD had run two vehicles at the Spahn Ranch, and both had come  
22 back as stolens.

23 At the location was a possible member of the "Satan Slaves" by  
24 the name of Summers, who was acting as a lock-out for the group of  
25 "Slaves" staying at Spahn Ranch. Summers advised Deputy Samuel J.  
26 Olmstead, #2504, that his group anticipated an attack by the "Black  
27 Panthers" and several of the people at the ranch are armed. Summers  
28 was allowed to accompany Olmstead to the location in order to help  
29 him round up the others in order to determine who the stolen vehicles  
30 belonged to. Unknown to Olmstead, there was a field telephone system  
31 at the location, and, as soon as the officers arrived, the alarm  
32 was sounded and the only persons found were those who were asleep

~~Management of the information on your off and had received, or collected in this office, and~~  
~~Management of the information on your off and had received, or collected in this office, and~~  
and didn't wake up with the alarm.

A walk-through check of the main buildings of the ranch disclosed eleven persons, as follows: Charles Killes Summers, F/3/35; John Harold Swartz, F/27; Larry Eugene Craven, F/29; Jason Lee Daniels, AKA Daniels, F/22; Robert John Nelson, F/27; Lynn Alice Frazee, F/20; Ruth Ann Houwvohert, F/17; Jacqueline Lee Knoll, F/26; George Harry Knoll, F/28; Arnold Edward Vitasek, F/20; and Jack Paul McMillan, F/26. Of the above, suspect John H. Swartz was arrested for 4453 CVC re: stolen plates on his vehicle at the Spain Ranch.

While checking the buildings, Olmstead and other officers came across one fully loaded .30-caliber carbine, one loaded 301 British in-field, and a .22-caliber rifle.

Olmstead asked one of the subjects where the rest of the group was, and he pointed in an easterly direction and stated, "over behind these rocks." Olmstead said, "let's go wake them up," and he stated the only way to reach them is by dune buggy.

Olmstead and other officers checked a small residence northwest of the main building, on a dirt road approximately 3/4 mile away from the ranch house. The house was empty of furniture, but there was evidence that someone had been there just prior to Olmstead's arrival. On the floor was approximately eight bed rolls. Around the door, stuck in the wall, were about six or eight toyenets, and on the floor near the door was a box (200 rounds) of .32-caliber bullets. Also in this house was a military type crank field phone, the same as those observed in the main building and house trailer just north of the main building.

After talking to the persons at the location, Olmstead was of the opinion that there is a fairly large number of people scattered throughout the ranch area and on surrounding ranches in old buildings.

4 On August 1, 1969, your affiant received information from a  
5 property owner named Harry H. Esplin (Crest Haven Ranch, Fern Ann  
6 Falls) who related that at about 6:00 P.M. on August 1, 1969, he  
7 saw two cyclist-type individuals walking east along the highway from  
8 the Spahn Ranch. Both individuals were carrying rifles and appeared  
9 to be looking for something off of the south shoulder. He stated  
10 that the weapons carried either had external ammunition clips or  
11 handles (strips) to the front. No better description of suspects  
12 could be given. He claims to have heard automatic weapons fire  
13 during the evening hours, coming from the hills behind his ranch (the  
14 area of Devil Canyon and Ybarra Canyon). He feels that the weapon  
15 being fired was larger than a rifle, due to the loudness of the  
16 reports.

17 Your affiant has also learned that the Los Angeles Police  
18 Department Headquarters Auto Theft is also conducting an investiga-  
19 tion at the ranch. Approximately July 15, 1969, Officer Breckenridge,  
20 while conducting an investigation at the ranch, flew over the area  
21 in a helicopter. He observed at least three Volkswagen floor pans  
22 which were in the area south of the main ranch buildings near the  
23 above-mentioned semi-trailer.

7 hence, for this reason and because of the other information received from said informant(s)  
8 and from the personal observations set forth elsewhere in this affidavit, your affiant requests that

AFTER REVIEWING THE FACTS, MR. SCHIRM ISSUED SEARCH WARRANT #2029 ON 8-13-69. THE SEARCH WARRANT WAS THEN SIGNED BY JUDGE JOHN MERRICK, MALIBU JUSTICE COURT.

AT THE ABOVE DATE AND TIME, SGT. GLEASON AND VARIOUS UNITS OF THE SHERIFF'S DEPT. UNDER THE COMMAND OF INSPECTOR JOHN GRAHAM, PATROL DIVISION WEST, PROCEEDED TO THE LOCATION PURSUANT TO THE SEARCH WARRANT.

UPON COMMAND, THE WRITER AND SEVERAL DEPUTIES WENT TO THE FRONT DOORS OF THE MAIN BUILDING, KNOCKED ON THE DOORS, AND ANNOUNCED THE PRESENCE OF DEPUTY SHERIFF'S BEING AT LOCATION TO SERVE A SEARCH WARRANT. AFTER THIS ANNOUNCEMENT, SEVERAL PERSONS WERE HEARD AND OBSERVED MOVING AROUND THE INTERIOR OF THE MAIN BUILDING. THESE PERSONS MADE NO ATTEMPT TO HONOR THE ANNOUNCEMENT; THEREFORE ENTRY WAS EFFECTED.

INSIDE THE MAIN BUILDING, SEVERAL OF THE ABOVE SUSPECTS WERE DETAINED FOR INVESTIGATION, AND A LARGE NUMBER OF DANGEROUS WEAPONS WERE SEIZED. DURING THE TIME THE SUSPECTS WERE BEING DETAINED AT THE MAIN BUILDING, THE DEPUTIES CONTAINING THE OTHER BUILDINGS WERE APPREHENDING OTHER SUSPECTS WHERE THESE PEOPLE WERE BEING DETAINED PENDING A SEARCH OF THOSE LOCATIONS.

AFTER THE 1969 VOLKSWAGEN, MOTOR NO. 119766041, REGISTERED TO DICK JOYCE VOLKSWAGEN AGENCY, WAS FOUND, ALL THE ABOVE SUSPECTS WERE ARRESTED FOR 487.3 PC AND ADVISED OF THEIR RIGHTS PER SH-AD 477.
