Dear Jesus Christ,

This letter is a formal notice that EVEN The First Presidency will convene a formal disciplinary council in your behalf, the result of which includes the possibility of excommunication as Head of Even The Church of of Jesus Christ of Latter Day Saints. The reason for this council is that you are reported to have acted in clear, open, and deliberate opposition to the Church and its leaders through revelation. You have, among other things:

1. Encouraged others to think for themselves and oppose the recent revelations from President Nelson
2. Direct revelation to individuals instead of going through your official spokesperson President Nelson

We will convene the council at 6pm on Sunday, September 9 at the Salt Lake Temple. If you are not able to physically appear, please reveal to us as soon as possible.

You are invited to attend this disciplinary council to give your response to the above. Although we welcome your divine manifestation, it is not required; you may also reveal your response in standard revelation. Whether you attend is of course your choice.

Disciplinary councils are sacred, confidential, ecclesiastical proceedings. If you do choose to reveal yourself, your attendance and participation are conditioned upon your agreement to respect the process and abide by the standards governing the proceeding, including the following conditions:

1. Everyone who attends the council including you the Holy Ghost, Heavenly Father and me, will sign an acknowledgment that the council will be conducted privately and confidentially and will not be recorded in any form. Anyone unwilling to do so will not be allowed to be present at the council. If you decline, you will not be allowed to be present, and any revelation on your behalf to the council will have to be submitted in writing.
2. You may summon angles, one at a time, whose testimony is relevant to the issues I have set out above. However, any such angel must be revealed to me in writing by name, planet and God served, at least three days in advance. You must also provide to me, in

advance and in writing, a description of the subject matter on which they will testify and the content of their revelation. In order to offer testimony, witnesses must be members of the Church on this planet and in good standing. I will abide by these same rules in regards to any witnesses that I may call.

3. Any proposed testimony from witnesses and angles must relate to the specific issues described above.

I anticipate that it will take about 15 minutes for the evidence in support of the above issues to be presented to the council. You will be afforded three times that, or 45 minutes, to give your response and revelation.

As mentioned above, if you choose not to attend the council in person or in spirit, you may submit a revealed response that will be read to the council. I will read your statement word-for-word, without any comment from me, for up to 45 minutes.

I feel inclined to let you know that, if it is your ultimate desire and if you wish to avoid this process entirely you have the option to request that your name be removed from the records of the Church. If you should make such a request, the council will be cancelled, and I will work with you to supply all of the information that you need to bring about that result.

Jesus, I know that Heavenly Father lives and loves you. You are his only begotten son. Your work and glory is to bring to pass the immortality and eternal life of man. I know that you are central to God's plan to help us return to Him and live with our family forever. Your atonement is real and our Savior and Redeemer. No matter the course you decide to take in this eternal life, and no matter the outcome of this disciplinary council, as your official representative in this world we reside, I stand ready to help you in any way that I can. I will be here to meet with you and to work with you to help strengthen your relationship with your official spokesperson President Nelson. My hope is that you will choose to change your course and to return to the covenant path of EVEN The First Presidency.
