## MARRABELLA-MAYFIELD CONCORDAT

Crowned Republic of Astoria - Warzone Trinidad Corporation

#### **Article I - Government Recognition**

Section I - This treaty, hereafter referred to as the **Marrabella-Mayfield Concordat** is drafted on behalf of two parties. The Crowned Republic of Astoria, represented by The Monarch, Astoreus, the Prime Minister and Crown Marshal, Omnicontrol, and the Warzone Trinidad Corporation represented by the Chief Executive Officer Flemingisa, the Board of Directors, and any legal successors to such.

Section II - For the purposes of this treaty, The Crowned Republic of Astoria shall be referred to as **AST**, and the Warzone Trinidad Corporation shall be referred to as **WZT**. Both will be officially recognized as signatories.

Section III - The signatories agree to recognize each other as the sole legitimate governments of their respective regions.

Section IV - Upon ratification of this treaty, the two regions shall maintain on-site embassies with each other.

#### **Article II - Non-Aggression Pact**

Section I - Both AST and WZT agree to uphold a non-aggression pact, whereby neither organization shall engage in acts of aggression, including but not limited to military invasions, espionage, and intentional sabotage, against the other.

Section II - This non-aggression pact shall extend to all official members of AST and WZT, including members of the Royal Operations Force and Warzone Trinidad Mafia, and any further iterations and subsidiaries of the two.

Section III - In the event that either party becomes aware of any covert or overt acts of aggression against the other party, they shall promptly communicate and resolve the issue through diplomatic channels.

#### **Article III - Military Cooperation**

Section I - Astoria and WZT acknowledge that they possess the ability to request mutual assistance from each other for the purpose of piling and raids, except in cases where other treaty allies of the requesting party are involved.

Section II - Both parties reserve the right to decline a request for assistance if a target does not align with their target selection criteria, or is invalid due to treaty obligations.

## Article IV - World Assembly Cooperation

Section I - The signatories affirm their commitment to cooperation within the World Assembly, hereafter referred to as the WA.

Section II - Either party may recommend **General Assembly** (GA) or **Security Council** (SC) proposals to the other party for their delegate's approval and support.

Section III - Both signatories shall consult on and attempt to coordinate their voting strategies, to the extent that it does not impede on either party's regional sovereignty.

Section IV - Neither signatory will support an injunction or liberation of either region, unless specifically requested.

Section V - Each signatory will seek to consult with the other regarding commendations, condemnations, liberations, and injunctions that relate to their personnel, or held regions, and provide support as directed whenever possible.

### **Article V - Disputes and Resolutions**

Section I - In the event of any disputes or misunderstandings arising from the interpretation or implementation of this treaty, both parties shall seek to resolve such issues through diplomatic negotiations and dialogue.

Section II - If diplomatic efforts fail to resolve a dispute, both signatories agree to submit the matter to a mutually agreed upon uninvolved third party for arbitration or mediation.

#### Article VI - Ratification, Amendments, and Termination

Section I - This treaty shall only be considered ratified after both parties have signed it and had it approved by whatever method is used for ratification.

Section II - This treaty may be amended at any time by agreement between the signatories. Amendments shall come into effect one week after being approved by both parties.

Section III - This treaty may be dissolved at any time by either signatory, and will be considered repealed one week, or seven days, after dissolution is formally communicated to the other party
