On 08/15/2007 at 1253 hrs I was dispatched to 906 Little Ln in reference to Anthony Farrer assaulting his sister Alicia Farrer. Dispatched advised that Anthony Farrer had left in his mother`s blk Ford Pickup Texas tag and may be enroute to MG`s cafe on Woods St.

I arrived at 906 Little Ln at 1301 hrs and Officer Jeff Jones 084 advised he was stopping the vehicle at the Parkview Apts in the 1200 of Taylor St.

I was met at the front door of the residence by Alicia Farrer and her mother Ruby Farrer. I asked if Alicia had any marks from the assault and her mother said yes. I asked Alicia how she got the marks and she stated that Anthony had hit her in the back several times with his fist. I had Ruby show me the marks on Alicia's back. She had three red marks the size of a fist, two on her upper right back and one just above he waist line in the middle of her back.

Alicia stated that Anthony asked her where his dvd was and she stated she did not know that it was in his player. Anthony got mad and yelled at Alicia, "fuck you". Anthony then struck Alicia in the back he his fist causing the red marks.

Their mother Ruby was in the kitchen and the assault was in the living room. When Ruby came into the living room Alicia told her mother what happened and Ruby called the police. When Anthony heard that Ruby was calling the police he got into his mother Ford Explorer and left.

I took photos of Alicia's back at 1319 hrs and the disc of photos was latter tagged and placed into the evidence locker and the SPD.

I advised Jones 084 of the injuries to Alicia and he placed Anthony under arrest for ACBI FV.

I recorded a statement from victim Alicia Farrer at 1325 hrs and that tape was later tagged and placed into the evidence locker at the SPD.

Alicia and her mother Ruby requested an Emergency Protective Order to keep Anthony from coming back home after he got out of jail and Jones 084 completed that EPO and left it at the jail for the judge to view.

I gave Ruby and Alicia family violence cards and information and a citizen information card with the case number.

On 08/15/2007 at approximately 0105 hours, I, along with Officer Jones #084, observed a black 2003 Ford Explorer Sport Track, Texas tag LP VIN , northbound on Grant Street. The vehicle turned Eastbound onto West Taylor Street. I knew that Officer Mauldin #40, was investigating an Assault Family Violence that had occurred at 906 Little Ln., and that the suspect was reported to be driving that vehicle. I followed the vehicle until the driver, later identified as Anthony William Farrer, w/m, Dates of Birth turned into the Parkview Apartments, located at 1200 W. Taylor Street. I activated my overhead lights to initiate an investigative stop on the vehicle. The driver pulled into a parking space and stopped.

I made contact with A. Farrer and confirmed his identity. Sergeant Hampton #112, arrived at that time. Communications advised that Farrer was wanted for J.P.1 Warrant #191024/MA for Assault Causing Bodily Injury. I advised A. Farrer of the possible warrant, and placed my handcuffs on him double locked. Once communications confirmed the warrant, I advised A. Farrer that he was under arrest. I searched Farrer, incident to arrest, and no weapons or contraband were found. I placed A. Farrer in the right rear seat of Unit 255.

I searched the vehicle, incident to arrest. During the search, a kitchen butcher knife, 2 razor blades, and numerous unused diabetic syringes were found within the reach of the driver. No contraband was found during the search. None of the possible weapons were determined to be illegal or contraband and were left in the vehicle. At the request of the registered owner of the vehicle, Ruby Farrer, the vehicle was left legally parked so that she could retrieve her vehicle. Officer Mauldin advised that Farrer had assaulted his sister, Alicia Farrer. A. Farrer was charged with Assault Causing Bodily Injury, Family Violence.

I transported A. Farrer to the Grayson County Jail. Upon arrival, I completed the booking process and a Request for an Emergency Protective Order. Digital photographs were taken of Farrer. While taking the photographs, I observed that Farrer had small abrasions to the inside of both his right and left forearms. I also observed that his knuckles were red as if he had struck something or some one. At approximately 1402 hours, I read the Miranda Warning to A. Farrer. I asked A. Farrer if he wished to make a statement about the family violence incident, and he stated that he would not speak without his attorney present. No further questions were asked.

The disk containing the digital photographs was placed into evidence.
