

# **Communications Officer (part-time)**

Surviving Economic Abuse (SEA) is the only charity in the UK dedicated to raising awareness of economic abuse and improving responses to victim-survivors. Launched in early 2017, it has already made enormous impacts on the understanding of this hidden but highly prevalent form of domestic abuse. In just once year it has achieved media coverage in national media including BBC Radio 4, BBC Breakfast, BBC Radio 5 Live and the Guardian.

This young, dynamic and fast growing charity is seeking a communications officer to build on the successes of its first year and establish its brand for the exciting developments to come.

We are seeking a communications officer who shares our passion for helping women survive and thrive after economic abuse. Joining at a crucial point in our journey, you will have the opportunity to raise awareness of economic abuse amongst policy makers, service providers and the general public. Crucially, you will also provide vital information for women experiencing economic abuse.

#### Job description

Surviving Economic Abuse is a young and fast growing charity at the start of an exciting phase in its journey. The role of communications office will include:

Media relations

- Developing and maintaining relationships with trade, national, online and broadcast media
- Drafting and distributing press releases
- Managing incoming press enquiries and arranging interviews with SEA spokespeople, including survivors
- Proactively seeking opportunities to comment on media stories

## Brand building

- Sourcing and managing opportunities to build the profile of SEA and its spokespeople including speaking opportunities, media and awards
- Developing materials and resources, enforcing brand guidelines
- Supporting the director to develop communications strategies

## Digital communications

- Day to day management of SEA's website
- Contributing to social media management

- Proactively seeking opportunities to engage in relevant social media conversations
- Amplifying SEA's campaigns, reports and events through creative social media campaigns
- Producing and distributing a quarterly newsletter
- Supporting the director to build and manage SEA's online international network

Sharing women's stories

- Building and maintaining relationships with survivors of economic abuse who wish to share their stories
- Interviewing survivors about their experiences and building a bank of first-hand accounts
- Supporting survivors to safely share their experiences with the media, at events and on digital channels

Events

- Supporting the director and other spokespeople to prepare for speaking or networking events
- Supporting the director to promote, organise and deliver events including launches and receptions

The position of Communications Officer if offered part-time (18.5 hours, 2.5 days a week) on a one year fixed contract which may be extended subject to funding.
