

TERMS & CONDITIONS

1. 2. Upon receipt of the voucher, the participants is required to place a booking of the ORA GOOD CAT ("Vehicle") with any authorized dealers of Great Wall Motor Sales Malaysia Sdn Bhd ("GWM") within the period.
