### The Amoctate of David (Ali) Sonboly

### Introductory remarks on the act and the situation

David (Ali) Sonboly, born on April 20th, 1998, planned a long time on July 22nd, 2016 Multiple killings committed in Munich. He started killing in a McDonald's restaurant In the Munich Olympic shopping center (OEZ) a total of nine people and five injured more people heavy with gunshots. Numerous other people have been through that Happened traumatized and mentally impaired.

Terrorist attack based on the Paris pattern cannot be ruled out, after which several locations in

Munich may have been attacked by several perpetrators.

In Munich it came off briefly after the fact to the first breaking news and special broadcasts about a possible terrorist situation several crime scenes in Munich. There was talk of several perpetrators with long guns who at had been seen in various parts of the city. In a short time a huge one locked

Police presence around the Olympic Center from downtown. The subway traffic was set, people hid in shops. The television showed pictures heavily armed police officers taking people to safety. In the social

Networks rolled over the rumors and alleged sightings of perpetrators and

Events repeated without the exact circumstances being clarified. Doctors became for Emergency call to the clinics, people did not reach each other. First against

At midnight it was clear that the act was carried out by an 18-year-old, mentally suspicious individual perpetrator

was committed and it was not an Islamist motivated perpetrator. The

Police assumed a murder, which turned out to be correct.

The unclear situation in the first few hours and the possibility of terrorist acts like in Paris im November 2015 called special reports and an enormous uncertainty of the Population. As a result there were further acts of terrorism and an abundance of Threats and announcements. And there is a new phenomenon for Germany:

### **Summary**

The perpetrator is a typical young gunman who took other perpetrators as models and identified with these and with the idea of a rampage. He was in a considerable way

His inability to maintain social relationships was particularly evident in his behavior the chat remarks made to the 16-year-old whom he wanted to please. Although they are For some time in the summer of 2014 he engaged in chat conversations with him, he destroyed them himself beginning friendly (chat) relationship through strange behavior and mediated uttered massive insults towards their peers. When she made contact in September 2014 broke off, his decision to act is likely to have entered the next phase and the concrete considerations for the implementation of an amoctate began. Towards her he responded to inquiries about what else could be concluded from his behavior: He had no future plans or even dreams and desires. His school efforts were not serious and his statement that he wanted to study remained empty and like himself was conscious, formulaic. Beyond the specifically xenophobic hate speech however, his thoughts of hate were directed against a number of other people and am End against society in general. The perpetrator had throughout his school days pronounced performance problems, but managed the transfers up to one year. At rather below average intelligence he was overwhelmed for years. He held himself however, for superior and did not recognize his deficits, but made the respective

The deal with swastikas and Hitler was also no stranger to other gunmen. They admired the greatest killer of all time and could find themselves in the tirades of hatred, which apply to large parts of humanity, find again. In addition, the written legacies that can be found on the Internet offer Eric Harris, one of the perpetrators at Columbine High School on April 20, 1999, was prone to crime until today possibilities of identification. If nothing if successful in life, at least the deed should never be forgotten. Like himself in one Chat carried out seven months before the act (they talked about terrorists and Breivik): "If you look closely you can see that these people were simply killing people

### I. The act on July 22, 2016 in Munich

On July 22, 2016 at around 5:51 p.m., 18-year-old David (Ali) Sonboly started in Hanauer Street in Munich in the fast-food restaurant McDonald's with fatal intent towards young people shoot. He killed in McDonald's and on Hanauer Strasse in the area of the OEZ a total of nine people and injured five others, some seriously. Around 8:26 p.m. he shot himself when he was caught by police officers.

At the start of the act, he aimed at a group of unfamiliar men and women Young people with a migration background. He had six teenagers around a table

had gathered in McDonald's, already observed. In the nearer preliminary phase to the deed was looking for Sonboly used the McDonald's toilet on the 1st floor three times between 5:08 pm and 5:50 pm up and went back and forth on this floor. At one near the toilet

Little by little, six young people who the perpetrator did not know were seated at the table. Around 17:23

Little by little, six young people who the perpetrator did not know were seated at the table. A (Victim 1) and (victim 2) arrived around 5:28 pm (victim 3) and (victim 4) and against 5:42 pm (victim 5) and (victim 6). The six had made an appointment and were talking, one Order has not yet been placed. Suddenly the perpetrator stepped out of the toilet and shot the youth of this group. Within 18 seconds, all six of several were Shots hit. The 15-year-old Hungarian citizen (victim

1) died immediately from two headshots. The 14-year-old German born in Munich Turkish nationals (victim 3) died instantly from a head and trunk shot.

On the 15-year-old German-Turkish citizen born in Munich (victim 4) the perpetrator fired six shots. The victim died from the two head and four torso shots.

The 14-year-old German citizen (victim 5), born in Munich, died of three
Torso shots. The perpetrator took aim and shot the two girls, waving to the left
and shot at the two boys (victim 1) and (victim 4) to head back to the right
pan of girls. Also the 14-year-old stateless person born in Munich (victim 6)
was hit. She suffered four gunshot wounds in the head, neck, torso and hand and
died after emergency medical care from the bullet in the hospital
7:13 pm. The 13-year-old (victim 2), born in Munich, citizenship not known,
was seriously injured by two shots. One shot hit the jaw as a bullet. The
second shot penetrated his chest. The boy survived with life-threatening ones

After the offense began with five dead and one seriously injured, the perpetrator went to the Ground floor and left the McDonald's in order to target him on Hanauer Strasse shoot unknown people. Looking towards the electronics store Saturn and the Entering and exiting the underground car park, he aimed at a car with Polish license plates and damaged the vehicle. The Polish driver was not injured. Then he shot one Car that just stopped at the exit barrier of the parking garage. The 47-year-old German Driver was uninjured. On the sidewalk at the level of the entrance to the underground car park, the 17th

year old Greek nationals born in Munich (victim 7) from four shots met. (Victim 7) was on the terrace of the McDonald's when the first Shots rang out. Together with his sister he fled over a fence in the direction Saturn, where he met the perpetrator. Sonboly hit him with three shots in the hand, im Abdomen and thigh so that he fell to the floor. The perpetrator gave another Headshot at the youngster lying on the ground, what the sister observed has been. She then ran away in a panic and dislocated her shoulder as she escaped and twisted his foot. Her brother died in the hospital at 7:58 pm. On the The perpetrator shot the 27-year-old German (victim 8) on the sidewalk and hit him in the back near the spine. The shot came from the stomach and life-threatening ones occurred internal injuries. The victim remained motionless and the perpetrator walked on. (Sacrifice 8) was found lying on the street by rescue workers and taken to a clinic. Immediately afterwards, Sonboly shot a Turkish wife and mother of two in the Chest. The bullet through was fatal. The one on the sidewalk near the underground car park existing 60-year-old German married nationals (victim 9) suffered a He was shot through the thigh and was initially treated in the clinic for eight days. Because of an incipient sepsis, he was again in a clinic for two weeks in September 2016. At the The perpetrator shot the 44-year-old from behind at the subway exit at the level of the Saturn market married (victim 10) (born in Kosovo, unknown nationality), whose Both lower legs were shot through. Together with her husband and the three of them She was able to escape to the Saturn market for children and survived. The perpetrator shot at the Sidewalk on the 19-year-old German (victim 11) and hit him from behind with five Bullets in the trunk and thighs. The victim collapsed and died.

The perpetrator slowly crossed Hanauer Strasse and went to the main entrance of the OEZ. He was seen changing the magazine. He met on the ground floor of the OEZ the 20-year-old Kosovar national (victim 12) who was born in Munich and who

It was 5:55 p.m. Sonboly walked past several OEZ shops and shot them

then Sonboly fired at people at random, shot the magazine empty and reloaded it.
Nobody was injured here. He shot two cars in the parking garage. He was
now from a store manager working in the OEZ who tried to protect motorists from the shooter
to warn, seen. The witness saw Sonboly fire several shots backwards
and screamed. He was able to promptly give police officers an indication of the walking direction
The perpetrator because he saw that he was going down to the second parking level.

On the parking deck there was now a dispute between Sonboly and a resident in the result of which the perpetrator fired a few shots at the 56-year-old German and at the same time the Neighbors, a 46-year-old Bosnian, suffered a splinter injury from a ricochet taught. The perpetrator continued to shoot at office windows, behind which he was a 56-year-old German office workers. He missed the man. In the middle of the parking deck there was now a clash with the police who shot off the Submachine gun fired on Sonboly, but missed. The culprit ducked, lost two Cell phones and disappeared. It was 6:03 p.m.

In those few minutes - from 5:51 p.m. to 6:03 p.m. - Sonboly had nine people fatally injured, five people seriously and numerous others injured in other ways. Many people were shocked and traumatized because of the fatal shots from the Experiencing closeness, enduring the fear of death, panicking and fleeing Injuries sustained.

Until 8:26 p.m., the perpetrator was largely in hiding. He was several times in the Spotted near. In the meantime he changed his black T-shirt to a blue one. Both T-Shirts were labeled irrelevant (Uncle Sam and Chill). Most likely he had stayed in the basement of buildings that are close together. He was against

asked to put down the weapon. Sonboly called out to the police several times to tell them to shoot him, which they didn't. He then shot himself in the left temple. The location of the suicide was near the former secondary school (Toni-Pfülf) that the perpetrator had visited.

At the time of the crime, the perpetrator was not under the influence of alcohol or psychotropic drugs.

Took during the killing phase of the incident between 5:51 p.m. and 6:03 p.m. Numerous witnesses came true to the perpetrator during or between the firing of the shot Made statements. He said among other things:

"Because of you, I had to suffer in Germany for seven years."

"Your asses are your own fault, you bullied me!"

"I've waited for this seven years!"

"Now I fuck you all, I fuck you all!"

"I hate you Muslims!"

"You brought death into the country!"

"Fuck Turks! I'm German!"

"I'm German - I was born here, because of the fucking Kanaks I do that!"

"I was in psychiatry."

Some have heard during the shot at the girls that he "Allahu Akbar" said Has.

As a witness later stated, who had heard the end, Sonboly should also be in the Phase shortly before his suicide said something to the police officers: "Shoot!

But before I go I have something else to get rid of! I am not an Islamist, not a Salafist. I was receiving treatment for mental health problems. It had to happen!"

As for the statements made during the firing of the gunshots, these are for murderers atypical. Basically, in other cases, the perpetrators were described as rigid, without Facial expressions, without uttering, calm in the movements, but emotionally immobile. Nobody has said something. Small deviations were seen, for example, with Robert Steinhäuser, who ended up too alleged to have said to a teacher: "It's over for today." During the act he said nothing. Some asked about certain people, but in a calm tone, without suspicion irritate. For the perpetrators, the decision to act was clear, they had long emotions prepared and carried out the deed in silence. It was different with Sonboly. These hateful ones Exclamations during the commission of the offense can be interpreted to mean that he does had a great need for subjective justification during the act. Although he was also years had thoughts of hate before and hinted at the act, it seemed to be a problem for him actually carry out the deed. Basically at every stage of the killing he felt the need to make sure. Should he actually "Allahu Akbar", this shows the even greater cynicism. He was not an Islamist and did not want to be understood that way either. So the statements can only be considered evil Understand cynical sacrifice devaluations (in the sense of: "There you Muslim women have what you want."). The content of the other statements is to be understood as justifications of violence. He had an extreme worldview and especially Turks and German-Turks were him hated. Here, however, there are also irrational elements of generalization, because he didn't even know his specific victims by sight. This also applies to the statements that he is been bullied and waited for revenge for years. Since he's neither his bullies from the Grades 5 through 7 still encountered the victims doing something with possible bullying had an irrational worldview with generalized hatred. Personality. No victim had anything to do with him. The few he invited to the crime scene (um killing them or witnessing his cruel actions) had not come, which didn't stop him from killing. That was not the point. He was obsessed with the idea of becoming famous with an amoktat and not with any one, but with THE German amoktat, which should cost at least 17 victims (puns in Nicknames with the number 17 (17hunter and others - Robert Steinhäuser had on April 26th, 2002 in Erfurt 16 people murdered, Tim Kretschmer in Winnenden and Wendlingen 15 people).

You can also see that there is no clear message of this act. During the ideological motivated perpetrator calls his "Allahu Akbar" and is repeatedly and clearly recognized as an Islamist, he also sends a clear Islamist message to all potential victims and the Society. The right-wing extremist who leaves a swastika and xenophobic slogans are roaring, clearly ideologically recognizable and sending one right-wing extremist message.

The change of crime scene is also noticeable during the course of the crime, which indicates several aspects (Inspiration from special first-person shooters, recent terrorist acts and significant Matches in particular with the fact in Winnenden and Wendlingen who made him particularly interested).

The choice of weapon and the enormous amount of ammunition are very typical. The high number of Victim results from the use of a firearm. Also the termination of the killing after one certain time is not uncommon. When choosing the date of the offense, the anniversary of the offense can be used cannot be denied in Norway (July 22, 2011).

### II. What are Amoctates?

Young gun killers up to the age of 23 form a specific group of phenomena and differentiate between them the personality and execution of other offenders who commit homicides.

The deeds are very rare. The specific risk factors allow in most cases early detection and intervention because the perpetrators hints at their plans before the act do.

Amoctates are "intentional, attempted or completed multiple killings of the type of mass murder, which is usually a lone perpetrator out of anger, hatred and vengeance attacked certain or arbitrarily selected victims. The perpetrator aims for fame or attention and often commits suicide following the offense. Young perpetrators up to Age 23 years differ from the more heterogeneous group of adults. At a core group of young perpetrators found personality problems that determine the offense are. The quiet, withdrawn, but always somewhat strange loner has one deep feeling of foreignness, feels hurt and disregarded, identifies with Perpetrators and finally staged his act as revenge for subjectively experienced insults. Schizotypic, paranoid and narcissistic aspects dominate. The perpetrators are not impulsive, aggressive or antisocial."

The case shows very typical elements from the core area of young gunmen. In one more as a three-year empirical research project funded by the BMBF, was a total census of young gunmen up to the age of 23, a comparison group of young people Offenders with multiple homicides and a partial survey of 40 cases of adult murderers performed.

After a long period of time, the Munich case was again a case of a boy

### III. Results of an empirical research project: Young gun killers

In June 2016, the BMBF-funded interdisciplinary research project TARGET (Act and case analyzes of highly expressive targeted violence) and here the sub-project Gießen: Criminological analysis of amoctures (juvenile and adult perpetrators of Multiple killings, threats of amok) completed. The final report and several detailed publications on the project were published in 2017.

Gun killers are usually single perpetrators who are high due to a spectacular multiple homicide Want to attract attention. Young and adult murderers show some

Similarities, but also differences.

According to the interdisciplinary empirical analysis of almost all the murderous acts of young perpetrators (up to 23 years of age) in Germany dating back to the early 1990s, it has been shown that the core group of young offenders (19 cases, 19 offenders) has specific characteristics.

A total of 33 cases with 35 young offenders were analyzed

Parents were usually around that Well their children - most of the perpetrators had siblings - worried. However, for later offenders usually have a special relationship. The family members lived by externally intact facade side by side and a relationship of trust between the later perpetrator to parents or siblings did not exist. The siblings, especially the more sensitive ones Sisters, often noticed the ambivalence of their brother, whom they on the one hand as strange, interested in amok, inaccessible and closed, overwhelmed at school, without friends and girlfriend, obsessed with computers, but also as lonely and perceived needy. But they also saw their parents as helpless towards their brother. The later ones The perpetrators mostly attended high schools, but were overwhelmed in terms of performance. Some were at a difficult stage shortly before they started their vocational training, but they did not considered suitable for themselves. It was noticeable that none of the perpetrators had any future plans and career aspirations. That played in the diaries and activities that were partly over are documented for a long period of time.

Of the 19 young offenders in the core group, eight offenders killed themselves (seven have

shot himself after the act, one later killed himself in the penal system), four tried, including three who provoked the arriving police officers and almost got shot (attempt at suicide by cop). ### IV. Biography of David Ali Sonboly - motives and causes of the act

### 1. Family

David Ali Sonboly was born on April 20th, 1998 in Munich. His parents settled in the year

1997 from Iran (Tehran) to Germany. He has a brother who is four years his junior. The family moved several times in Munich and improved from an economic point of view considers the lifestyle and the residential area. The father is more independent Taxi operator, the mother worked temporarily. Seen from the outside, it is a successful integration.

His parents tried to have a harmonious family life. There were no negatives Educational practices or even abnormalities that can be identified with a so-called "broken home" connects. On closer inspection, however, there was a certain helplessness of the parents in the Regarding the personal development and behavior of their son David (Ali). Sonboly was born as Ali and rejected that name as "inferior". From the age of majority in In 2016 he changed his name to David. He spoke to his parents about this fact, enforced the decision just as independently as previous behavior. With there were few activities together with the father, but quite a few visits to Tehran, last in 2015. The visit to a sports hall with a picture which shows David (Ali) shooting with a rifle. The unknown coach of this Iranian sports center praised David (Ali) for his good Shooting performance, which made son and father equally proud. The problematic one The father did not become aware of any component of these skills. This is interesting here Parallel to some other German rampage cases, in which the fathers also only have one had a superficial relationship with their son. His younger brother reported that it was normal for Ali to retire to his room, Seldom shared meals and barely spoke. Parents recognized that he had been from early childhood had emotional deficits, he could not comfort anyone or himself even as a toddler empathize emotionally with another person. The father blamed them for many difficulties school problems, which he saw as remediable. The years of cognitive Overstrained the slightly below-average talented son escaped the parents who gave him also wanted to see some of them as gifted. Bullying in grades 5 - 7 too did not tell David (Ali) to his parents. Only at the end did he tell his father, who then justified the son's change of school with this fact. Since 2010 David (Ali) is in psychotherapeutic treatment after first contacts to in 2007 to a psychiatrist. Very problematic issues emerged here early on Personality developments and the parents generally reacted passively and in denial. This attitude can also be found in the parents of other people who run amok. Sonboly never enjoyed going to school and was always a mediocre to poor student. In In elementary school (2004 to 2007) he fell due to immature behavior, restlessness, lack of Concentration, walking around the classroom and making uncontrolled statements. In the early testimonials, the assessment of his behavior is negative (poor student, switches off, reacts unpredictably, can only follow simple tasks, incomprehensible expression in German etc.). He did not defend himself physically, but with counter-insults, as testimony of some classmates attest. Also a teacher in a later school says Ali often felt attacked and bullied, even when laughing at little things has been. He saw a lot of supposed bullying. The therapist who knew him best also recognized the problematic parts of the behavior and said that he had tried to him to make it clear that it cannot go well if you approach classmates as want to go to war.

### 4. Social contacts - no friends, no girlfriend

When he travels carried out to visit Winnenden or to buy the firearm (of which the parents had no idea), his absence at home was clearly noticeable. But he explained himself not towards the parents.

The concern with the computer and especially with first person shooters (see 10. below) was extremely time-consuming. One can hardly speak of leisure behavior, since he is the Performance area in favor of its time consuming computer comprehension long ago neglected. He went to school regularly, so he didn't skip that Classes. However, he was likely to have been mentally absent frequently during class.

#### 6. Matrix and the Viruses

### 7. Psychopathological abnormalities

Sonboly had had psychological problems since 2007 and had had since then (around the age of nine Years) contacts with psychotherapists and psychiatrists who lasted to the end in the 2015 and 2016 were even very intense.

At the beginning in the years 2007 to 2009 there were speech therapy examinations and school-based Problems. The first contacts were made in the psychiatric practice of Dr. (Dr. 1) and Dr. (Dr. 2) instead of (2007 - 2009). In addition to these few contacts, there was also im 2013 Dates in which ADHD with appropriate medication and

The recommended inpatient accommodation took place in the period from 29.07. - 09/22/2015 in one

Clinical center. Here was Dr. (Dr. 4) treating psychiatrist. She advocated one longer inpatient accommodation, which Sonboly and his parents disagree with were. She was supported by a qualified social pedagogue who mainly did the Treat social behavior and the time-consuming computer game problem therapeutically should.

After September 28, 2015, Dr. (Dr. 5) the outpatient therapy following the inpatient accommodation. There were four dates in 2015 and seven dates in the year 2016 took place. Dr. (Dr. 5) prescribed the drugs Abilify and Mirtazapine, the Sonboly took some time, but then because of weight problems, tiredness and concern discontinued the side effects listed in the package insert.

From October 15, 2015 to February 15, 2016 there was an investigation for autism in one specialized outpatient clinic. In February 2016, autism was taken for granted.

Most recently there was a single appointment in the university clinic (children's and Adolescent psychosomatics). One denied the diagnosis of a social phobia, but saw urgent need for treatment.

The recommendations who pointed early towards the development of social skills and group training, were basically not implemented. It wasn't just David Ali Sonboly's rejection that played a role here a role but also that of his parents, who in very different situations acted denying. This coincides with observations made by other parents of gunmen.

One puts the psychologically conspicuous accents on performance impairments or pushes they even to third parties (bullying). This is repeated with the son and later perpetrator Behavior that the parents already showed to some extent: One denies the real problems of the pronounced mental disorders, fends off the psychiatric problem and pushes

Blame third parties for it.

Towards the end of the preparations for the crime (end of 2015, 2016) Sonboly was in his submissions no longer as open towards the psychiatrist as in the inpatient placement in Fall 2015 or in the therapy talks with Dr. (Dr. 3).

The psychopathological development remained in particular Dr. (Dr. 3) not hidden. He noticed the problems of the sprawling computer gaming, which not only was far too time consuming but also had problematic content that glorified violence. Sonboly was already showing killing fantasies back then, loved the virtual first-person shooter worlds and was in his Social behavior difficult. The killing fantasies were directed against fellow men early on general, also explicitly against the brother or against classmates. Goal of early therapies was above all a reduction in PC games and the development of social skills. Dr. (Dr. 3) saw the narcissistic traits with hostile and socially phobic behavior. Man wanted to strengthen his self-worth and clarify the issue of the matrix and the viruses, by who Sonboly was fascinated by. Dr. (Dr. 3) also recognized phases. He saw that the state of the Young people always related to certain events. If it went well, it improved his condition, when things went badly, frustrations, behavior disorders and to amok fantasies and death threats. Saw a specific danger to himself or others Dr. (Dr. 3) never, he later also considered autism to be incorrect. He only saw a few Autism points as fulfilled, also a psychosis-related development (but no

Dr. (Dr. 3) knew about the specific background of the school disappointment, including that of the Parents. It was not a question of a psychosis (see 6. above), which Dr. (Dr. 3) ultimately did not accept. Dr. (Dr. 3) also knew about hatred of foreigners. He realized also very good the provocative character of Sonboly and his contribution to the Insults and hostilities that he experienced at school. Dr. (Dr. 3) stated, Ali did not respond when spoken to. When he felt pressured he insulted foreigners extremely and became racist. He then threatened wildly and withdrew extremely into his first-person shooter world. If it went well, he could But also giving up your attitude, making contacts and even becoming a class representative.

In inpatient accommodation (directly after failure in school in the preliminary class of the FOS) from 29.7. - 9/22/2015 stood for Dr. (Dr. 4) the topic of matrix and viruses in Foreground. When asked, he clearly did not appear psychotic to her. However, she knew also of hostile and xenophobic statements and swastikas. She denied the possible danger to others. The social pedagogue supporting them knew about the fears of Fellow patients before Sonboly, however, denied the relevance of the amok fantasies and played down their seriousness.

Guns, amok and death and also criticized him in many places. When it got too much for him he no longer answered. He tried to get Sonboly out of the subject and the extreme
Dissuade point of view. He also knew of Sonboly's hints in the case of school
Failure. In the end, however, he was neither privy to crime planning nor did he perform an act seriously for possible.

Three teenage girls were significantly more concerned. You often heard Ali say he was wanted to be called "AmokläuferZ", that he spoke of amok, made death threats (I'll kill you all!) that he painted swastikas and spoke positively of Hitler. she contacted the therapists concerned, but they "explained away" these concerns and didn't take it seriously. They justified Sonboly's talk with the bullying he had experienced (!) and didn't ask. The three girls could not be reassured, they wanted to out of fear to be picked up by the parents.

The perpetrators often know themselves that they are mentally disturbed and that their thoughts of hate and Killing fantasies are not normal. It was no exception here.

In 2014 he said to Esma: "I want to tell you that I am not completely healthy."

On the one hand, Sonboly may have hoped that he would get help in psychiatry. He was more often voluntarily in treatment and he did not keep his killing thoughts a secret. But he was not seriously questioned. On the other hand, the thought of doing the deed was become very strong. The further the crime planning progressed, the more it was about them Implementation of the act. He (correctly) did not accept the diagnosis of autism; here is too suspect that he had the impression that he could not be helped. To a stationary one Neither he nor his parents were ready for accommodation at this point. A Compulsory placement because of endangering others was not considered at any point.

The narcissistic aspect of his mental disorder also left him towards the end (2015/2016) heading for action. He then refused any further psychotherapy.

### 8. Development into a murder victim - first thoughts, planning and execution of the crime

The first thoughts about killing people and an amoctate go back a long way.

Hateful statements and announcements that they wanted to kill everyone were Registered in school, chats and with psychotherapists. In grades 5 to 7 fall into

These first statements were not yet a sign of preparation for the crime, because they came about in heated situations. But they already showed fundamental problems at. As a young student, Sonboly was unable to resolve conflicts, relationships and

Forming bonds and was certainly also full of social anxiety. But he also provoked with xenophobic sayings. At the same time he looked and felt strange to the others look strange and different in society.

He set up his first Steam account back in 2007, when he was still in elementary school.

So one can assume that the mental escape is not age-appropriate

Computer games began very early and that his anger here went largely unnoticed

let out, but also initiated a pattern of incompetent social behavior that always

was further strengthened. So he practiced virtually for the later deed, because he was dealing with the characters identified by responding to his own impotence and anger with virtual killing. At

Real-world learning of social skills fell by the wayside in these activities.

The secondary school period was certainly a problematic phase and because of the bullying that missing friends as well as the performance problems a time when there was already a pertinent Problem behavior loomed. However, his personality developed from childhood problematic. The enormous vulnerability in everyday situations and the self-image of a good one The student who is superior to the other encountered the reality of the assessment at best satisfactory, rather just sufficient area. Even the early psychotherapeutic ones Efforts brought the deficits (expression, language, incomprehensible articulation, Behavioral problems) clearly expressed without any noticeable improvement entered. He was also not only certain of his deficits in school and social behavior to some extent consciously, he also constantly felt strange and different.

In the first psychotherapy sessions (with Dr. 3) the hateful thoughts were already noticed. He was but only 12 years old and there were development issues. Therapy solved his problem Not. Rather, problem behavior intensified during puberty and it was now (2012/13) more frequent death threats and hatred.

The problem of not having a girlfriend, even though he is with the Esma of his own age Had met in 2012 in the Wing Tsun Club, would have liked to be close friends, headed one further escalation. From September 2014, he must have the idea of a "normal"

Interested in murderers.

As early as the end of 2014, he began to deal intensively with other acts and murderous criminals (see also under 12.). He visited Winnenden, dealt with the act in Emsdetten, intensely with Columbine, of course, with some American gunmen. The Information is quickly available when the interested party begins to familiarize themselves with relevant issues Internet sites to deal with.

In 2015 he still had a sense of achievement at school, but that was of no relevance more, since a further school path or a professional orientation is of no interest to him has been. He started looking at gun accessibility, did some research on other terrorist perpetrators and was so busy. The burden of The approaching act and his killing fantasies were still noticeable. During this time the increasing mental crisis and he also spent two months in the inpatient Psychiatry.

Radicalization. The perpetrator can enjoy his violent fantasies to make himself big

But the result was a much more comprehensive picture of the hatred of a young mentally disturbed boy People.

#### "My fight with people"

In April 2015 he had already written the text: "My struggle with people". On two Pages shows the psychopathological side of Sonboly very well. He addressed his Being different, feeling strange: "Since the 3rd grade I noticed that I am different, behave differently ...".

He took up the thoughts of Bastian Bosse (Emsdetten, see under 12.) (victims of society).

And he glorified himself while at the same time ascribing unreal blame to others: "In from childhood i was a very kind, hyperactive person ... well alas, i guess

not that my life has any coincidence, I got off the beaten track. The pressure that

Ms. R. (...) gave me from class 3-4 changed my behavior towards the future ... ".

Then began massive xenophobic and misanthropic devaluations, in which he presented himself as a victim (the Bosnian woman whose family he was going to wipe out, the fat Afghan woman with 12 siblings ...). The matrix was also mentioned here as a matter of course. He claimed to have been bullied from day one, which is not true

The Bastian chat is particularly interesting. The police investigation did not yield any References to a real existing Bastian or Sebastian, also no "amok-Cell". This confirms the assumption that the chat was something else. In the entire development of the Sonboly had a tendency to give rise to many thoughts as a voice message or in recordings. His few social contacts took place less in personal conversations than in various chats. Besides, he had strange habit of appearing under false identities on multiple occasions.

Sonboly dealt with the following gunmen in more detail.

### Tim Kretschmer, deed on March 11, 2009 in Winnenden and Wendlingen

The perpetrator killed 15 people. The first crime scene was the one previously visited by the perpetrator Albertville Realschule. This is where the first act of the act took place. The perpetrator attacked Schoolgirls (primarily) in two selected classrooms, but also schoolchildren and Teachers. He shot the caretaker and the arriving police officers. David Ali Sonboly was never identified with right-wing extremists, but rather amoctoists. From terrorists (especially lone perpetrators) he let himself be with regard to the Inspire deed execution. Only Germans had a deeper meaning for identification and American gunmen, not even Breivik.

As the German gunman, he wanted to become immortal with at least 17 dead.

### VII. The Munich Amoctate - neither hate crime nor right-wing terrorism

#### 1. Hate crime

#### 2. Right-wing terrorism

A distinction must be made between right-wing extremism and right-wing terrorism. So much for the typical one Variant of group acts is meant, a murder victim is categorically different. There are some right-wing extremist individual perpetrators, but again these perpetrators are different from the Gun killers through their directed ideology and specific choice of victims.

For example, if you look at the Reker assassin (2015), the difference to the Murderer clearly. This assassin had a specific enemy image. He was earlier Member of a right-wing comradeship, which was over for many years. As alone He was a living 45-year-old man with failed relationships for over two years before the crime unemployed and watched the influx of refugees with suspicion. Here was now his right-wing extremist ideology. He made politicians for choosing refugees To let it flow "uncontrolled" to Germany was responsible and found its special Enemy image in today's Cologne mayor. 3. The police definition system politically motivated crime (PMK)
