SIXTH AMENDMENT TO GRANT AGREEMENT

BETWEEN

CITY AND COUNTY OF SAN FRANCISCO

AND

URBAN ALCHEMY

Tenderloin Neighborhood Litter Reduction and Workforce Development

This GRANT AMENDMENT (this "Amendment") is made as of July 1, 2021, in San Francisco, State of California, by and between **Urban Alchemy** ("Grantee") and the **City and County of San Francisco**, a municipal corporation ("City") acting by and through **San Francisco Public Works** ("Department").

RECITALS

WHEREAS, the City and Grantee have entered into the Agreement as defined in Section 1 below; and

WHEREAS City and Grantee desire to modify the Agreement on the terms and conditions set forth herein to increase contract by \$336,340; extend contract by two (2) months; incorporate budget fee schedule for grant period beginning July 1, 2021 through August 31, 2021.

WHEREAS City and Grantee desire to execute this amendment to update the prior Agreement.

NOW, THEREFORE, City and Grantee agree to amend said Grant Agreement as follows:

1. Definitions. Terms used and not defined in this Amendment shall have the meanings assigned to such terms in the Grant Agreement.

2. Modifications to the Agreement. The Grant Agreement is hereby modified as follows:

(a) **Article 3 Term.** *Section 3.2* of the Agreement currently reads as follows:

Duration of Term. The term of this Agreement shall commence on the effective date specified in Section 3.1. Subject to Section 2.2, the term of this Agreement shall be from the date of certification by the Controller to June 30, 2021 with option to modify for up to twelve (12) months.

Such section is hereby deleted and replaced in its entirety to read as follows:

Duration of Term. The term of this Agreement shall commence on the effective date specified in Section 3.1. Subject to Section 2.2, the term of this Agreement shall be from the date of certification by the Controller to August 31, 2021, with option to modify for up to ten (10) months.

(b) **Article 5 Use and Disbursement of Grant Funds.** *Section 5.1* ("Maximum Amount of Grant Funds") of the Grant Agreement currently reads as follows:

5.1 Maximum Amount of Grant Funds. In no event shall the amount of Grant Funds disbursed hereunder exceed \$3,266,596 (THREE MILLION TWO HUNDRED SIXTY SIX THOUSAND, FIVE HUNDRED NINETY-SIX DOLLARS).

Such section is hereby amended to read as follow:

5.1 Maximum Amount of Grant Funds. In no event shall the amount of Grant Funds disbursed hereunder exceed \$3,602,936 (THREE MILLION SIX HUNDRED TWO THOUSAND, NINE HUNDRED THIRTY-SIX DOLLARS).

(c) **Attachment D.** Tenderloin Neighborhood Litter Reduction Services Budget Schedule for Grant period beginning July 1, 2021, through August 31, 2021, is hereby added and fully incorporated in Appendix B of the Agreement.

3. Effective Date. Each of the modifications set forth in Section 2 shall be effective on and after the date of this Amendment.

4. Legal Effect. Except as expressly modified by this Amendment, all of the terms and conditions of the Grant Agreement shall remain unchanged and in full force and effect.

IN WITNESS WHEREOF, the parties hereto have caused this Amendment to the Grant Agreement to be duly executed as of the date first specified herein.
