### **Annual Planning Meeting Details**

We would like to share with you the plans for the August 20<sup>th</sup> Annual Budget Planning and Project Prioritization Meeting. The purpose of this meeting is to learn about each other's content publishing projects (Projects that PSD will help create) for 2013, to more effectively distribute Church messages. Please come prepared to review your department's content publishing <u>initiatives</u>, requests for services (<u>budgets</u>), and <u>ranking</u>. Your Publishing Services Partner should already be working with your staff to prepare this information for your review (see enclosed template).

Initiatives should be broken down into three categories:

- 1. New Initiatives (please rank initiatives this category by order of importance)
- 2. Continuation of Existing Initiatives (in-flight initiatives)
- 3. Maintenance of Existing Initiatives (minor enhancements / "keep the wheels on")

Until we hear from Finance and Records, we will operate under the assumption that budgets will remain flat for 2013.

### Informational Items for the Meeting:

- 1. **Currently** PSD PSPs are currently working with your staff to create your 2013 initiative list. Each initiative will include:
  - Name
  - Brief Description
  - Budget
  - Ranking
- 2. **August 14** Each department will have their initiative list completed and submitted by the PSP into the SharePoint tracking system <u>before</u> August 15<sup>th</sup>.

2013 plan to meeting attendees on August 15<sup>th</sup>. Each managing director should come prepared having reviewed all of the initiatives. In the meantime, PSD has been asked to examine all initiative proposals and determine how they would accommodate all requests in the proposed timeframe. Their findings will be discussed during the August 20<sup>th</sup> meeting.

- 4. **August 20** Each department will have 15 minutes to discuss and entertain questions about their initiatives. After each department has reviewed its initiatives, PSD will be asked to present their plans to support the proposed projects. The combined results of this meeting will be reviewed by executive directors before August 30<sup>th</sup>.
- 5. **August 30** Managing directors of initiating departments will be invited to attend the CSC meeting on August 30<sup>th</sup> to present the proposed plan for 2013.
