### The May Firm Sues SEED Public Charter School for Youth's Suicide

The death of Stormiyah Denson-Jackson has touched former D.C. Council member and Ward 8 attorney LaRuby May in a special way and she is using her legal skills to get justice for the family of her young friend.

Denson-Jackson committed suicide on Jan. 23, 2018 while in her dormitory at the SEED Charter Boarding School in Washington, D.C. The 12-year-old was in the loco parentis (parental) custody of both the SEED

### Hope Village Wins Protest Against Federal Bureau of **Prisons**

Hope Village, a well-known company that operates a halfway house for men in the District of Columbia, is protesting a decision by the U.S. Department of Justice, Federal Bureau of Prisons (BOP), awarding of a contract to a competitor.

Hope Village filed an official protest on Feb. 21, 2019 on the awarding of a halfway house contract to CORE DC. Both contractors are competing for work dealing with a residential re-entry center and home

Charter School and the SEED Foundation and May, with the help of co-counsel Will Lightfoot of the law firm Koonz, McKenney, Johnson, De-Paolis & Lightfoot will seek \$5 million in compensatory damages for her death.

"This is gross negligence on the part of the SEED charter school and The SEED Foundation," May said in an interview with the Capital News on Jan. 29, 2019. "The school wasn't in compliance with the law of the District of Columbia." District law states that school personnel are to be trained and in some cases, certified by the D.C. Department of Health, to deal with young people, particularly those who may have mental health issues.

In their lawsuit that will be litigated in the D.C. Superior Court of the District of Columbia's Civil Division in the name of Stormiyah's mother, Patricia Denson, as the personal representative of her deceased daughter's estate, May and Lightfoot say that school officials weren't certified to deal with suicide or other mentally-troubled students, as is required by law. Also, the attorneys say that Denson wasn't notified about her daughter's volatile mental state even when Stormiyah was seen by the school's counselor, whom the documents list as "Ms. Hopkins."

May and Lightfoot make it clear that Denson should have been consulted about a Dec. 12, 2017 counseling session when Stormiyah told Hopkins "she didn't want to live anymore" and "she couldn't take it anymore." It has been revealed that despite Stormiyah's cries for help, Hopkins assessed her as a lower level suicide threat and informed SEED principal Zenda Mahon and other SEED administrators of her conclusions.

May and Lightfoot said in the lawsuit if Denson knew of her child's suicidal tendencies, she would have taken her to a psychiatric hospital for care and withdrawn from SEED. May said the SEED charter school and The SEED Foundation need to pay for what they have done.

"I knew Stormiyah and her mom," May said. "This school needs to be held accountable for

what happen to her and justice needs to be had."

May said Stormiyah was excited at first about attending SEED. The school is unique in that it has a dormitory for students who live at the school from Sunday night through Friday, and it is a requirement that students stay there.

"Being at SEED was super important for Stormiyah because she thought being educated there would lead to a bright future," May said. "She talked about going to college and doing great things."Lightfoot said what makes the case so sad is that school officials openly violated the law.

"They knew about the required training but they ignored the law," he said. "There is another case about a student who attempted suicide that we are aware of and again, they didn't follow the law."Lightfoot is speaking about the Chante C. Lee case in Superior Court where she alleges her son tried to kill himself because of bullying and constant harassment by students and, like the Stormiyah case, the situation wasn't properly handled by SEED officials. The Chante C. Lee case was filed on Aug. 22, 2018.

May holds a juris doctorate from the David A. Clarke University of the District of Columbia School of Law and is a member of the D.C. and Florida bars. Lightfoot is a graduate of the George Washington University School of Law and a member of the D.C. bar.

May represented Ward 8 on the D.C. Council from May 2015 to January 2017. May expressed pride that Denson came to her for representation.

"Ms. Pat was able to go to a lawyer in her community, someone she knew and trust, she didn't have to go to K Street for quality representation," May said. "She has it with me and in Ward 8. My firm offers stellar legal services for anyone that needs help and I am available." ■

#### confinement services.

In the District, many inmates aren't housed at the D.C. Jail but at residential-like facilities in the city's neighborhoods. Many residents don't like having halfway houses in their midst because of the fear of increased criminal activity and negative economic values of properties that are close to them.

Plus, the District government doesn't offer nearby residents any financial incentives to have halfway houses close by. Supporters of halfway houses argue that it brings inmates into the community and hopes to mainstream them while saving taxpayers the expense of housing them at D.C. Jail.

Residents of Hope Village are offered courses and programs that will help in their rehabilitation such as employment assistance/readiness, GED preparation, substance abuse and mental health counseling and case management.

The D.C. Superior Court and the U.S. District Court for D.C. makes the placements of these inmates.

The decision to award CORE DC the residential re-entry contract by the BOP was made on Oct. 19, 2018 and Hope Village received notification of the award on Nov. 1, 2018. While the BOP has stated in documents that CORE DC had a better proposal, it seems that Hope Village's decision not to accept predatory sex offenders or child molesters seemed to doom its chances of landing the contract.

"As a result, Hope Village's final revised proposal was assigned an unsatisfactory rating for the site validity and suitability element because Hope Village did not provide or cite to any ordinances that might preclude it from accepting specific types of referrals and limited the acceptance of certain high risk offenders based on their classification," the protesting document said.

Hope Village argues that its policy of not accepting predatory sex offenders or child molesters should not have prejudiced it during the consideration process, saying "the protestor argues that the solicitation did not require offerors to accept all offenders."

CORE DC, whose corporate presence is in Florida, has had issues in the District. D.C. Councilmember Kenyan McDuffie (D-Ward 5), late last year, protested a halfway house in the area of 3400 New York Ave., N.E., saying that residents of the neighborhood didn't get the chance to weigh-in on the process.

Thomas Armstrong is the general counsel for the General Accounting Office of the Comptroller General of the United States.

He stated that the protest should be sustained in part and denied in part. Basically, Armstrong said that the agency should re-open the competition for the contract, conduct discussions and collect other information and "prepare a new source selection decision." He also recommended the agency reimburse Hope Village its costs associated with the filing and other reasonable attorney's fees.

### Councilmember Todd Introduces Legislation To Improve Affordability & Livability For Veterans In District Of Columbia

Retirement Income Tax Exemption & Short-Term Parking Permits For Disabled Servicemembers Honor The Sacrifice Of DC Veterans

Washington, DC – Today, Councilmember Brandon Todd (D-Ward 4) introduced two bills that aim to improve affordability and livability for District veterans while honoring their serve and sacrifice.

The Veteran Retirement Income Tax Exclusion Amendment Act of 2019 would exempt retirement income for members of the Uniformed Services from DC personal income tax. 22 states currently classify military retirement income as tax exempt. Over a dozen residents of Ward 4's Knollwood Military Retirement Community attended the legislative meeting in support of the bill. The legislation was co-introduced by Councilmembers Grosso, R. White and Cheh, and co-sponsored by Councilmembers Evans, Allen, and Bonds.

"This legislation not only further honors the sacrifices of retired members of the uniformed services, but also makes the District a more attractive destination for retired servicemembers," said Councilmember Todd. "This bill can also serve as an economic engine by attracting active duty military seeking to retire and work in civilian business, and by attracting civilian businesses seeking highly-trained employees."

"Knollwood is home to more than 300 retired officers and spouses who have served our nation for a lifetime, many in times of war," said Col. Paul Bricker (Ret.), COO of Knollwood Military Retirement Community in Ward 4. "We are proud to support the DC Council as they take this monumental step to make retired military pay exempt from DC income tax and assist in making Washington a retirement destination of choice. This gesture is another small way we can express our thanks for their sacrifices."

Councilmember Todd also introduced the District Wounded Warrior Parking Permit Act of 2019, which would create a parking permit for disabled veterans and Purple Heart recipients that provides free short-term parking at all District-owned and operated lots, garages, meters, and pay stations. Eligible recipients would apply for a unique placard issued by the District Department of Transportation, with renewal required after three years. States such as Oregon, Texas, Florida, Louisiana, and New Jersey have passed similar legislation. The bill was co-introduced by Councilmembers Nadeau, Silverman, Grosso, Bonds and R. White, and co-sponsored by Councilmembers Cheh, Allen, Gray, T. White.

"This bill is designed to remove roadblocks and help veterans access their personal and medical appointments with more ease and comfort," said Councilmember Todd. "As parking becomes increasingly challenging and costly in the District, we must take steps to ensure that those who sustained injuries in service to our nation are accommodated and supported."

### Congress Heights Community Training & Development Corporation (CHCTDC) Launches CBE Entrepreneurs Boot Camp



WASHINGTON, February, 2019 – Congress Heights Community Training & Development Corporation (CHCTDC) started an initiative dedicated to increasing the number of viable Ward 7 and Ward 8 Certified Business Enterprise (CBE) by launching this month an Entrepreneurs CBE Boot Camp.

The Boot Camp is designed as an opportunity to develop and support participants' business' development and growth. This multi-week, FREE course teaches participants and their team how to manage their firm/business; to secure CBE certification from DC Government; and to sell or win work opportunities in the highly competitive CBE market place. This immersive program is designed to impart practical advice and develop actionable skills for emerging and socially and economically disadvantaged Ward 7 and 8 entrepreneurs.

Each boot camp session does a deep dive into a subject area that founders of most early-stage companies and business owners need to navigate in order to succeed, grow and make money. "This initiative is long overdue and necessary for our small business technical assistance clients.",said Wendell Quann, CHCTDC's Director of Small Business Programs. "Ensuring that Wards 7 and 8's socially and economically disadvantaged small business owners are included in DC's procurement and contracting opportunities is a priority for us." "We have found that African-American business owners East of the River appear to be disproportionately excluded or waived out of DC's procurement contracting opportunities.", Quann concluded.

FREE small business technical assistance and program designed to provide local, small and disadvantaged business enterprises (LSDBEs) with equal access to economic and procurement opportunities by educating and training them. The aim is to increase the number of CBE's and ensure these businesses are prepared and prosper.

"CBE certification to expand contracting opportunities for small and local businesses by giving preference to certified business enterprises (CBEs)" said Monica Ray, Executive Director of CHCTDC. "DC government has many opportunities for public contracts and with this Boot Camp, we can better ensure that our Ward 7 and 8 small and local businesses are first in line for those government contracts".

As the District embarks on several large infrastructure and construction projects, it is critically important to keep as many dollars as possible within the District and maximize CBE and SBE participation to provide them with additional economic benefits in Wards 7 and 8.

Through its CBE Boot Camp, CHCTDC is training over 75 entrepreneurs to create viable CBE certified businesses. The Boot Camp sessions are held on Wednesdays from 6:00 pm until 8:00 pm at the Malcolm X Opportunity Center, 2nd Floor, 1351 Alabama Avenue SE, Washington DC 20032. The Boot Camp is a 6 Sessions camp held on February 13, 20 and 27th and March 6, 13 and 20th 2019. The culminating event of the Boot Camp is a Pitch Competition that will be held on Saturday April 13, 2019.

### Lyft Is Offering Low-Cost Rides to Grocery Stores in Ward 8



A six-month pilot program, from Lyft and Martha's Table kicked off in January to help residents living in D.C.'s biggest food deserts access groceries. The program allows select Ward 8 (and Ward 7) families to pay a \$2.50 flat fee for shared rides to and from the three full-service grocery stores east of the river, plus the lobby market at Martha's Table located at 2375 Elvans Road SE. There are two Safeways' (322 40th St. NE and 2845 Alabama Ave. SE) and one Giant (1535 Alabama Ave. SE).

Lyft and Martha's Table will identify 500 families to participate in the initial "Lyft Grocery Access" program. Each family must have a child enrolled at one of seven elementary schools in order to qualify: Anne Beers Elementary School, Garfield Elementary School, Moten Elementary School, Rocketship Rise Academy, Savoy Elementary School, Stanton Elementary School, and Turner Elementary School. Families with children participating in educational programs through Martha's Table are also eligible.

Those interested in joining the program can apply here. Registration is on a first come, first served basis. Registration will remain open until 500 families are enrolled.

### Angela Davis to receive civil rights award after museum reverses decision

The Birmingham Civil Rights Institute issued a public apology for denying the award and said there should have been more conversation

Asking the public to help "rebuild trust" in the Birmingham Civil Rights Institute, the chairman of the Alabama museum's board said on Friday it had reversed course after a public outcry and would give the activist Angela Davis an award that was offered then rescinded.

Davis was formerly an active member of the Black Panther party, the Student Nonviolent Coordinating Committee and the US communist party. The institute announced in October that she would receive the Fred Shuttlesworth Human Rights award.

But Davis is also an outspoken supporter of a movement criticizing Israel's treatment of Palestinians. Earlier this month, after a local Holocaust education group asked it to reconsider, the BCRI board withdrew the award.

In a statement issued amid widespread outcry, Davis said she had "devoted much of [her] own activism to international solidarity and, specifically, to linking struggles in other parts of the world to US grass roots campaigns against police violence, the prison industrial complex, and racism more broadly.

"The rescinding of this invitation and the cancellation of the event where I was scheduled to speak was thus not primarily an attack against me but rather against the very spirit of the indivisibility of justice."

The board issued a public apology and said there should have been more conversation before mak-

ing the decision to revoke the award.

In a statement issued on Friday, the BCRI said: "Immediately after that public apology, in keeping with its commitment to learning from its mistakes and in order to stay true to the BCRI's founding mission, the Board voted to reaffirm Dr Davis as the recipient.

"Dr Davis was immediately thereafter personally invited to reaccept the award. The BCRI respects her privacy and timing in whatever her response may ultimately be."

The BCRI president and chief executive, Andrea Taylor, praised Davis as "a daughter of Birmingham ... highly regarded throughout the world as a human rights activist".


"Her credentials in championing human rights are noteworthy," she said.

Rev Thomas L Wilder, interim chair of the BCRI board, said: "At the end of the day, we stand for open and honest dialogue on issues. It is only through our ability to talk openly and honestly with one another that we can achieve true understanding and appreciation for one another's perspectives."

After outlining the museum's "Vision 2020" strategic plan, he added: "We ask everyone to partner with us to rebuild trust in the institute and its important work."

Davis did not immediately comment.


