THE TOTALITARIAN VIRUS

INTRODUCTION

Lockdowns were initially introduced as temporary measures to “flatten the curve” and prevent healthcare systems from collapsing. It turns out the Covid19 fatality rates used to justify the first lockdowns were over-estimated by a factor of as much as 10 times. Published fatality rates are themselves grossly over-inflated using every conceivable artifice. Doctors have been “encouraged” to issue death certificates citing Covid19 as the primary cause of death. Those who object to this fraud are censored, and threatened with the loss of their jobs.

The number of deaths from loneliness, despair and suicide will far exceed deaths from the virus itself. Leading doctors, and even the World Health Organisation (WHO), have come out against lockdowns. Before the first UK lockdown even began, the British Government had already recognized that Covid19 was no longer a High Consequence Infectious Disease (HCID) in the UK, on account of its relatively low fatality rate. Sweden, which did not do lockdown, hasn't seen a meaningfully higher fatality rate than nations that did. For the purpose of saving human lives, draconian Covid19 lockdown restrictions make no sense at all.

All over the world, Covid19 has led to an unprecedented assault on our democratic freedoms. Under Covid19, the French need special documents to leave their home – the last time this happened was in WW2. A senior WHO official recommends that sick family members be forcibly removed from their homes – and nobody bats an eye. New Zealand builds mandatory quarantine camps. Australian police smash car windows and arrest old ladies for sitting on a bench during Covid19. A nurse who brings her 97 year old mother home from a nursing home gets arrested by police. The UK “opposition” calls for the censorship of voices opposing vaccines. Police encourage neighbour to snoop on neighbour. Government controls was once the preserve of North Korea have become the norm in once democratic states.

Covid19 restrictions no longer have anything to do with protecting public health, if they ever did. For the World Economic Forum (WEF), Covid19 represents a wonderful opportunity to remake the world in its image. Their Great Reset agenda includes a cashless economy, universal surveillance and world government among others. In the glorious future envisaged by the WEF, you will own nothing and have no privacy. Artificial Intelligence will eventually destroy your job, hence the need for a Universal Basic Income (UBI) scheme. In due course, a chip enabling the government to read into your thought will be inserted in your body, according to the WEF's influential founder, Klaus Schwab.

This is full blown totalitarianism to the benefit of the world's elites and to the detriment of the common peoples.

Back in 2010, the Rockefeller Foundation laid out a remarkably prescient pandemic scenario where a virus outbreak led to travel restrictions and draconian restrictions on individual liberties. The scenario presented matches the Covid19 sequence of events point for point. Barely a month before Covid19 broke out in Wuhan, China, in November 2019, a global pandemic exercise called Event201 was held in New York. The sponsors of Event201 were none other than the World Economic Forum and the Bill and Melinda Gates Foundation.

Bill Gates, the software billionaire turned philanthropist and self-styled health expert, has warned in no uncertain terms that life will not return to normal until all seven billion human beings have been vaccinated. Furthermore, ensuring all have been vaccinated will require digital proof of vaccination, to be carried on your mobile phone – or worse, in your body – without which you will not be allowed to travel or buy or sell or pretty much do anything. Numerous initiatives are afoot to create digital vaccination IDs. One of these initiatives, ID2020, is backed by the Rockefeller Foundation and the Bill and Melinda Gates Foundation. The Bill and Melinda Gates Foundation has showered the world's healthcare institutions with vast sum of monies. These funds appear to have been highly successful in purchasing an undue level of influence with government scientific advisors, who then go on to urge lockdowns and more lockdowns.

The fact that Covid19 is serving to usher in an agenda set by actors who predicted its emergence long in advance with an uncanny degree of accuracy strongly suggests that it was planned. Covid19 lockdowns and destruction of the economy are deliberately being used create despair so that mass vaccination with digital IDs certificates can be presented as the only way out.

What we are witnessing is essentially a coup d'état against democracy. If the Great Reset agenda is implemented under the guise of Covid19, your democratic freedoms will be rendered null and void. You will own no property and have no privacy, and be subject to 24/7 police state surveillance worthy of North Korea. Your children and your grandchildren will be condemned to live forever under an Orwellian nightmare, with no prospects of liberation.

THE VIRUS OF FEAR

"Whoever controls the people's fears becomes master of their souls" - Niccolo Machiavelli

As Machiavelli astutely observed, fear is a powerful means of social control. A fearful public will accept draconian curtailments of its democratic rights provided it believes the government is acting in the interest of its "safety". Hitherto unthinkable situations, such as the government arrogating for itself the right to decide which businesses are "essential" and which aren't, or fines for leaving your home without permission, become palatable or at least tolerated.

In March 2020, Imperial College released a bombshell report predicting up to 500,000 deaths in the UK, and up to 2 million deaths in the US, if lockdown were not imposed and Boris Johnson's

government continued to practice its initial strategy of herd immunity¹. The Imperial College report persuaded an initially reluctant Boris Johnson to impose lockdown in the UK on the 23rd of March 2020. The United States, France and Germany followed suit.

The man behind the Imperial College computer model, Professor Niall Ferguson, has a proven track record of grossly over-inflating potential deaths from disease. According to Professor Michael Thrusfield of Edinburgh University, during the 2001 foot & mouth outbreak, Professor Ferguson warned 150,000 people and could die. Six million animals were slaughtered as a precaution, causing billions of damages to the UK farming industry. In the end, 200 people died. During the 2005 bird flu outbreak, Niall Ferguson predicted 200 million could die. The final figure was in the low hundreds. In 2009, one of Niall Ferguson's computer model predicted that 500,000 people could die from swine flu in the UK. In the end, less than 500 died².

But the public had been successfully conditioned to fear Covid-19 under a relentless media fearmongering machine, which drummed in, day in and day out, how deadly the novel virus was.

Five months into the first lockdown, UK Covid19 fatalities stood at around 41,000¹⁸. Nowhere near close to 500,000. America's favourite doctor, Dr. Tony Fauci predicted that the US could see millions of cases and 100-200,000 deaths¹⁹. His predictions proved a rather closer to the mark than Prof. Niall Ferguson's. As of November 2020, the US had registered 10 million cases with 237,000 deaths²⁰. However, according to the CDC (Center for Disease Control), over 90% of US Covid19 patients suffered from an underlying condition such as hypertension, diabetes or obesity²¹. The CDC reported that only in 6% of US Covid19 deaths was Covid19 the only cause²². According to the CDC, Covid19 survival rates for patients below 70 are around 99.8%.

Was it worth putting 51 million Americans out of work to save them from a virus with a 0.2% fatality rate? ²⁴ The World Health Organisation has put its estimate of median Covid19 fatality rates at around 0.27% - far below the 3.4% estimate the organisation had pushed earlier, based on the experience in China²⁵. One researcher has concluded that "Sampling bias in coronavirus mortality estimations led to a 10-fold increased mortality estimation in March 11, 2020 US Congressional testimony...**Evidence from the WHO confirmed that the approximate Case Fatality Rate of the coronavirus is generally no higher than that of seasonal influenza.**"²⁶

In 2017/18, there were 50,100 excess deaths from flu in the UK, according to the Office of National Statistics (ONS)²⁷. The 1968 flu pandemic, a global pandemic that originated in Hong Kong, resulted in an estimated in an estimated 1 to 4 million deaths globally²⁸. Neither the 1968 flu nor the 2017/18 flu resulted in lockdowns, compulsory mask wearing or a media-orchestrated panic. Why is it now necessary to wreck the world economy and destroy any semblance of democratic freedoms over Covid19, when such measures were deemed unnecessary during previous flu seasons?

Dr. Roger Hodkinson, former Chairman of the Royal College of Physicians and Surgeons committee in Ottawa, has described Covid19 as an "**utterly unfounded public hysteria driven by the media and**

politicians. It's outrageous. This is the greatest hoax ever perpetrated on an unsuspecting public. (COVID-19) is nothing more than a bad flu season. This is not Ebola. It's not SARS. It's politics playing medicine, and that's a very dangerous game."²⁹

GASLIGHTING AS STATECRAFT

Did you know that as early as 19 March 2020, the British government no longer considered Covid19 to be a High Consequence Infectious Disease (HCID)? This is according to the government's own website³⁰.

Covid19 is no longer considered a High Consequence Infection Disease in the UK



In the UK, a high consequence infectious disease (HCID) is defined according to the following criteria:

- Acute infectious disease
- Typically has a high case-fatality rate
- May not have effective prophylaxis or treatment
- Often difficult to recognise and detect rapidly
- Ability to spread in the community and within healthcare settings
- Requires an enhanced individual, population and system response to ensure it is managed effectively, efficiently and safely

The British government website states that "more information is available about mortality rates (low overall)" (as of 19 March 2020), justifying removing Covid19 from the list of HCIDs. If the government acknowledges that Covid19 mortality rates are low overall, then why did Prime Minister Boris Johnson order a disastrous (first) national lockdown four days later?

Between March and June 2020, Boris Johnson's government spent £225 million building seven emergency Nightingale hospitals. Most of these seven hospitals failed to see a single Covid19 patient³¹. London Nightingale hospital, with a capacity of 4,000 beds (and 500 intensive care units), had admitted just 54 patients by June 2020³². Why were all these resources being expended when the government had already determined that Covid19 was no longer a High Consequence Infectious Disease in the UK?

A senior consultant, working for an NHS Hospital in Surrey, has written a detailed testimony to the effect that hospitals were empty during what was supposed to be the height of the pandemic.

However, doctors who revealed this truth were threatened with loss of income. Writing anonymously:

“In the months from March to June (inclusive) we would normally expect to see 100,000 out patients, around 30,000 patients admitted to hospital and perhaps 30,000 pass through A&E. This year (and these figures are almost impossible to get hold of) we are over 95% down on all those numbers. In effect, the hospital has been pretty much empty for that entire period.

At the start, staff that questioned this was told that we were being used as ‘redundant’ capacity, kept back for the ‘deluge’ we were told would come. It never did come, and when staff began to question this, comments like, ‘for the greater good’ and to ‘protect the NHS’ came down from above. Now it’s just along the lines of, ‘Shut up or you don’t get paid’.

The few Covid cases that we have had get repeatedly tested, and every single test counted as a new case. Meaning the figures reported back to ONS/PHE (Office for National Statistics & Public Health England) were almost exponentially inflated. It could be that Covid cases reported by hospitals are between 5 to 10x higher than the real number of cases. There has been no pandemic and this goes a long way to explain why figures for the UK are so much higher than anywhere else in Europe.”³³

Another NHS physician confirms that there was no Covid19 hecatomb in Britain between January and July 2020:

“Frankly, if it had not been for mainstream media and the government, I would not have even noticed there were a pandemic. I experienced no excessive dying, and no excessive becoming seriously ill. Since January, I have worked in three different general practices across England, in two regions. Accumulatively, they contained over 16,000 patients. Up to my last time of asking in September 2020 there had been many well Covid-19 “swab positives”, and only 5 deaths “with” a Covid-19 “swab positive”. Those 5 deaths were all white, over 60 years, with other co-morbidities.

“In the BAME-dominated practice of nearly 6000 where I work with the most deprived, the poor, the homeless, addicts, and migrants, no one was known to have died in association “with” a Covid-19 swab-positive test.

In the practice of 1800 where I worked through the inception and peak of the pandemic, only two people died of anything between January and July. These two were expected deaths of metastatic terminal cancer.”³⁴

Covid19 fatality rates are being inflated by all sorts of artifices. And not just in the UK. In Florida, a motorcycle accident victim was counted as a Covid19 victim³⁵. In South Carolina, Joan Hill, a dementia sufferer who died at the age of 79, had “Covid19 complications” listed as one of the causes of death along with Alzheimer, despite her family saying she never tested positive nor showed any symptoms³⁶.

Lena Kay was shocked when she saw Covid19 as a cause of death on the death certificate of her father, who had been dying from Alzheimer's for 10 years. Lena complained to her family doctor, who explained that **"orders from higher up in the NHS is anybody who dies during this time we have to put Covid19 on the death certificate"**³⁷. Before Lena Kay's dad died, a family friend, with a history of heart disease, died of heart attack. Covid19 was also put as cause of death on the death certificate. They were told the same thing by their family doctor: "orders from higher up, anyone who dies during this time, we have to put Covid19 on the death certificate".

As the Surrey NHS senior consultant confirms:

"Regarding death certification. All staff that are responsible for this have been encouraged where possible to put Covid-19 complications as reason for death, even though the patient may have been asymptomatic and also not even tested for covid. I feel this simply amounts to fraudulently completed death certificates and has been responsible to grossly inflating the number of Covid deaths.

The fact is that regardless of what you actually die of in hospital, it is likely that Covid-19 will feature on your death certificate. I have included with my statement the detailed published guidance from Government on Death Certification which shows how Covid-19, as a factor is encouraged to at least feature on a death certificate."

Why on earth would Boris Johnson's government cause the Covid19 death count to be artificially inflated? Could this be a way to retrospectively justify spending £225 million on emergency hospitals and explain away the economically disastrous first lockdown? But that is the case, it still doesn't explain why Boris Johnson's government instituted a second lockdown, when the grievous error of the first lockdown was apparent so early on.

The same fraudulent death certificate methods also apply in the United States. Senator Scott Jensen (R – Minnesota), a trained physician, reported that the American Medical Association is encouraging doctors to over-count Covid19 deaths. The reason is that Medicare reimburses hospitals \$13,000 for a patient admitted with Covid19, and \$39,000 if the Covid19 patient goes on a ventilator³⁸.

Because Covid19 deaths, though artificially inflated, are still too low to maintain panic mode, media and governments have taken to citing cases – rather than deaths – as a means to keep Covid19 panic well and alive. After all, the Covid19 virus is so utterly terrifying that 78% of sufferers don't show any symptoms³⁹ and don't even know they have it. The only way to know if they have Covid19 is to test them. And obviously, the more tests are carried out, the more cases arise, which serves to justify further economically destructive lockdowns. The fact that the tests are unreliable doesn't seem to matter, for they serve their purpose in maintaining a state of panic.

"Currently there are two types of diagnostic tests– molecular tests, such as RT-PCR tests, that detect the virus's genetic material, and antigen tests that detect specific proteins from the virus"⁴⁰. PCR (Polymerase Chain Reaction) tests are subject to "very high" false positive rate according to none

other than the UK's First Secretary of State Dominic Raab⁴¹. As one instance of this, 77 US NFL (National Football League) players were tested positive for Covid19. The following day, the players were re-tested, and came back negative⁴². Elon Musk, the famous entrepreneur behind Tesla and SpaceX, was subject to 4 antigen tests in rapid succession: 2 came back positive, 2 negative⁴³.

The President of Tanzania, John Magufuli, was so doubtful of the quality of the test kits his country was supplied with, that he ordered his security forces to investigate. They proceeded to randomly collect non-human samples from a goat, a sheep and a papaya. The lab workers were not told where the samples came from. The papaya and the goat both tested positive for Covid19⁴⁴.

The attempt to maintain Covid19 panic by hook and crook is a global phenomenon. In August 2020, Spanish television interviewed Dr. Luis de Benito on prime time. The journalists tried extremely hard to force Dr. de Benito to confirm their narrative that Spanish hospitals were being overwhelmed. The courageous doctor stubbornly refused, and patiently explained that the increase in cases resulted from an increase in PCR testing, which did not mean that patients were sick. The female journalist even tried to get the doctor to sing the praises of vaccines, but the plucky doctor responded that the only thing that needs vaccinating against is fear! Towards the end, we hear the voice of her frustrated male colleague interjecting "we have lost control, haven't we?"⁴⁵.

Dr. Mike Yeadon, former Vice President and Chief Scientific Officer for Pfizer, has come forward to say that "there is no science to suggest that a second wave should happen". Dr. Mike Yeadon says that half or even "almost all" Covid19 cases are false positives, and "given the "shape" of all important indicators in a worldwide pandemic, such as hospitalizations, ICU utilization, and deaths, "the pandemic is fundamentally over."⁴⁶

Despite the low Covid19 mortality rate, Boris Johnson's government keeps threatening the public with still more rules if they don't comply with the existing ones. Matt Hancock, Health Minister, warned the public to "follow Covid rules or they will get tougher"⁴⁷. Existing rules already prescribe a fine of up to £10,000 for those who fail to self-isolate on the basis of (highly unreliable) test results.

The Covid19 rules themselves make little sense if their prime objective is to protect the public from a virus whose fatality rate is sufficiently low for it not to be classified a High Consequence Infectious Disease. The British public are now prevented from travelling abroad for holidays in order "to protect the NHS and save lives". However, travelling abroad for assisted suicide is allowed⁴⁸. Why would a government ostensibly so determined to save lives that it is willing to wreck its economy for the purpose then allow an exemption for assisted suicide?

Thanks to Covid19, British students are treated as virtual prisoners, forced to eat alone at exam style desks while "security guards roam the halls in the evenings knocking on noisy doors, threatening

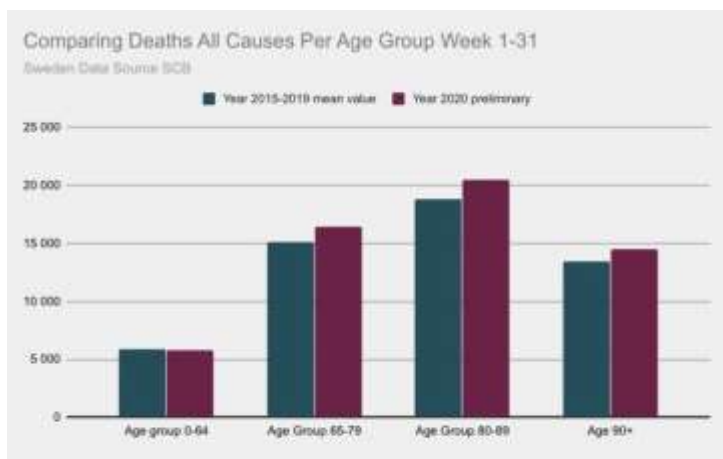

finances and suspensions”⁴⁹. Manchester University went as far as to build walls around student halls of residence to supposedly control the spread of the virus⁵⁰. The students finally had the guts to tear down their wall. Meanwhile, up to 450 Scottish prisoners were set to be released early so as to free up more cells for single occupancy and limit the spread of the virus⁵¹. Covid19 has created an Orwellian situation where actual prisoners get released early while students are treated as prisoners.

When Boris Johnson’s government instigated a 10:00pm curfew forcing bars and restaurants to shut, bars in the House of Commons were initially slated to be exempt from the measure – until public outrage forced a U-turn⁵². When his cabinet met together face to face in July for the first time in four months, they naturally exempted themselves from the obligation to wear face masks which they foisted upon everyone else⁵³. Would politicians really exempt themselves from the rules they expect others to follow if they really believed their own rhetoric that Covid19 is the worst thing since the 1918 Spanish Flu? Boris Johnson’s government has banned singing in churches, because congregational singing may “cause a risk of increased transmission of Covid-19”⁵⁴. The county of Cornwall, with 565,000 souls, was placed into lockdown when just 7 patients were suffering from coronavirus, with 3 in intensive care⁵⁵. This all makes sense, doesn’t it?

Sweden hasn’t had lockdowns, curfews or mask mandates. Despite its government not locking its people down, deaths in Sweden are broadly in line with the average for the previous five years⁵⁶.

For most of 2020, Covid19 fatalities per million in the UK actually exceeded those in Sweden. Because this fact is embarrassing for lockdown advocates, the media have been trying to spin Sweden as a Covid disaster. The Sun newspaper published the graph below under the blaring headline “Sweden’s coronavirus death toll is the HIGHEST in the world per capita over the last week

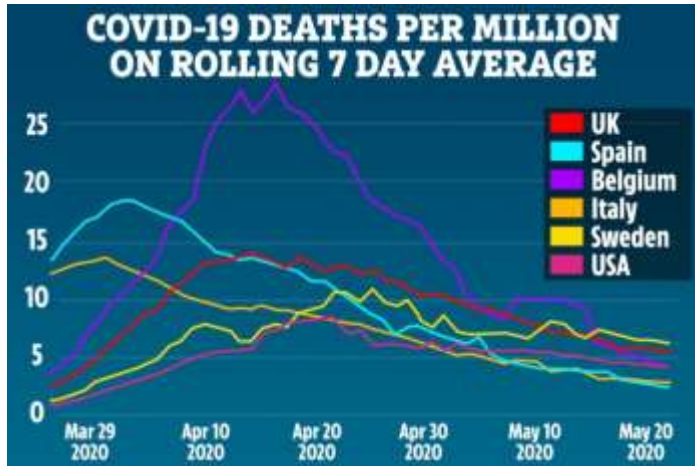

after ignoring lockdowns”⁵⁷. Clearly, the mainstream media not want you to realise that Sweden managed to avoid a massive Covid19 death toll without wrecking its economy and imprisoning its citizens.

Swedish deaths: in line with other countries, despite no lockdown



Gaslighting is “a form of psychological manipulation in which a person or a group covertly sows seeds of doubt in a targeted individual or group, making them question their own memory, perception, or judgment, often evoking in them cognitive dissonance and other changes, including low self-esteem, thereby rendering the victim additionally dependent on the gaslighter for emotional support and validation”⁵⁸.

It just does not make sense that draconian and often ridiculous restrictions on democratic freedoms should be imposed over a virus which the even government agrees presents a relatively low fatality rate, all else being considered. What are being gaslighted - and on an unprecedented scale.

KILLER LOCKDOWNS

If their purpose was to destroy millions of livelihoods and wreck the economy, lockdowns have worked like a charm. More than 50 million Americans have filed for unemployment benefits⁵⁹. One in five restaurants in the US may close their doors permanently⁶⁰. 60% of “temporary” Covid-19 small business closures may turn out to be permanent⁶¹.

British GDP fell by a record 20.4% during the first month of lockdown⁶². Welfare rolls swelled by 1.4 million, 7 times faster than usual⁶³. 6 million British small businesses are now at risk of failure and 16

million people are at risk of losing their jobs⁶⁴. Central London looks like a scene from the apocalypse: normally bustling shopping arcades are all boarded up and quiet⁶⁵. These businesses are not coming back.

Worldwide, the economic devastation has reached Biblical proportion. In India, 120 million people lost their jobs in April alone⁶⁶. The United Nations has warned that the number of people suffering from malnutrition could double to 260 million as a result of the Covid-19 recession⁶⁷. The World Bank has warned that Covid-19 could push 150 million people into extreme poverty by 2021⁶⁸.

As for the death toll, lockdowns will likely result in more deaths than the lives supposedly saved by them. A report by the British Government's own SAGE group, which is pushing for lockdowns, nevertheless projects that "75,000 people could die over the next five years from non-Covid causes as a result of the lockdown. More than 30,000 of these projected deaths will be the result of undetected cancers, cancelled operations and health problems associated with economic recession. 26,000 are expected to die if people continue to avoid seeking out critical medical care."⁶⁹

The mental health toll is enormous. In Japan, "**Far more Japanese people are dying of suicide, likely exacerbated by the economic and social repercussions of the pandemic, than of the COVID-19 disease itself**". As of October 2020, 17,000 people have taken their lives in Japan this year, versus less than 2,000 Covid19 deaths⁷⁰.

In September 2020, Belgian doctors signed a declaration harshly criticising harsh measures such as lockdown and mandatory mask wearing. "**There is no medical justification for any emergency policy anymore. The current crisis management has become totally disproportionate and causes more damage than it does any good. We call for an end to all measures and ask for an immediate restoration of our normal democratic governance and legal structures and of all our civil liberties.... The course of COVID-19 followed the course of a normal wave of infection similar to a flu season... If we compare the waves of infection in countries with strict lockdown policies to countries that did not impose lockdowns (Sweden, Iceland ...), we see similar curves. So there is no link between the imposed lockdown and the course of the infection. Lockdown has not led to a lower mortality rate.**"⁷¹

The Great Barrington declaration, signed by over 40,000 medical practitioners around the world, confirms that lockdowns do more harm than good:

"The Great Barrington Declaration – As infectious disease epidemiologists and public health scientists we have grave concerns about the damaging physical and mental health impacts of the prevailing COVID-19 policies, and recommend an approach we call Focused Protection.

Coming from both the left and right, and around the world, we have devoted our careers to protecting people. **Current lockdown policies are producing devastating effects on short and long-term public health. The results (to name a few) include lower childhood vaccination rates, worsening cardiovascular disease outcomes, fewer cancer screenings and deteriorating mental health – leading to greater excess mortality in years to come, with the working class and younger members of society carrying the heaviest burden.** Keeping students out of school is a grave injustice.”⁷²

In the UK, 70 high profile General Practitioners (GP’s) warned the government that a second lockdown “would cause more harm than good to the population’s ‘health and wellbeing’”. The GPs warned that lockdowns “threatens more lives and livelihoods than Covid-lives saved”⁷³. Needless to say, they were ignored.

Even the World Health Organisation has spoken out against continued lockdowns. Dr. David Nabarro of WHO has urged world leaders to stop “using lockdowns as your primary control method”. He indicated that “We in the World Health Organisation do not advocate lockdowns as the primary means of control of this virus”, and reminded listeners that “**Lockdowns just have one consequence that you must never ever belittle, and that is making poor people an awful lot poorer**”⁷⁴.

Covid19 lockdowns, ostensibly imposed to save lives, have created a deeply inhumane society where a nurse can be arrested for removing her 97 old mother from care home after she had been unable to see her mother for 9 months⁷⁵. A 104 year old care home resident in Scotland, Mary Fowler, tearfully begged to be allowed to see her family again⁷⁶. As might be expected, Scottish First Minister, Nicola Sturgeon, responded with the usual platitudes about keeping care home residents “safe”. “To Mary, I’m heart sorry for the position you’re in and the position your family’s in. That’s replicated many, many, many times over across the country. But we have to keep people in care homes as safe as possible”⁷⁷.

COVID19 TURNS COVID1984

Covid 19 has turned into a once in a lifetime opportunity for authoritarians of all stripes to roll back democratic freedoms in a way not even imagined during wartime. Early on in the pandemic, a senior World Health Organisation (WHO) official, Dr. Michael Ryan, called for family members of alleged Covid19 sufferers to be forcibly removed from their homes – and no one batted an eyelid.

“In most parts of the world, due to lockdown, most of the transmission that’s actually happening in many countries now is happening in the household at family level. In some sense transmission has been taken off the streets and pushed back into family units. Now, we need to go and look in

families to find those people who may be sick and remove them and isolate them in a safe and dignified manner⁷⁸.

Dr. Michael Ryan: sick family members to be removed in a “safe and dignified manner”



New Zealand is leading the way in removing sick family members in a “safe and dignified manner”. In a country better known for picturesque landscape, "mandatory quarantine will apply to both new cases and, if necessary, close family members who might be at risk", with forced removal from your home if you do not comply⁷⁹ When New Zealand sets up ~~concentration~~ quarantine camps for Covid19 ~~suspects~~ patients, you would expect the Covid19 death toll there to be pretty high, right? Wrong. As of the ~~concentration~~ quarantine camp announcement, New Zealand had just 22 alleged Covid19 deaths, for a population of 5 million. That’s a whopping mortality rate of 0.0004%. This is so lethal that democratic freedoms must turn asunder and the ~~Gestapo~~ friendly health officials empowered to knock on your door and remove you in a “safe and dignified manner”.

Canada also has big plans to build Covid19 internment camps. Ontario MPP Randy Hillier, raised a question about them in parliament, but only managed to secure an evasive answer to his question:

“In my supplemental question yesterday, I asked if the people of Ontario should prepare for internment camps. In September, the government posted a call for expressions of interest for contractors to provide, supply, and manage quarantine isolation camps throughout every province and every territory in Canada. These quarantine isolation camps, however, are not, however, limited to people with Covid, but provide a wide latitude for many people to be detained. Surely this government is aware of the intention to build these isolation camps from coast to coast. And my question to the premier is, how many of these camps will be built, and how many people does this government expect to detain?”⁸⁰.

Totalitarianism has become the norm. Covid19 has turned into Covid1984. Australia is the country where the process is most advanced. Melbourne cops were empowered to enter homes without a warrant, after an additional 11 people allegedly died of Covid19⁸¹.

In the state of Victoria, a pregnant woman was told by police she couldn't sit on a park bench because of Covid19. Two elderly women were arrested by police for sitting on a park bench.⁸² One Melbourne policeman virtually strangled a woman for failing to wear a face mask outside.⁸³ As an eyewitness described it, Victoria police have lost all common sense. Those who complain about Covid19 totalitarianism could soon find themselves detained under measures to detain so-called "Conspiracy Theorists" planned by the Australian government⁸⁴.

Australia's own Gestapo removing protesters in a safe and dignified manner



Dr. Bella d'Abrera, a Melbourne resident, seeing the state of Victoria's slide into totalitarianism, has said that **"there has to be a larger agenda. I do feel like Melbourne has been a test run and a test case to see how you can control a population, how you can manipulate a population—and it's being done absolutely brilliantly"**⁸⁵

In the United Kingdom, UK local councils have been given authority to demolish buildings, including private homes if they are contaminated by Covid19⁸⁶. UK police pepper-sprayed a man for refusing to wear mask on public transport⁸⁷. You can be fined £200 for leaving your house without good reason⁸⁸. Fines-for failing to self-isolate (when you have had a false-positive PCR test result, for instance) can reach £10,000⁸⁹. Police shoved a middle-aged woman to ground by during an anti-lockdown protest in Trafalgar Square⁹⁰. A German professor got arrested after speaking at an anti-lockdown rally in London⁹¹. One woman got threatened with police visit for not the NHS contact and

tracing app, which is supposed to be completely voluntary⁹². Perhaps it is time to consider rebranding the NHS as the Orwellian Health Service (OHS)?

Encouraging citizens to snoop on one another, once the preserve of states like the Soviet Union or North Korea, is now actively encouraged by the British police in a land that prides itself as being one of the world's oldest democracies⁹³. However, one may rightly question whether Britain is still a democracy at this juncture. When Boris Johnson's government ordered the second lockdown, the only thing the leader of the so-called "opposition", Keith Starmer, found objectionable was that it didn't happen earlier! The "opposition" Labour Party has called for emergency censorship laws against anti-vaccination content⁹⁴ to boot. What kind of a "democracy" is it when the only thing the so-called "opposition" finds objectionable about government measures is that they aren't harsh enough?

Lord Sumption, former Supreme Court Justice, has warned that Britain is at risk of exchanging democracy for totalitarianism:

"During the Covid-19 pandemic, the British state has exercised coercive powers over its citizens on a scale never previously attempted. It has taken effective legal control, enforced by the police, over the personal lives of the entire population: where they could go, whom they could meet, what they could do even within their own homes. For three months it placed everybody under a form of house arrest, qualified only by their right to do a limited number of things approved by ministers. All of this has been authorised by ministerial decree with minimal Parliamentary involvement. It has been the most significant interference with personal freedom in the history of our country. We have never sought to do such a thing before, even in wartime and even when faced with health crises far more serious than this one"⁹⁵.

Things aren't much better elsewhere. German parents face jails if they don't confine Covid-suspected children in their own rooms⁹⁶. Spanish police use helicopters to tell sunbathers to leave the beach – or else⁹⁷. Californian residents have discovered the joy of snooping on your neighbour, and have been known to report sneezing or coughing neighbours to police.⁹⁸ Pennsylvania has mandated that people wear masks inside their own homes, if they have visitors⁹⁹.

The people of France now need to fill in a police form before leaving their homes to go shopping. The fine is €135 for a first "offence", rising up €3,500 if they commit more crimes of leaving their homes without a paper "offences"¹⁰⁰. The last time the French needed special travel documents was during the German occupation. Covid1984, the totalitarian virus, will serve to justify anything.

Covid19 has served as a convenient pretext for the state to arrogate for itself the right to determine which items are essential and which aren't. In Ireland supermarkets are forbidden to sell clothing -

but socks, underwear and baby clothing are allowed¹⁰¹. France has taken the notion of the state deciding what is essential and what isn't to an extreme. Supermarkets are allowed to sell socks, but not slippers. USB keys and other IT supplies are safe, but children's toys are dangerous. Household cleaning product as safe, but children's gifts aren't. According to a French opposition politician, Francois Asselineau, these apparently irrational rules are in fact a psy-ops operation whose objective is the destruction of any idea of resistance or rationality in the population¹⁰².

One thing is certain: this creeping totalitarianism has very little to do with protecting your health. In Nigeria, security forces enforcing lockdown killed more people than the virus in the first three weeks of lockdown. According to Nigerian Health Ministry data, the virus had killed 12 people in Nigeria from the beginning of lockdown in late March until the 16th of April 2020. Over the same period, Nigerian security forces killed 18 people enforcing the lockdown had killed 18 people¹⁰³. Ugandan police had killed 12 people while enforcing lockdown as of July 2020. Over the same time period, only one person had died from Covid19 in Uganda¹⁰⁴.

If this what a virus with a 0.2% mortality rate has wrought, imagine what would happen if Covid-19 mutated or a virus with a far higher lethality somehow got released?

HOLDING HUMANITY HOSTAGE TO A VACCINE

Back in June 2020, the UK hosted the Global Vaccine Summit. Representatives from 52 countries were in attendance, including 35 leaders from global health organisations and vaccine manufacturers. World leaders pledged \$8.8 billion to Gavi, the self-styled Vaccine Alliance, to "immunise 300 million children and support the global fight against Covid-19"¹⁰⁵. The British Government pledged to contribute £1.65 billion to Gavi over the next 5 years¹⁰⁶.

Gavi was founded in 2000 as a global health partnership. The organisation is headquartered in Geneva. The founding partners are The Bill & Melinda Gates Foundation, UNICEF, the World Health Organization, and the World Bank¹⁰⁷. Gavi received an initial pledge of \$750 million from the Bill & Melinda Gates Foundation in 1999¹⁰⁸. During the Global Vaccine Summit, the Bill & Melinda Gates Foundation pledged \$1.6 billion, bringing its total commitment to Gavi to date to \$4 billion¹⁰⁹.

Bill Gates has warned us repeatedly. There cannot be a return to normal until every single human being on the planet has been vaccinated. As the maestro writes on his personal blog:

"One of the questions I get asked the most these days is when the world will be able to go back to the way things were in December before the coronavirus pandemic. My answer is always the same: when we have an almost perfect drug to treat COVID-19, or when almost every person on

the planet has been vaccinated against coronavirus....Humankind has never had a more urgent task than creating broad immunity for coronavirus. Realistically, if we're going to return to normal, we need to develop a safe, effective vaccine. We need to make billions of doses, we need to get them out to every part of the world, and we need all of this to happen as quickly as possible"¹¹⁰

Bill Gates has given numerous interviews underscoring the point. "Until we get almost everybody vaccinated globally, we still won't be fully back to normal"¹¹¹. Scott Morrison, the Australian Prime Minister, agrees with Mr. Gates: life will not return to normal until a vaccine is available. "A vaccine ultimately enables everybody to go back to life as it was. In the meantime, we'd have to be careful that if we are ever to ease restrictions that we just wouldn't then see a rush on the virus again and our worst fears realised."¹¹² So it would appear that the choice is vaccination or permanent lockdown. Take your pick. It seems no other possibility is being envisaged by our elites.

There is obviously no way all seven billion human beings on Earth will be vaccinated if vaccination were left to individual discretion. Accordingly, the Australian Prime Minister has called for the vaccine to be "as mandatory as you can possibly make it"¹¹³ He later backtracked from this position after it caused a furore. UK Health Secretary Matt Hancock is on the record as not ruling out compulsory vaccination¹¹⁴. In Switzerland, "while Swiss law doesn't allow authorities to force anyone to be immunised against their will, a health official said coronavirus vaccine could be obligatory for some people" such as health care workers¹¹⁵. In Malaysia, the Health Minister has stated that "There is a big possibility it may be compulsory, but we have to assess before making a decision"¹¹⁶. Denmark had prepared a law giving health authorities the power to forcibly inject people with vaccines, with physical detainment and police help if necessary. After 9 days of public protests, the proposed law was dropped¹¹⁷.

Danes successfully protest against a forced vaccination law



Galicia, a Spanish region, has been rather more explicit about its intention to make Covid-19 testing, quarantine, medical treatment and vaccination potentially compulsory. The region is in the process

of passing the legislative framework to make vaccination mandatory, with fines of up to 600,000 Euros for non-compliance¹¹⁸. However, Alberto Feijóo assured the press that they the Galicia government would only have the power to enforce compulsory vaccination if the WHO or the EU decided to make vaccination compulsory. At least we know who's behind this.

How will the authorities know who has been vaccinated and who hasn't? Worry not, Bill Gates has the solution:

“Eventually what we’ll have to have is a certificate of who’s a recovered person, who’s a vaccinated person, because you don’t want people moving around the world where you’ll have some countries that won’t have it under control, sadly.”¹¹⁹

As luck would have it, there is an organisation dedicated to ~~inflicting~~ bestowing a digital identity on every human being on the planet. The initiative is called ID2020. The organisation, set up in 2016, proclaims that: “Identity is vital for political, economic and social opportunity. But systems of identification are archaic, insecure, lack adequate privacy protection, and for over a billion people, inaccessible. Digital identity is being defined now – and we need to get it right”¹²⁰.

The sponsors of ID2020 are Gavi, the self-styled Vaccine Alliance, Microsoft, and the Rockefeller foundation. The fact that Gavi, the self-styled Vaccine Alliance, is a key sponsor of the digital ID initiative is clear proof that the vaccine is to be rolled out with digital proof of vaccination.

Digital ID initiatives in connection with Covid-19 are proliferating like bad weed. The Covid-19 Credentials Initiative (CCI) claims to be “a global community of more than 300 individuals from over 100 organizations looking to deploy and/or help to deploy privacy-preserving verifiable credential projects in order to mitigate the spread of COVID-19 and strengthen our societies and economies.”¹²¹

Covi-Pass is the result of a partnership between VST Enterprises, a Manchester based digital security firm, and Circle Pass Enterprises (CPE), a digital health company. The initiative aims to create a digital health passport designed to “manage a safe return to work, life, and safe travel after the Covid-19 coronavirus pandemic”¹²² This digital health passport is to be supplied to “15 countries around the world, including Italy, Portugal, France, Panama, India, the US, Canada, Sweden, Spain, South Africa, Mexico, United Arab Emirates and The Netherlands, with the goal of supplying 50 million digital health passports”. “The Covi-pass will work using a colour system of green, amber, red to indicate whether the individual has tested positive or negative for Covid-19 and relevant health information.” Covi-Pass “will help monitor every aspect of citizens’ lives in the name of strengthening public health management”¹²³.

The Iris based ROQU Group claims to have launched the world’s first health passport digital platform. The passport “has been developed to help national economies by enabling businesses to remain open through continuous proactive testing of employees, identifying positive results at the

earliest stage whilst simultaneously protecting communities by offering increased testing. The platform will enable businesses and individuals to quickly minimise risks related to COVID-19 and ensure they can continue daily activities.”¹²⁴

Not to be left outdone in the race to make our world as Orwellian as possible, the World Economic Forum (WEF) is touting its CovidPass as “the future of travel and events”¹²⁵. The application will “store encrypted data from individual blood tests, allowing users to prove that they have tested negative for COVID-19.”¹²⁶

What happens if you want to fly but don’t have a digital health passport? You don’t get to fly. With an article titled “Want To Fly? You May Need This Blockchain-Backed Health Passport”, Forbes Magazine predicts that “to travel internationally shortly you won’t just need a paper passport; you’ll likely need a digital one. This will be a smartphone app—secured by blockchain protocols—that certifies you’re not infected with COVID-19.”¹²⁷ Things couldn’t be clearer than that, could they? Alan Joyce, the Qantas CEO has already announced that the airline will make Covid19 vaccination compulsory for boarding its international flights¹²⁸.

Want to travel? Don’t forget your health passport!



In fact, it seems that without the digital proof of vaccination certificate, you won’t be able to shop or go to work. This is already pretty much reality in Singapore:

“To go anywhere in Singapore these days, Joni Sng needs mobile phone apps and other technologies: a QR code to enter shops, a digital map to see how crowded a mall or park is, and a tracker to show if she was near someone infected with the coronavirus.

For the roughly 5.6 million people in Singapore, these actions are routine as the government eases restrictions placed to contain the spread of the disease.

‘The apps are quite convenient and easy to use, and I feel a little safer knowing that everyone else is also using them,’ Sng, a videographer, told the Thomson Reuters Foundation.

‘It has become very natural to click on the apps while going somewhere, just like wearing a mask’, she said.”¹²⁹

Reassuring to know that tyranny comes in such a convenient package, and is so easy getting used to! This dystopian vision of the future is coming soon to a place near you.

The British Government is planning to spend £100 billion of monies it doesn’t have on Operation Moonshot to roll out digital immunity passports by 2021. The digital immunity passports “will be used to allow people who have tested negative for the virus to return to work, to travel and to take part in other activities.”¹³⁰ For now, the focus of Operation Moonshot is mass testing, not proof of vaccination.

Beginning September 24, 2020, all UK businesses have been obliged to display the NHS QR code poster to “allow customers to check-in and log their details for the NHS Test and Trace service”¹³¹. And it’s not just businesses. Our Lady of Lourdes & St. Bernadette Catholic Church in Bristol has introduced the NHS QR code and displayed it at various points in the church porch¹³². Other churches will surely follow. One day, without your digital ID, you will not be able to travel, shop, work, attend church, or pretty much do anything.

THE GREAT RESET

The World Economic Forum (WEF) is best known for organizing the annual Davos summit, a four day junket that sees world's billionaire oligarchs, politicians and celebrities take the quaint little Swiss town of Davos by ~~storn~~ private jet. But make no mistake: the WEF has big plans for your future.

As far as the WEF is concerned, Covid19 represents a “unique window of opportunity to shape the recovery, this initiative will offer insights to help inform all those determining the future state of global relations, the direction of national economies, the priorities of societies, the nature of business models and the management of a global commons”¹³³. The WEF calls this brave new world the “Great Reset”.

Klaus Schwab, the WEF's founder and chairman since 1974, has made it clear that no country and no aspect of the world economy will be spared from the imperative of the Great Reset:

“To achieve a better outcome, the world must act jointly and swiftly to revamp all aspects of our societies and economies, from education to social contracts and working conditions. Every country, from the United States to China, must participate, and every industry, from oil and gas to tech, must be transformed. In short, we need a ‘Great Reset’ of capitalism”¹³⁴.

Covid19: a fantastic opportunity to remake the world



Technology will play a key role in this brave new world. In his 2016 book, “The Fourth Industrial Revolution”, Klaus Schwab enthuses about the endless perspectives offered by technologies such as Artificial Intelligence (AI) and drones:

“Consider the unlimited possibilities of having billions of people connected by mobile devices, giving rise to unprecedented processing power, storage capabilities and knowledge access. Or think about the staggering confluence of emerging technology breakthroughs, covering wide-ranging fields such as artificial intelligence (AI), robotics, the internet of things (IoT), autonomous vehicles, 3D printing,

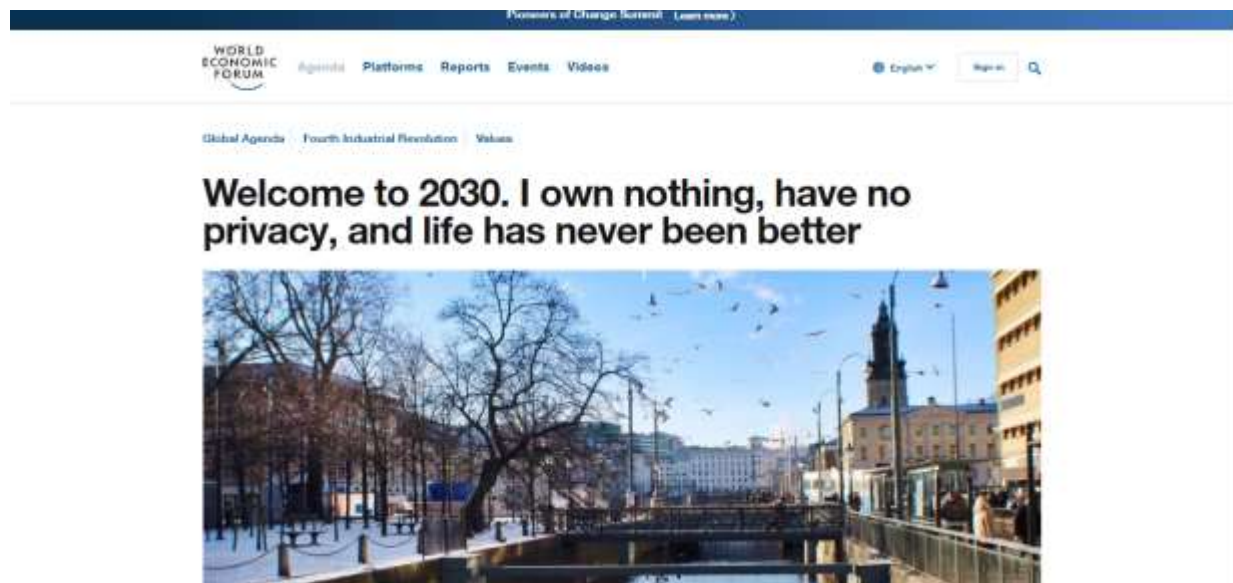

nanotechnology, biotechnology, materials science, energy storage and quantum computing, to name a few. Many of these innovations are in their infancy, but they are already reaching an inflection point in their development as they build on and amplify each other in a fusion of technologies across the physical, digital and biological worlds¹³⁵

These wonderful new technologies may lead to massive job losses. But don't worry about it. The World Economic Forum sees a glorious future where people "own nothing" and "have no privacy"¹³⁶. And by nothing, the WEF really means nothing: "I don't own anything. I don't own a car. I don't own a house. I don't own any appliances or any clothes."

A glorious future: the people will own nothing and have no privacy



Presumably, this material dispossession shall not apply to the sort of people who get invited to the Davos summit every year. Billionaires have done very well out of Covid19, growing their collective net worth by \$637 billion in the US alone, while small businesses have been pumelled¹³⁷.

Transhumanism, the merger of man and machine, is the future according to Klaus Schwab. **"At the end, what the 4th Industrial Revolution will lead to is a fusion of our physical, our digital and biological identities"**¹³⁸. **Chips that can read your thoughts will be inserted into your body, allowing governments to "intrude into the hitherto private space of our minds, reading our thoughts and influencing our behaviour."**¹³⁹ One wonders what Hitler and Stalin could have accomplished had they had the technology to read into peoples' minds and influence their behaviour electronically?

Time Magazine, owned by billionaire Marc Benioff, who just so happens to be a World Economic Forum trustee member¹⁴⁰, has honoured the “Great Reset” and the “Fourth Industrial Revolution” with front page covers. The Time headline reads “Your move, humans”, but it might as well scream “Move over, humans”.

Humans to be replaced by robots and the world rebuilt to the liking of Davos billionaires



If all this sounds impossible, then consider that Rahm Emmanuel, former advisor to the Obama administration, famously proclaimed that “You never let a serious crisis go to waste. And what I mean by that it's an opportunity to do things you think you could not do before”. Right on cue, Covid19 is being used to implement a pre-existing agenda.

A “cashless society” has been talked about for quite some time. From the perspective of the world’s elites, a cashless society affords two benefits: the complete death of financial privacy and the ability for central bankers to drive interest rates negative without hindrance and thereby confiscate your life savings, impoverishing the middle classes, more quickly. A cashless society also provides the added “benefit” of making it possible for governments to prevent someone whose vaccination record is not up to date (or who have expressed a view the government disagrees with) from buying or selling anything.

“17 ways towards which Covid19 is ushering us towards a cashless society”, Nayax, 23 July 2020¹⁴⁶

WHO, one of the main architects of the Covid19 panic, has wasted no time in warning that “people should stop using banknotes and make contactless payments instead to prevent the spread of the coronavirus”¹⁴⁷. Mastercard, a company committed to “to leading the way toward a World Beyond Cash™”, is also the technology partner to Gavi, the Vaccine Alliance (about which more later)¹⁴⁸. The message could not be clearer: no vaccination record means no buying and selling for you.

Universal Basic Income (UBI) has been increasingly discussed. The basic idea is that governments should provide everyone with a no questions asked guaranteed income to make ends meet. If we ever reached a situation where Artificial Intelligence (AI) should come to displace all jobs, from the most unskilled to the most skilled, then it could some sense to tax the robots to provide a decent minimum standard of living for human beings. However, when governments are wantonly destroying millions of livelihood through lockdowns, replacing lost income with UBI is starting to look an awful lot like an attempt to introduce communism by the back door. One will not be surprised to discover that Covid19 has unleashed a deluge of calls to introduce Universal Basic Income:

How very remarkable that ostensibly unrelated publications across continents should be pushing the same idea, sometimes within days of one another. One would almost think they were acting under the guidance of a hidden hand telling them to push the same agenda.

Global government is another long term objective of the Great Reset/New World Order. Did you know that “solving” Covid19 may require a world government? Gordon Brown, former UK Primer

Minister, has called for a “temporary” world government to tackle coronavirus¹⁵⁷. UN chief Antonio Guterres has called for “improved world governance”, a codeword for world government¹⁵⁸. A number of so-called “world leaders” have called on the UN to institute global governance to save us from “Covid19” and “climate change”¹⁵⁹.

They are by no means the first in calling for world government to fight pandemics. In a 2015 interview to Sueddeutsche Zeitung, Bill Gates called for world government as a useful tool to solve pandemics. "But what about epidemics? How many doctors do we have for it, how many airplanes, tents, scientists? If there were such a thing as a world government, we would be better prepared."¹⁶⁰

We may already be living under world government, in disguised form. Back in March 2020, Belarus was negotiating with the International Monetary Fund (IMF) for a \$940 million loan. According to Belarussian President Alexander Lukashenko, who did not place his population under house arrest as the “democracies” did, the IMF insisted on the imposition of “quarantine, isolation, curfew” to release their loan. An IMF spokesman, Gerry Rice, confirmed that while the IMF “did not demand quarantine, isolation, lockdown”, it “sought assurances for steps to contain the pandemic in line with WHO recommendations”, so “just the same”¹⁶¹. Lukashenko, branded a “dictator” by the Western media, refused to place his people under house arrest as the Western “democracies” did.

Now why on Earth would the IMF, ostensibly an organisation with a purely economic purpose, impose health policy conditions on a loan to Belarus? One answer is that we already living under a hidden world government, of sorts, where no nation can be allowed to diverge from the policies of other nations. Belarus refused was one of a few nations not to impose lockdown, and this was unacceptable to the New World Order.

WAS IT PLANNED?

In 2010, the Rockefeller Foundation published a prophetic report titled “Scenarios for the Future of Technology and International Development”¹⁶². The document describes a hypothetical pandemic set in 2012. The purported sequence of events bears is eerily similar to what would play out 10 years later with Covid19. In the Rockefeller Foundation scenario, it’s a “new influenza strain”, “infecting nearly 20 percent of the global population” and “killing 8 million in just 7 months, the majority of them healthy young adults”. This pandemic has a “deadly effect on economics”. **“International mobility of both people and goods screeched to a halt, debilitating industries like tourism and breaking down local supply chains. Even locally, normally bustling shops and office buildings sat empty for months, devoid of employees and customers”** (p.18).

The pandemic envisaged the Rockefeller Foundation provides a wonderful pretext for governments to curtail the liberties of their citizens. The Chinese government immediately responds with the

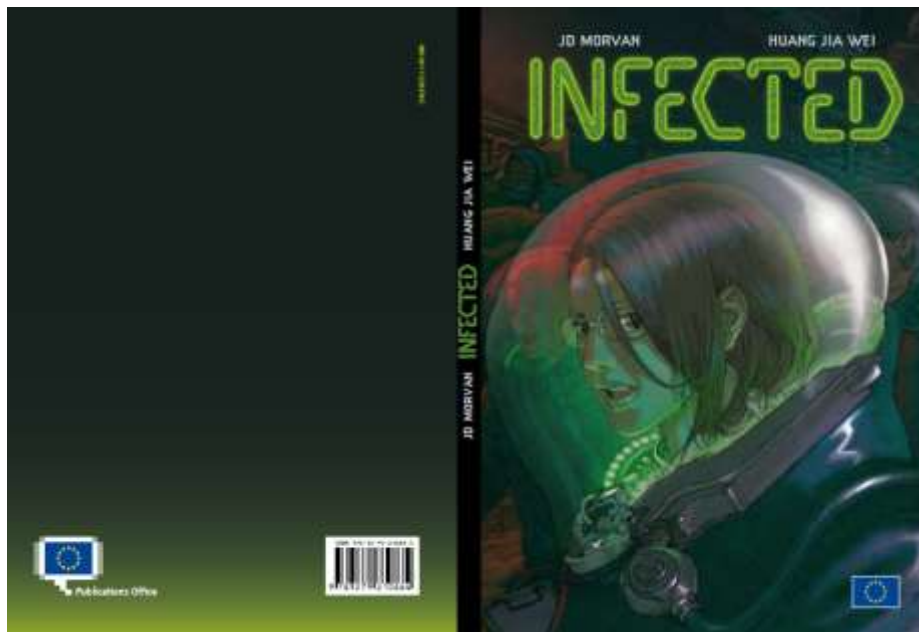

“quick imposition and enforcement of mandatory quarantines for all citizens” and “instant and near-hermetic sealing of borders” (p.18). **“National leaders around the world flexed their authority and imposed airtight rules and restrictions, from the mandatory wearing of face masks to body-temperature checks at the entries to communal spaces like train stations and supermarkets. Even after the pandemic faded, this more authoritarian control and oversight of citizens and their activities stuck and even intensified”** (p.20).

What amazing prophetic powers the Rockefeller Foundation have! The collapse of international tourism, empty office buildings, mandatory quarantines, face masks and citizens eagerly embracing state control in the name of security, all predicted, with eerie accuracy, 10 years before the fact.

In 2012, the EU sponsored the publication of “Infected”, a comic book by French writer Jean-David Morvan¹⁶³. In the comic, a man travels from the future to our time to prevent a devastating pandemic, with the help of the Chinese assistant to the UN’s top pandemic expert. The scenes begin in Beijing. After 6 weeks, the virus is with the help of the vaccine developed from samples given by the man from the future. The EU congratulates itself on limiting fatalities to less than 1 million.

In 2015, Bill Gates predicted that "if anything kills over 10 million people in the next few decades, it's most likely to be a highly infectious virus rather than a war"¹⁶⁴.

One year later, it was Dr. Anthony Fauci’s turn to play prophet. At that time, 2016, Dr. Fauci was already the director of the National Institute of Allergy and Infectious Diseases, a ~~secure~~ position he has held since 1984. The good doctor warned us that “there is no question that there will be a challenge to the coming administration in the arena of infectious diseases” and “there will be a

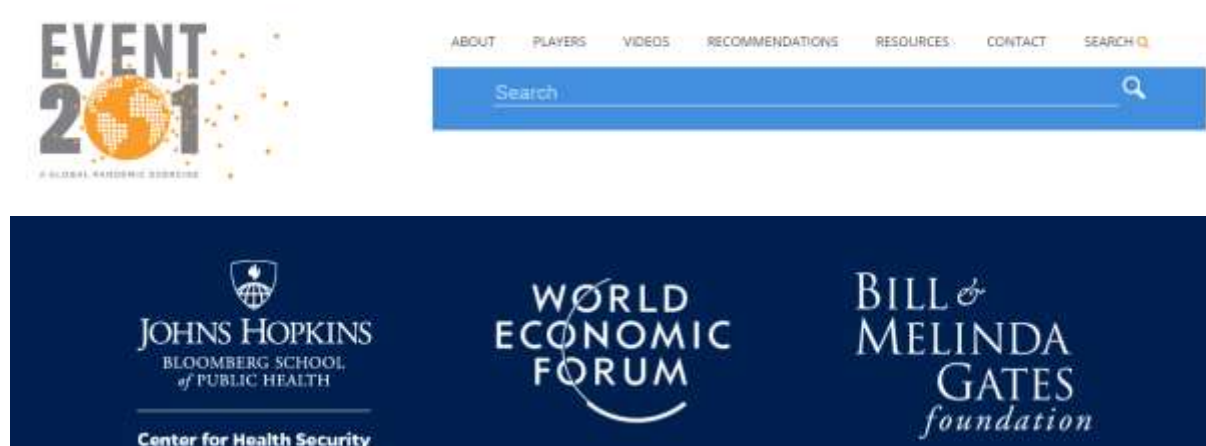
surprise outbreak”¹⁶⁵. Dr. Fauci’s powers of prediction are almost as uncannily accurate as that of the Rockefeller Foundation. Just how did Dr. Fauci know that “there will be a surprise outbreak”? Aren’t surprises supposed to be, well, surprises?

2016 saw the birth of the ID2020 initiative. You will recall that ID2020 is the UN backed initiative pushing for digital ID’s globally. Gavi, the self-styled Vaccine Alliance backed by the Bill & Melinda Gates Foundation, is one of the main ID2020 backers. Why did its founders decide to name their organisation ID2020 back in 2016? How did they know a digital ID would come in handy in 2020?

Event201 was a pandemic preparation desktop exercise held on the October 18, 2019, a month before the breakout of Covid19 in Wuhan¹⁶⁶. Event201 stressed the need to “prepare for the event that becomes a pandemic”. The main sponsors of Event201 were the Bill & Melinda Gates foundation, the World Economic Forum (WEF) and the John Hopkins Bloomberg School of Public Health.

In July 2020, John Hopkins published a document essentially calling for vulnerable populations such as older adults, low income adults, Black and minority communities to be denied food packages, rental assistance and healthcare if they did not take the Covid19 vaccine¹⁶⁷.

Event 201: a remarkably timely “exercise” sponsored by the usual suspects



Then there is the fact that Covid19 came at a propitious moment. All over the world, the people were beginning to revolt. In France, the Yellow Jacket protests began with planned fuel rises that President Macron’s government wanted to implement in December 2018. The movement quickly morphed into a broader revolt of the have-nots against an out of touch elite. Despite making liberal use of police violence, maiming some protesters for life and taking out eyes and hands, President Macron’s was unable to put down the protests which persisted throughout the whole of 2019. Lebanon also widespread protests over the high cost of living in 2019, and as in France, these were

met with beatings, tear gas, rubber bullets and occasionally, live bullets¹⁶⁸. Hong Kong saw massive pro-democracy protests starting March 2019. As in France and Lebanon, police brutality was tried, but failed to quell the protests. What better way could there be to quell popular revolts than telling the people to stay home to save themselves from a deadly virus?

So we have pandemic making its appearance at a particularly opportune time and helping to usher a pre-existing agenda. The pandemic and its resulting harsh crackdowns on democratic freedoms were predicted a decade before the fact by the Rockefeller Foundation. By “coincidence”, the Rockefeller Foundation happens to be one of the sponsors of ID2020, the digital vaccine certificate supported by the Bill and Melinda Gates foundation. By “coincidence”, the Bill and Melina Gates Foundation is a sponsor of Event201, along with the World Economic Forum, which regards Covid19 as a wonderful opportunity to remake the world. The third major sponsor of Event201, John Hopkins, later comes up with a report in effect calling for vulnerable populations to be coerced into taking the vaccine.

When an event like Covid19 is helping to user in a pre-existing agenda, while the constellation of interconnected actors behind the pre-existing agenda happen to also be the ones who have predicted the event with uncanny prescience well before the fact, one may reasonably be certain that what we are facing is no accident, but something that was deliberately planned.

WHAT DRIVES THE WORLD’S MOST GENEROUS MAN?

Bill Gates is a very generous man. In 2010, Mr. Gates made quite a splash when he pledged to give away most of his fortune, estimated at \$95.5 billion¹⁶⁹. The Bill & Melinda Gates, ostensibly set up for the purpose of giving away the Gates fortune, has been generous to a fault. Below is partial list of their grants exceeding \$10 million:

- \$40 million to the London School for Hygiene and Tropical Medicine (July 2000)¹⁷⁰
- \$32 million to Imperial College for Schistosomiasis Control Initiative in Africa (June 2002)¹⁷¹
- \$39.8 million to the London School of Hygiene and Tropical Medicine (October 2007)¹⁷²
- \$16.5 million to Imperial College for agriculture development in Africa (October 2009)¹⁷³
- \$16 million to the London School of Hygiene and Tropical Medicine (November 2010)¹⁷⁴
- \$37 million to Imperial College for malarial eradication (June 2016)¹⁷⁵
- \$10 million to the London School of Hygiene and Tropical Medicine (July 2016)¹⁷⁶
- \$50 million to WHO for key health technologies (October 2017)¹⁷⁷
- \$27 million to African Agricultural Technology Foundation (March 2018)¹⁷⁸
- \$80 million to WHO for polio eradication (August 2018)¹⁷⁹

- \$64.8 million to WHO for polio vaccination in Pakistan (August 2018)¹⁸⁰
- \$37.1 million to WHO for polio vaccination (August 2019)¹⁸¹
- \$19 million to WHO for the treatment of bacterial infections (November 2019)¹⁸²
- \$79 million to Imperial College for malarial control in sub-Saharan Africa (March 2020)¹⁸³
- \$30 million to WHO for purchasing polio vaccines (October 2020)¹⁸⁴
- \$34.4 million to WHO for effective regulation of health products (October 2020)¹⁸⁵
- \$20 million to LumiraDX, maker of a Covid19 test (November 2020)¹⁸⁶

If the purpose of this torrent of generosity towards the world’s healthcare institutions is giving away the Gates fortune, then the endeavour has been an abject failure. After a decade of ostensibly trying to give away his wealth, Mr. Gates is now worth \$102 billion¹⁸⁷, about the same as when he pledged to give it all away.

Before he turned to philanthropy, Bill Gates was better known as the software tycoon who ran Microsoft. Under his leadership, Microsoft wasn’t particularly renowned for philanthropy. Back in the 1990s, Microsoft attempted to force Netscape to accept an (illegal) market sharing agreement. As Netscape CEO James Barksdale recounted:

“I have never been in a meeting in my 35-year business career in which a competitor had so blatantly implied that we would either stop competing with it or the competitor would kill us. In all my years in business, I have never heard nor experienced such an explicit proposal to divide markets.”¹⁸⁸

How did Bill Gates make such a seamless transition from ruthless businessman to cuddly philanthropist dedicated to (unsuccessfully) disposing of his fortune while taking over the world’s healthcare system? Why is the man who got rich by selling software subject to all sorts of bugs and viruses so hell bent on vaccinating every human being on the planet against viruses? What does he know about viruses that we don’t?

The Bill Gates family history may provide a clue. Bill Gates was close to his father, Bill Gates Sr., a prominent Washington state lawyer. Bill Gates Sr. served on the board of numerous organisations, including Planned Parenthood¹⁸⁹.

Planned Parenthood is the largest provider of abortion in the United States, and the main political force behind the pro-abortion movement in that country¹⁹⁰. It was founded in 1921 as the American Birth Control League by Margaret Sanger¹⁹¹. Margaret Sanger believed in eugenics, the pseudo-science which advocated (in her own words) “the gradual suppression, elimination and eventual extinction, of defective stocks — those human weeds which threaten the blooming of the finest

flowers of American civilization.”¹⁹² Eugenics fell rather out of fashion after WW2, for obvious reasons. In the 1900s to the 1930’s, though, it was extremely popular. One of the largest funders for the eugenics movement in the early 1900s was none other than the Rockefeller Foundation¹⁹³.

Like his father, Bill Gates is big on population control. In a 2011 TED talk conference, Bill Gates has made it clear that he views population reduction as essential to achieve a zero carbon emissions world. Vaccines and healthcare are essential tools in this population reduction arsenal:

“The world today has 6.8 billion people. That’s headed up to about 9 billion. Now if we do a really great job on new vaccines, healthcare, reproductive health services, we could lower that by perhaps 10 or 15%”¹⁹⁴

This view of vaccines and healthcare as means of population reduction is odd to say the least. Bill Gates loves vaccines with a passion. He has described them as “my best investment”¹⁹⁵. In one interview, Bill Gates admitted that 700,000 people would suffer and develop side effects from Covid19 vaccines¹⁹⁶. A Danish government sponsored study has shown that showing that the DTP vaccine, a flagship WHO/GAVI programme for African babies, resulted in vaccinated children dying at 10 times the rate of unvaccinated children¹⁹⁷

Let’s vaccinate the world to reduce the population by 10-15% and cut CO2 emissions!



While Bill Gates’s philanthropy may have been spectacularly unsuccessful at disposing of his great wealth, it has bought him one thing: influence. As but one example of this, the Bill & Melinda Gates Foundation have given well over \$100 million to the London School of Hygiene and Tropical (LSHT)

medicine. Before becoming Chief Medical Officer (CMO) for England, Chris Whitty was a professor at the LHST, an organisation Bill Gates personally visited in 2016¹⁹⁸.

Unsurprisingly, Professor Chris Whitty has been one of the most vocal proponents of harsh lockdowns in the United Kingdom. Together with Sir Patrick Vallance (whose dementia fund has attracted \$50 million from the Bill & Melinda Gates foundation¹⁹⁹), Professor Chris Whitty has been influential in persuading PM Boris Johnson to instigate a second lockdown with their apocalyptic predictions of up to 50,000 cases a day if no lockdown were instigated²⁰⁰. Simon Jenkins, writing for the Guardian, stated that “Vallance and Whitty spoke reasonably and sincerely in their press conference. **But their data was selective, and they seem determined to cause alarm**”²⁰¹. Another SAGE (Scientific Advisory Group for Emergencies) member, Professor John Edmunds, warned that the measures announced by Boris Johnson before his second lockdown were not “strict enough”²⁰². John Edmunds, OBE, studied at Imperial College and is also a professor at the London School of Health and Tropical Medicine²⁰³.

Is it a coincidence that SAGE group members whose institutions benefit from the Bill & Melinda Gates generosity turn out as advocates of harsh lockdowns? Professor Niall Ferguson, whose uncanny ability to over-estimate potential deaths by a factor of 10, was used to justify lockdowns in the UK and the US, worked for Imperial College – another major beneficiary of the Bill & Melinda Gates benevolence. In fact, a large proportion of the UK’s SAGE members are part of institutions that have seen Bill & Melinda Gates monies lavished upon them²⁰⁴.

Unfortunately, the legendary Bill Gates philanthropy doesn’t stop with healthcare. It extends to the mass media. In 2011, the Bill & Melinda Gates Foundation gave the BBC World service a \$20 million grant to disseminate information in the Indian state of Bihar²⁰⁵. By 2020, the Bill & Melinda Gates Foundation had given well over \$50 Million to BBC Media Action²⁰⁶. The BBC repaid the Bill Gates generosity by branding those who disagree with him as “conspiracy theorists”²⁰⁷ and pooh-poohing the notion that Bill Gates wants to microchip people²⁰⁸.

The Guardian newspaper has waxed lyrical about Chris Witty, anointing him as “the expert we need in the coronavirus crisis”, whose value as an “impressive” Chief Medical Officer for England has been recognised by 10 Downing Street²⁰⁹. It is purely a matter of coincidence, I am sure, that Guardian News & Media Ltd. has had about \$10 million of grants from the Bill & Melinda Gates foundation over the years²¹⁰.

Le Monde (“the World”), a well-known but struggling French newspaper, has received €1.9 million from the omnipresent Bill & Melinda Gates Foundation²¹¹. By “coincidence”, just during the month of May 2020, Le Monde published two articles lamenting the fact that Bill Gates, for some mysterious reason, is a target of what the newspaper brands “conspiracy theories”²¹².

THE GATES OF HELL?

“The second beast was given power to give breath to the image of the first beast, so that the image could speak and cause all who refused to worship the image to be killed. It also forced all people, great and small, rich and poor, free and slave, to receive a mark on their right hands or on their foreheads, so that they could not buy or sell unless they had the mark, which is the name of the beast or the number of its name. This calls for wisdom. Let the person who has insight calculate the number of the beast, for it is the number of a man. That number is 666.” – Revelation 13:15-18

As the Bible makes perfectly clear, towards the end of times, a tyrannical government will rule the world and force everyone to bear a mark demonstrating their allegiance to Satan, 666 being the number of the devil. Without this mark, you will not be allowed to buy or sell, or pretty much do anything in life. You will be frozen out of society. Although the word global government is not explicitly mentioned in the Bible, this fact can be inferred from the fact that no one, rich or poor, will be spared the Faustian choice: accept the mark of the devil, or be frozen out of society.

Today, we face a situation where vaccination is being pushed as the only way out of lockdown. The possibility of making vaccination compulsory is being openly discussed. Various digital vaccination ID initiatives are under way. One proposal, developed by MIT researchers, is for an ink that can be imbedded in the skin along with the vaccine. The ink would only be visible using a special smartphone camera app and filter. The invisible tattoo accompanying the vaccine would be made up of minuscule quantum dots (semiconducting light reflecting crystals). The work of the MIT researchers “was funded by the Bill & Melinda Gates Foundation and came about because of a direct request from Microsoft founder and philanthropist Bill Gates himself”²¹³.

The bioluminescent agent allowing the ink to become visible is called luciferase. The MIT has already used this Luciferian sounding substance to create glowing plants. As an MIT video proudly explains, “To create their glowing plants, the MIT team turned to luciferase, the enzyme that gives fireflies their glow. Luciferase acts on a molecule called luciferin, causing it to emit light”²¹⁴.

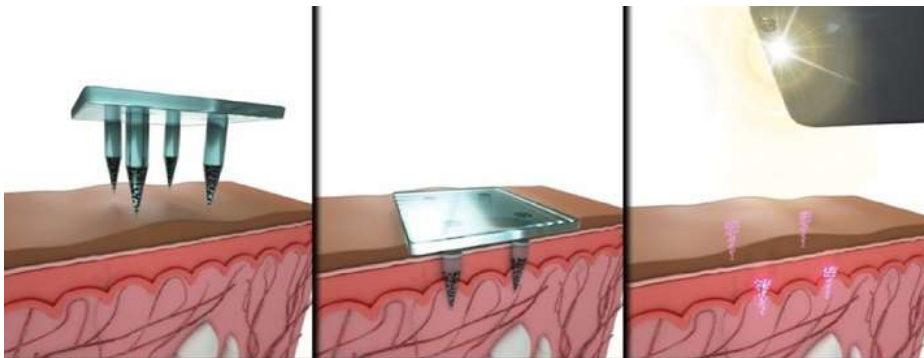

Quantum dot tattoo vaccination certificate with Luciferase as the bioluminescent agent



In “Will travel be safer by 2022?”, the BBC sees a future where “Travellers would present the customs officers with an entrance visa and a vaccination record. That could be a paper card – or a tiny tattoo on their arm, invisible to the naked eye but readable by an infrared scanner.”²¹⁵

Microsoft, the company that made Bill Gates a billionaire, has filed a patent for a “Cryptocurrency System Using Body Activity Data”. The cryptocurrency system would use a “sensor communicatively coupled to or comprised in the device of the user may sense body activity of the user” (see patent claim 6)²¹⁶. The patent number for this currency system to be integrated with the human body is WO2020060606. By “coincidence”, we have a patent application for a method of payment (without which you cannot buy or sell) integrated in the human body number containing the number 666.

Bobby Rush, a Democratic congressman from Illinois, introduced a bill called “H.R.6666 - COVID-19 Testing, Reaching, And Contacting Everyone (TRACE) Act” before the United States Congress. The bill proposes to spend \$100 billion – yes, \$100 billion – to “trace and monitor the contacts of infected individuals”²¹⁷. This is a huge sum of money to be expanded on additional state snooping of citizens. According to whistle-blowers John Moynihan and Larry Doyle, back in August 2019, Bobby Rush travelled to Rwanda to take part in a weeklong event sponsored by Bill and Melinda Gates Foundation and the Rockefeller Brothers Fund (RBF)²¹⁸. Now that is a surprise!

If a virus with a mortality rate of just 0.2% can render our democratic freedoms null and void, and prompts talks of compulsory vaccination with digital ID’s, just think what a significantly more potent virus, if it gets released, could achieve. Bill Gates has warned us to get ready for such an event. “Most of the work we are going to do to be ready for pandemic 2 – I call this pandemic 1 – most of what we will do to be ready for that are also the things we need to do to minimize the threat of bioterrorism... So we, you know, will have to prepare for the next one. That, you now I’d say, uh, will get attention this time”²¹⁹.

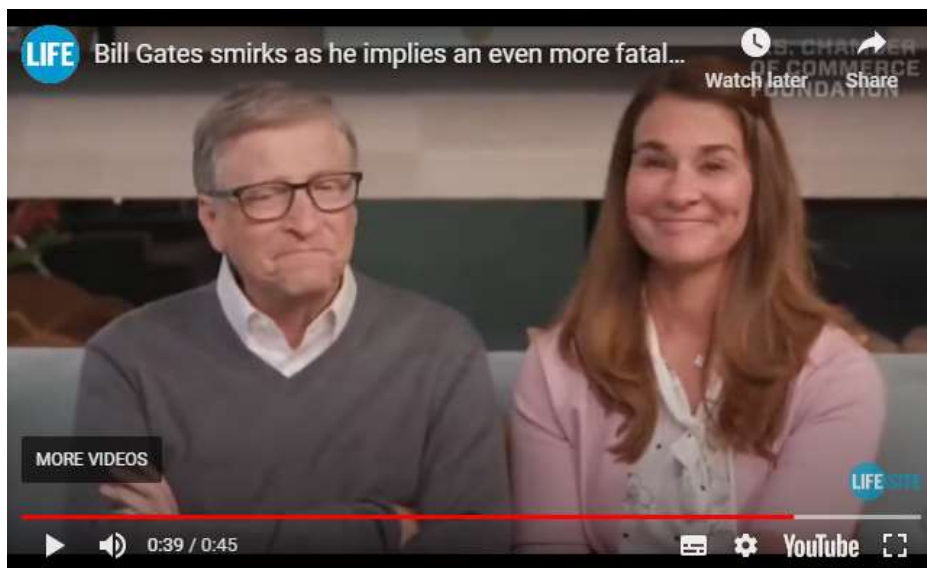

A great philanthropist and his wife warn of a deadly virus to come



It is rather odd, to say the least, to see a great philanthropist smirking when announcing that a deadly virus, one that will presumably destroy what's left of our freedom and prosperity, is on its way. If a virus with a 0.2% mortality rate can turn our democratic freedoms into a distant memory, with millions of citizens placed under virtual house arrest, can you imagine what would happen if a really lethal virus somehow got released, as Bill Gates predicts?
