

Racism, bigotry, prejudice and hatred can go in many directions, and is not confined to one race. This is the Oxford Dictionary definition of Racism: prejudice, discrimination, or antagonism directed against someone of a different race based on the belief that one's own race is superior.

If some people want to blame others for their own inability to take a stand, in a peaceful manner, that's on them. Martin Luther King was ready, willing and able to die for what he believed in. John Lennon & Yoko Ono advocated for peace and became targets of former President Nixon and the FBI (who plotted to kill them, because they tried to stop a war). These individuals walked in peace and advocated for peace. So did Mahatma Gandhi, as examples. They never blamed others, or projected hatred. Gandhi waged war without weapons, or hatred. He freed a country through peaceful social disobedience.

"The problem is that white people see racism as conscious hate, when racism is bigger than that. Racism is a complex system of social and political levers and pulleys set up generations ago to continue working on the behalf of whites at other people's expense, whether whites know/like it or not. Racism is an insidious cultural disease. It is so insidious that it doesn't care if you are a white person who likes Black people; it's still going to find a way to infect how you deal with people who don't look like you. Yes, racism looks like hate, but hate is just one manifestation. Privilege is another. Access is another. Ignorance is another. Apathy is another. And so on. So while I agree with white people who say no one is born racist, it remains a powerful system that we're immediately born into. It's like being born into air: you take it in as soon as you breathe. It's not a cold you can get over. There is no anti-racist certification class. It's a set of socioeconomic traps and cultural values that are fired up every time we interact with the world. It's a thing you have to keep scooping out of the boat of your life to keep from drowning in it. I know it's hard work, but it's the price you pay for owning everything."

I'm not comfortable with statements made by Scott Woods which have been posted online. I'm not an unconscious bigot, or a racist based on the color of my skin. There is no excuse, under any

circumstances to be violent, hateful or destructive; nothing justifies same in the name of any race. I'm also personally offended by the use of the words "white people", or "white privilege" in statements I've seen posted. I've personally been attacked and threatened by some people of color, who used the word "white" as a weapon against me (I look white but I'm actually multi-racial for those who need to define me by race). So, to me, the label holds the same hateful feeling as the "N" word for African Americans. People are not colors, and they don't fall into boxes on a government survey. The use of labels is classic stereotyping, which is part of "blame type systems". Stereotype, as defined by the Oxford Dictionary, "is a mistaken idea or belief many people have about a thing or group that is based upon how they look on the outside, which may be untrue or only partly true. Stereotyping people is a type of prejudice because what is on the outside is a small part of who a person is". It's wrong to make cookie cutter statements about other people, when you've never walked in their shoes. If you want real change, then take responsibility for your own life, examine your own motives and prejudices, and stop blaming others for what's wrong in the world.

The fact is, according to the latest US Justice Department statics from 2016 as reported by the Marshall Project (and many other groups) <https://www.themarshallproject.org/records/909-deaths-in-custody> more white detainees, per number of arrests, are killed or murdered while in custody then blacks. There is another factor to consider and that relates to racial makeup of arrested individuals. The Innocence Project does estimate, based on overturned cases, that perhaps 12 % of all incarcerated individuals are actually innocent; but as far as the total number of incarcerated individuals "Blacks" are the largest population (about 1/3 of all convicted felons are black), less the 12% variance. <https://www.channel4.com/news/factcheck/factcheck-black-americans-commit-crime>

So, is society at large, "White Privilege" responsible for those crimes, or are the perpetrators of the crimes? Also, how could there be "white privilege" when so many "whites" actually live in poverty? The facts are; incarcerated individuals did commit the crimes 88% of the time, and are actually guilty, according to statics. Perhaps a feeling of "superiority" (racism) and uneducated individuals, contribute to denial of these numbers. If so, then remember, numbers don't lie. They can be manipulated by people, who have their own selfish motives at heart, however. Facts, and truth are also subject to manipulation. Research can prove, that when the numbers remain the same, over and over, with only slight variances, they are likely true and correct. Yes, 'BLACK LIVES DO MATTER'; but embracing everything we are (members of the human family without regard to race), is how balance is obtained, and thus PEACE. I was held for over a year, mostly in isolation, until I finally agreed to stay silent.

I know how the “system” works and where the bodies are buried. I also know, if you want to end the “evil empire” then you need to start at the metaphoric “top of the food chain” and expose the ones who are truly responsible.

Donald Trump may be part of the contemporary “evil 1%”; but he is only a puppet for those who are really in “charge”.
