## ABSTRACT

Stonks Inu (**SINU**) is a hybrid utility meme token that incentivizes both traders and investors to participate in the growth of the token through the unique features that make it one of the first in the space to do so. With **Stonks Hour**, a set amount of time in which the buy tax is wholly reduced to **0%**, allowing new members to hop aboard and take advantage of the reduction before the big incoming buyback. Sell tax additionally will be doubled before slowly reducing through the next few hours to discourage heavy dumping until it returns to normal.

Alongside this, the unique tokenomics of Stonks Inu provide a brand new experience for those who are wary of meme coins by adding immediate and necessary utility before launch to show people our commitment to actions to secure investor confidence.

## VISION AND MISSION



Stonks Inu intends to be an industry leader and a first for many meme tokens and altcoins in utility delivery and team vision. At its heart, it encourages intelligent investor conversation while rewarding committed investors and shrewd traders through various methods while remaining innovative and open to market changes.

Each day, the smart contract will have one hour allocated for the opportunity for new investors to hop aboard. A 0% Buy Tax will be implemented alongside a doubled sell tax that will decrease with each corresponding hour until it is back to normal to discourage dumping. ## Stonks NFT Collection

Stonks Inu understands the power of imagery and branding, hence why NFTs are integral to our core concept. The whitelists are given to significant bag-sized holdings to participate in minting! The more you hold, the better your chances of being chosen for whitelisting as we go through with our plans. This method is the best way for our investors to reap the benefits of being long-term holders by allowing the opportunity for further growth by getting in early to our NFTs.

## Stablecoin Rewards (With a Twist!)

4% of every Buy and Sell contributes to the supply and is converted back into BUSD (BEP20) depending on **bag size, trading volume, and circulating supply**. However, Stonks Inu understands that there should be benefits for those holding those big bags, wanting rewards. **With doubled rewards for our NFT holders**, we're looking to expand the benefits for those seeking rewards, and as stated above, this is a crucial first step in doing so.

## Small Circulating Supply

Many tokens rely on massive burns and huge token supply but rarely meet the intended final goal throughout their token lifetime. Stonks Inu recognizes the limitations of these factors. That's why our goal is **1 USD = 1 SINU Token**. To help in that goal, we intend to have a **420 Million Token** supply, with **milestone burns** to show just how quickly we can reach that goal. Lastly, with a 300BNB presale hard cap, we want to focus on getting there quickly and sustainably

## Stonks Tools

Immediately at launch, SINU Investors will be able to use a coin tracker that ties back into the primary utility of Stonks Inu. A utility available at launch is what many tokens forget, and thanks to much testing and development, it is readily available for our investors as soon as trading opens.

The platform allows you to view crypto tokens, live trades, and charts also included. In the future, swapping will be a definite possibility. It will tie back into the utility that Stonks Tools can commit to, not only its investors but also the greater crypto community. Much like Coingecko or similar sites, you'll be able to see the **top 10 tokens for gain or losses within 24 hours** as well. Communities can also vote for the coin and put it on a list for the **top 10 trending** like Dextools.

## TOKENOMICS



### 14% TOTAL BUY AND SELL TAX

**8% - Marketing and Buyback** - The highest allocation towards marketing and buyback ensure the Stonks Inu team has the required capital needed to buy back in large numbers and continuous marketing that drives the project forward. Thanks to this, many people will be seeing Stonks Inu more often than not.

**4% - BUSD Rewards** - The contribution of 4 percent to rewards allows investors to reap the benefits of passive income. The introduction of staking and NFT holding will allow doubled reflections, raising the value to 8%. This process makes passive income through Stonks Inu an incredibly lucrative process for large-sized bag holders.

**2% - Liquidity Pool** - A required contribution to the liquidity pool ensures a sustainable liquidity pool for our chart to keep up with buying and selling.

**Q: Who is in charge of marketing? Do you need mods or community help?**

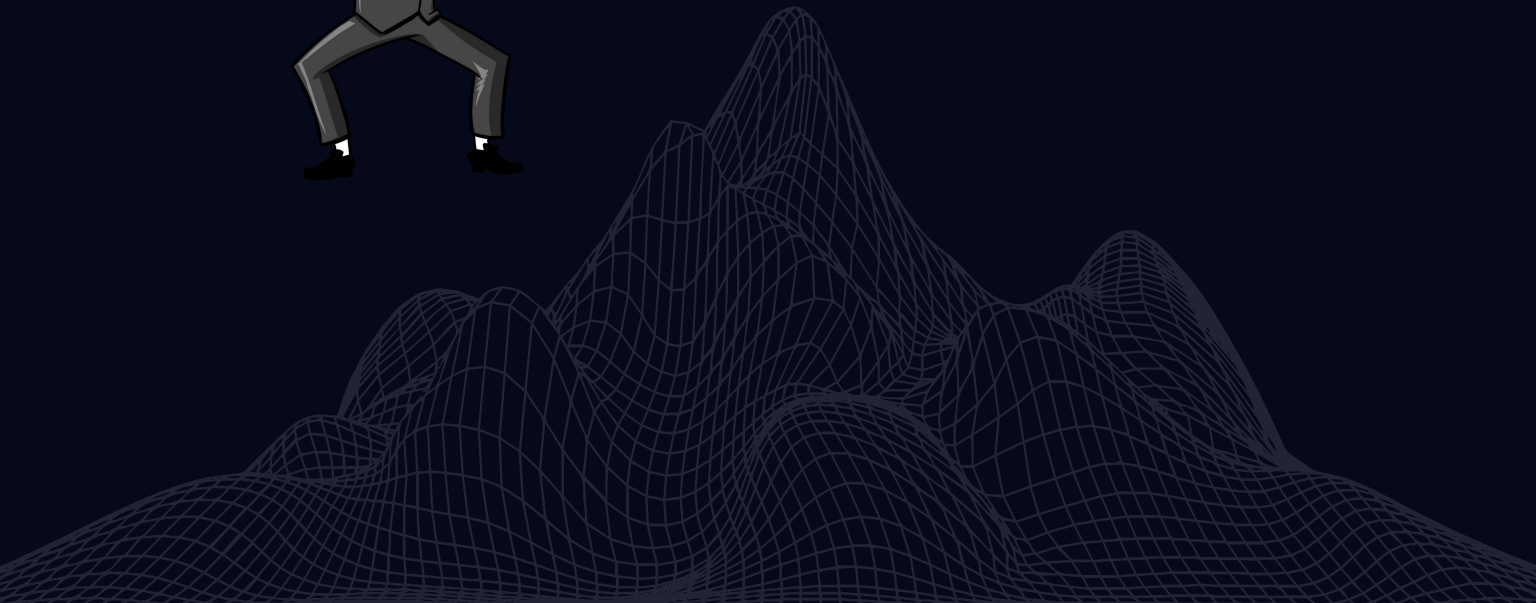
