

The Coudenhove-Kalergi plan - The genocide of the peoples of Europe

Mass immigration is a phenomenon, the causes of which continue to be cleverly obscured by the system, and the multicultural propaganda attempts to falsely portray it as inevitable. With this article we want to prove once and for all that this is not a spontaneous phenomenon. What they want to present as an inevitable result of modern life is in reality a plan devised around the table and prepared for decades, to completely destroy the face of the continent, reports The Exposé.

The Pan-Europe

Few people know that one of the main initiators of the process of European integration was also the man who designed the genocidal plan of the Peoples of Europe. It is an obscure person, whose existence is unknown to the masses, but the elite consider him the founder of the European Union. His name is Richard Coudenhove-Kalergi. His father was an Austrian diplomat named Heinrich von Coudenhove-Kalergi (with ties to the Byzantine family of the

Kallergis) and his mother the Japanese Mitsu Aoyama. Thanks to his close contacts with all the European aristocrats and politicians, thanks to the relations of his father, a nobleman diplomat, and by going behind the scenes, far away from publicity, Kalergi managed to win over the most important heads of state to his plan, making them allies and collaborators for the "project of European integration."

In 1922, he founded the "Pan-European" movement in Vienna, which sought the creation of a New World Order based on a federation of nations led by the United States. European integration would be the first step toward a world government. Early supporters included Czech politicians Tomáš Masaryk and Edvard Beneš and the banker Max Warburg, who put in the first 60,000 marks. Austrian chancellor Ignaz Seipel and the next president of Austria, Karl Renner, took on the responsibility of leading the "pan-European" movement. Later, French politicians such as Léon Bloum, Aristide Briand, Alcide De Gasperi, etc. would offer their help.

With the rise of fascism in Europe, the project is abandoned and the "Pan-European" movement is forced to dissolve, but after World War II, thanks to frantic and tireless activities and the support of Winston Churchill, the Jewish Masonic lodge B'nai B'rith and major newspapers such as the New York Times, Kalergi manages to get the plan accepted by the United States government. The CIA later took charge of implementing the project.

The essence of the Kalergi plan

In his book "Praktischer Idealismus," Kalergi indicates that the inhabitants of the future "United States of Europe" will not be the people of the Old Continent, but a kind of sub-humans, products of miscegenation. He clearly states that the peoples of Europe must interbreed with Asians and colored races, in order to create a multinational herd that has no quality and can be easily controlled by the ruling elite.

Kalergi proclaims the abolition of the right to self-determination and then the elimination of nations using ethnic separatist movements and mass migration. In order for Europe to be controlled by an elite, he wants to turn people into one homogeneous mixed race of blacks, whites and Asians. But who is this elite? Kalergi is particularly illuminating about this:

Man of the future will be of mixed race. Today's races and classes will gradually disappear with the elimination of space, time and prejudice. The Eurasian-negroid race of the future, similar in appearance to the Ancient Egyptians, will replace the diversity of peoples and the diversity of individuals. Instead of destroying European Jewry, Europe, against its will, has refined and educated this people, driving them through this artificial evolutionary process to their future status as a leading nation. It is not surprising that the people who escaped from the ghetto prison became the spiritual nobility of Europe. Thus the merciful care of Europe created a new race of aristocrats. This happened when the European feudal aristocracy collapsed due to the emancipation of the Jews [as a result of the actions of the French Revolution].

Although Kalergi is not mentioned in any textbook, his ideas are the guiding principles of the European Union. The conviction that the peoples of Europe must be mixed with Africans and Asians, in order to destroy our identity and create a single mestizo race, lies at the heart of all Community policies designed to protect minorities. Not for humanitarian reasons, but because of the directives of the ruthless Regime that is bringing about the greatest genocide in history. The Coudenhove-Kalergi European Prize is awarded every two years to Europeans who have excelled in promoting this criminal

scheme. Among those who have received such an award are Angela Merkel and Herman Van Rompuy.

The incitement to genocide, is also the basis of the constant calls from the United Nations demanding that we admit millions of immigrants to help with the EU's low birth rate. According to a report published in January 2000 in Population division Review of the United Nations in New York, entitled "Immigration replacement: A solution to declining and aging population", Europe will need 159,000,000 migrants by 2025.

One may wonder how the estimates of immigration could be so accurate, even though it was not a preconceived plan. It is certain that the low birth rate could easily be reversed with appropriate measures to support families. It is equally clear that the introduction of foreign genes does not protect our genetic heritage, but allows its disappearance. The sole purpose of these measures is to completely deform our people, to turn them into a group of people without national, historical and cultural cohesion. In short, the policy of the Kalergi Plan was, and still is, the basis of the official government policy aimed at genocide of the peoples of Europe, through mass immigration.

G. Brock Chisholm, former director of the World Health Organization (OMS), proves that he has learned the lesson of Kalergi well when he says, "What people in all places need to do is to limit the birth rate and promote mixed marriages (between different races), this has the purpose of creating a single race in a world that will be run by a central authority."

Conclusions

As we look around us, the Kalergi Plan seems to have been fully realized. We are faced with the fusion of Europe with the Third World. The wave of interracial marriages is producing thousands of mixed-race youth each year: "The Children of Kalergi." Under the twin pressures of misinformation and humanitarian bemusement promoted by the MSM, Europeans are being taught to renounce their origins, their national identity.

The servants of globalization try to convince us that renouncing our identity is a progressive and humanitarian act, that "racism" is wrong, because they want us all to be blind consumers. It is necessary now more than ever to refute the lies of the system, to awaken the revolutionary spirit of Europeans. Everyone must see this truth, that European integration amounts to genocide. We have no other option; the alternative is national suicide.

Translator's Note Namaste: While the reasons why Kalergi made the choices he did are not of particular interest to us, we will attempt to answer a question that our readers have no doubt already asked: Why did a European aristocrat with Flemish, Polish, Greek-Byzantine roots and even with some samurai blood in his veins (from his mother) get such a body plan and organ into the hands of dark powers? The reasons are, in our opinion, multiple, idiosyncratic, psychological and ... women.

We therefore observe a personality with a strong snobbish attitude, arrogance and, allow me the term, "degenerate elitism". Also, the fact that his mother was Asian may have caused internal conflicts and frustrations, something that can happen in people with such a temperament. But the most decisive factor must have been the "decent teenager," who, by the way, was of course next door to him, and became his first wife (at the age of 13): The Jewess Ida Roland, who would later become a famous actress.

European Council

On November 16, 2012, the President of the European Council, Herman Van Rompuy, received the Coudenhove-Kalergi Prize at a special conference in Vienna to mark the 90th anniversary of the Pan-European Movement. The prize is awarded every two years to outstanding personalities for their outstanding contribution to the process of European integration.

The decisive factor in winning the prize was the balanced way in which President Van Rompuy acquitted himself of his task in the new post of President of the European Council, established by the Lisbon Treaty. He fulfilled this particularly sensitive leadership and coordination role with a spirit of determination and conciliation, while also emphasizing his skillful arbitration on European affairs and his unwavering commitment to European moral values.

During his speech, Mr. Van Rompuy described the unification of Europe as a peace project. This idea, which was also the objective of Coudenhove-Kalergi's work, is still relevant after 90 years. The prize bears the name of Count Richard Nicolaus von Coudenhove-Kalergi (1894-1972), philosopher, diplomat, publisher and founder of the Pan-European Movement (1923). Coudenhove-Kalergi was the pioneer of European integration and popularized the idea of a federal Europe through his work.

Award winners include the Chancellor of Germany Angela Merkel (2010) and the President of Latvia Vaira Vike-Freiberga (2006).
