The facts supporting this belief are as follows: On Sunday, October 15, 2023 at approximately 16:30 hours, defendant began harassing people attending a school-sponsored Trunk or Treat event in the parking lot at 11287 Manchester Road in Kirkwood, Missouri. Hundreds of children and adults were present in the parking lot. The defendant aggressively approached numerous attendees at the event and made statements such as, "you are all going to die." The defendant was eventually shoved in the chest after threatening a witness and the witness's wife in this manner. The defendant fell to the pavement in the center of the parking lot while surrounded by hundreds of children, stood up, pulled up his shirt to display a handgun and badge, then began firing his weapon in an upward direction approximately a dozen times while shouting that the attendees would die. The people gathered in the parking lot, including victims E.M., F.M., K.O., and O.O., all under the age of 17, frantically ran for cover. School personnel attempted to quickly gather up and shelter the children who had been separated from their parents while the

defendant was firing his weapon indiscriminately. Several witnesses tackled the defendant and seized his weapon.

I believe that the defendant will not appear in court in response to a criminal summons and further believe that the defendant poses a danger to the community or to any other person because the defendant is employed as a police officer, has access to numerous personal weapons, is known to carry a weapon, and the circumstances of the offense involved erratic and violent conduct towards members of the public at a public event.
