You may make representations to Essex County Council as to why this penalty charge should not be paid. These representations should be made not later than the last day of the period of 28 days beginning with the date on which this Notice is served and any representations which are made outside that period may be disregarded.

NOTE: If you do not pay the penalty charge or make representations before the end of the 28 day period specified above the Council may issue a Charge Certificate, which will increase the original penalty charge by 50% to £90.00 and take steps to enforce payment.

This notice will be cancelled if one or more of the specified grounds are established. This notice may be cancelled for other compelling reasons even if none of the specified grounds apply. If the notice is cancelled any sum already paid will be refunded.

If your appeal is submitted within the 14 day 'early payment incentive' period (outlined on page one), this tariff will continue for a 14 day period following decision of an unsuccessful appeal.

If your appeal is submitted outside of the 'early

Representations which are made after the end of the 28 day period specified on the first page of this notice may be disregarded. This notice will be taken to have been served on the second working day after the day of posting unless you can show that it was not. For more information on this, please refer to 'rules relating to the service'. If you submit your representations late, you should explain why.

If your representations are received in time or are received late but are taken into account, Essex County Council will aim to let you know its decision in writing not later than the last day of the period of 56 days beginning with the date on which your representations was served on it. If your representations are rejected, you have the right to appeal against that decision to an independent adjudicator. An appeal form will be sent with the letter rejecting your representations. The form will explain how and when to appeal to the adjudicator.
