
MOTION TO CONTINUE AND FOR A CHANGE OF VENUE AND AFFIDAVITS IN SUPPORT

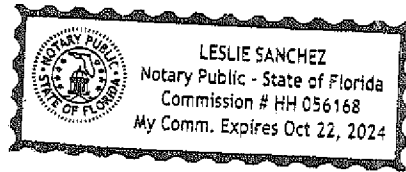
