EFFECTIVE DATE CHART**

It is important to verify your benefits election/deduction on your Leave & Earning Statement (LES) each pay period. Contact the Benefits & Entitlements Service Team (BEST) immediate if there are any issues with your TSP deductions. An error in deductions may result in an indebtedness to the government and missed contributions by the employee. **The annual maximum TSP and/or ROTH contributions (combined) based on the IRS elective deferral limit for 2021 is:**

- **\$19,500.00 - Age 49 or younger**
- **\$26,000.00 - Age 50 (or turning 50 in 2021) and older**
