- It is a family owned company founded by Dr. Rafi' Al-Rawi in 1992 and located in Baghdad / Iraq.
- In 2004 we start to establish our factory.
- In 2007 we gain the License for MDI factory from the Iraqi M.O.H.
- In 2008 we gain under license for 42 products from SDI (the biggest governmental medicine factory in Iraq).
- In 2009 we start our negotiation with GSK.
- In 2011 MDI 'Baghdad manufacturing site has been audited by GSK and has been approved.
- In march 2012 we begin with the secondary packaging for some of GSK products.



MDI HISTORY

- In 2012 MDI became GSK agent in Iraq for over than 40 finished products.
- In 2012 we had been awarded BS EN ISO 9001:2008 from QIC & the GMP certificate.
- In 2012 we became ASPIN agent for about 25 products —Private sector and tender.
- In Oct 2013 we sign an agreement with GSK to promote 24 products by our trained sales force.
- In 2013 we sign an agreement with ASPIN to promote 7 products by our trained sales force.
- In Dec 2013 after we complete all the GSK requirements we will be audited for primary packaging.









We have a dedicated regulatory department with experience staff to handle all the regulatory requirements in relation to : Registration.


