Rey Rivera Note Observations

Be patient with this there has been so much information that I have been reading I am trying to keep this organized so that you do not get lost.

Note Analysis indicates with blue highlighting the items that were in version 2 of the note. In the area with the names of people that had passed away the names Donna, Christopher Reeves, Porfiria Rosado are part of version 2.

Christopher Reeve is the proper spelling of the last name. But Rey added an s to it. Interesting. We have always assumed that Donna was in reference to Christopher's wife Dana. I do not think so any longer.

Two things when you Google Christopher Reeves many listings for Christopher the movie star but I also noticed a guy by the name of Christian Reeves. He is a tax attorney out of San Diego his specialty is living offshore and avoiding the IRS. He also goes by the name Christopher Rusch. He has some indirect affiliations with some of the editors from Agora that cover this area. But I could not find any connection to Rey because I think it was after Rey passed away. I have put this part on hold.

Through this thought process I did make some interesting observations.

Chris Reeves participated in many clinical trials as a human test subject. Here is an article where he speaks at an conference regarding treatment of human test subject. <u>https://www.businesswire.com/news/home/20030827005474/en/Christopher-Reeve-Open-NPSF-Conference-Integrity-Accountability</u> Amgen were big supporters of his foundation,

I believe that Donna is actually in reference to a Donna Reeves who is the Manager of Fresenius Medial Care North America since 1993 and is based out of the Washington D.C. area. I also found agendas for "MARYLAND COMMISSION ON KIDNEY DISEASE OPEN SESSION MEETING MINUTES" and she was in attendance. Fresenius is like Davita and dialysis clinic. (hold this info for now)

Christopher Reeves Foundation received a lot of support from the company Amgen. (also very important later in the note)

I then started through the help of social media and the help of a friend to check off names that I knew were people that Allison and Rey actually knew. What I noticed was that many of the friends and family were grouped together toward the beginning of the list. But then I also noticed that right around where Porter's families name began some of the people that I know he was tight with the names were mixed in with some of the Agora people. I was keeping in mind Allison's statement about some key people were not mentioned.

I then noticed that the list of drugs are part of version 2 of the note and the last drugs added were all from Amgen. There is a guy on the list Jay Hagan who was with Amgen during this time. This information is from his current company website.

Managing Director of Amgen Ventures and head of corporate development for Amgen Inc. Mr. Hagan has led numerous strategic and financing transactions including the acquisitions of Immunex and Tularik and the spinout of Novantrone and Relyspa, as well as many other business development efforts totaling over \$15 billion in value.

What made his name stand out is that even though he played waterpolo on the west coast my friend did not really recall his name. I am not sure if he was a friend or just a name on the list. Could go either way he went to school in San Diego not the same school as Allision went to but not sure how close of a relationship it was. So I started taking a closer look at Amgen. And a light bulb goes on.

The Amgen website has a very interesting history:

1980 - Amgen experiment with extracting oil from shale

1983 – Amgen tasked a team with finding and cloning the erythropoietin gene from this Epogen is created 1985 - From same research with erythropoietin Neupogen was created

1989 – FDA approval of Epogen

1991 – FDA approval of Neupogen

1992 – Amgen a Billion \$\$\$ company

1993 - opens a facility in Puerto Rico and it becomes the flagship manufacturing site

Mid 1990's - researchers add 2 sugar chains to erythropoietin and this allows protein to remain in the body and Aranesp is created

1998 Enbrel approval. Fda

2000 Kevin W. Sharer who has been working close with the prior CEO takes the reigns of the company.

2001 – January Kevin Sharer starts to bring on his executive team. The first person hired was Richard Nanula He had no experience in the pharma area. See his Wikipedia he has had a lot of controversy in his careers. https://en.wikipedia.org/wiki/Richard Nanula

Also the team was on the cover of this periodical so it was a big deal for Kevin to run Amgen by a team. https://www.pharmexec.com/view/amgens-new-dream-team

2001 September - Aranesp gets FDA approval

Now during Kevin's tenure at Amgen there were a few lawsuits. Two were whistleblower cases. One case was about a patent for and a gift that was given to a scientist. <u>https://www.cbsnews.com/news/amgen-in-criminal-probe-over-15m-gift-that-allegedly-supressed-witness-testimony/</u>

The other is in regards to Amgen paying bribes to get doctors to use Aranesp. They would overfill the vials to give more product to induce doctors to purchase and prescribe their product. This case went on forever and Rey would have found out about it if involved in the early stages. The whistleblowers all the names have not been released so hard to tell. This drug was for anemia and kidney patients were the targets.

One whistleblower wore a wire during meetings and an email that Kevin Sharer is asking about overfill and the amounts becomes a key document in the case. Note in the drugs added on note version 2 email is part of that list.

Amgen also got in trouble for prescribing these drugs for uses that were not approved by the FDA and down playing side effects for some conditions. I had to search for a while but I did find Aranesp not being recommended for patients with Porphyria.

Kevin Sharer bringing on his executive team and the FDA approval of Aranesp happen in 2001 this is 5 years form the time Rey died and the note was found. Did any of the people listed on the note die from kidney complications and were taking any of these drugs?

A couple of other interesting thing I noticed was that many of the movies or books as well as drugs all had patent or trademark challenges. We have focused on the themes but maybe they were included because of patent trademark challenges ownership. Star Wars has tons of trademark cases they even had to sue the government for using star wars to name a military operation. Dan Brown was challenged as to whether he stole the concept for the book Da Vinci Code.

Drug companies are constantly fighting to extend and hold on to their patents as long as possible. I have also noticed that pharma patents are a popular them on Oxford Club reports.

Some of the friends of Rey and Allison that are listed toward the bottom of the names also had the same last names as Amgen executives. So where they placed there on purpose?

Donna Reeves and her position with Dialysis clinics did Rey talk to her?

Someone on reddit posted a listing of owners of space on the 11th floor of the Belvedere Hotel. There is a name Darnell in Rey's list of names. So you do not know if it's a first or last name. There is an attorney in Baltimore that is listed as an owner of a unit on the 11th floor. His last name is spelled Darnall he is interesting because he is affiliated with a mediation company which is usually how Amgen liked to settle disgruntled employee cases. He also is the owner of a couple of patents or prepped the paperwork. He is also affiliated with an organization that works with local produce and food companies an association for like the produce market. Its international but one of the patents is for technology that uses waste to create bio-fuel.

One other interesting individual on the 11th floor list his name does not show up on Rey's note but in light of what happen to Rey and others there is a guy who owns 2 units and he is a Forensic Psychiatrist. There is also a Florida financial advisor could be a could be nothing.

What does all this mean. There are some folks that maybe might have some information was Rey onto some whistleblower stuff. Did he know someone in the Puerto Rico Manufacturing plant?

How does Agora entities fit in? I did notice on one Oxford Club newsletter they were shorting Amgen in 2002 but some of the other stocks that sale generics would benefit from patents expiring etc... Davita or other dialysis companies did this impact anything oxford club or other agora entities had picked as winner or loser stocks.
