Dear Dr. Panjab Singh,

I am glad to inform that the proposal titled "Establishment of facilities for identification, chemical characterization, standardization and quality control of medicinal plants found in tribal area in Central India" submitted by BHU has been recommended for funding under Drugs & Pharmaceuticals Research Programme of this Department with the following observations :

- A Sub-committee comprising Dr. J.S. Yadav, Director, IICT, Dr. Laxman Prasad, Advisor and Dr. G.J. Samathanam, Convenor may visit BHU and hold a detailed discussion with Vice-Chancellor/Registrar on the commitment of the University for continuing the maintenance and other Scientific Activities of the facility after the completion of project duration and the support of DST after three years.
- The University Authorities should provide a letter of commitment to this effect.
- The manpower component could be discussed with University and essential manpower including Research fellows etc. may be finalized.
- Once the sub-committee is satisfied with the discussion and the minutes of the Sub-committee may be considered by the DST for funding support of this facility.

In this regard I am to further add that this will be the first of its kind to consider such proposal relating to tribal area under Drugs and Pharmaceutical Research Programme for the valuation of therapeutic efficacy of tribal plants. As the objectives of the proposal have been carefully written in a meticulous manner, it is desirable to have more substantiation of the claims indicated in the proposal. It will be appreciated if the following aspects are further elucidated :

- i) As a number of Ayurvedic/Siddha/Unani formulations are taken up for scientific validation and clinical trials under various on-going government programmes at AYUSH as well as joint programme like Golden Triangle Partnership (GTP), it is desirable to encourage such of the activities not covered in any other programme for this project. Such a direction has also been encouraged under National Innovation Fund, Ahmedabad for dovetailing a traditional knowledge data base collected by them for further explorations.
- ii) Several leads which are not in Ayurveda /Siddha / Unani formulations may have been taken up by BHU by the investigators of this project and intellectual property (IPR) have been protected through national and international patents and the same may please be provided prioritizing such IPRs for discussion in the meeting.
- iii) It is desirable to know the expertise available with the investigators on surveillance to execute tribal area medicinal plants proposed in the project may also be compiled.

- iv) Tribal medicines very often use animal products in their formulations. Considering various environmental limitations whatever the tribal leads taken up through this centre should ensure that no such animal products demanding formulations are entertained under this project. It is better to delineate the domain of research in this programme
- v) Very often when Indian scientists seek for approval of USFDA/European Union invariably they fail to substantiate their claim of usage of these traditional tribal leads for centuries/history of use through literature of local language on its usage. It will be very much useful if this centre gives importance for such links through literature on history of use. Such efforts can convince the regulatory organizations of developed nations to liberalize the stringency for safety standards for human use. Otherwise poly herbal formulations demand extensive research and data generation on safety standards involving millions of rupees for satisfying such requirements.
- vi) The proposal is also lacking on the detailed methodology of tribal preparations for the formulations to be taken up for further studies under this project and the expertise available on the preparation of standard extracts with the investigators may be provided.

I shall appreciate that the investigators of the proposal are able to pool their information on the above issues and provide the same at the time of Sub-Committee meeting. In order to conduct the Sub-Committee visit to BHU, a convenient date in the month of May preferably between 12-15th, 2007 may be given to coordinate the Sub-Committee's visit and hold a detailed discussion on the various issues.

I earnestly solicit your early decision to coordinate the visit of the Sub-Committee and for facilitating further necessary action for the sanction and implementation.

At the very outset Prof. Panjab Singh, Vice-Chancellor welcome the delegation and also the individual members of the expert team for visiting the BHU. He also gave an account of new ventures of the university in the field of academic pursuits and research areas. Prof. Singh mentioned about the Rajeev Gandhi South Campus of the University at Barkachha and informed the delegation that it is ideal tribal belt surrounded by the three neighbouring states like Madhya Pradesh, Chhatisgarh and Bihar in addition to U.P. and is the ideal place for establishing research centre in the field of tribal medicine.

Hon'ble Vice-Chancellor assured that the university will extend all possible help for smooth conduction of the project so that it comes to a logical end and deliver good to the society. Prof Panjab Singh also shown his concern and informed the house that the team of investigators and experts in the field have been identified for scientific and smooth conduction of the work. Prof. R.G. Singh, Professor of Nephrology, IMS will coordinate the work as Principal Investigator of the Project.

Dr. Samathanam, Advisor of the Drug & Pharmaceutical Division of DST gave the background of the drug & pharmaceutical division of DST and it is the need of the day to recognise our strength and show our presence in the global scenario of herbal medicine. He high lighted the contribution made by BHU specially Prof. G.P. Dubey and his group in the field of Ayurveda & tribal medicine. He also stressed the need of active collaboration by the Drug-Industry for promoting research and helping the institution to establish facilities for higher research in the field of new drug development. He repeatedly emphasized the need of active collaboration between institution and universities, DST and Pharmaceutical houses for collaborative research directed for development of new drug molecules from herbal and tribal medicine plants.

He also emphasized that project should move in vertical direction i.e. showing steady progress. This for molecules who have been patented or in the process of patent, the biological standardization i.e. (clinical trial at various phases) should be undertaken to complete the requirement for global marketing and promotion on priority basis. Further an attempt to be made for identifying other active medicinal molecules in the tribal medicine by the group for further validation.

He also emphasized that the grant of Rs. 10 crore is just a pea nut for the development of new drug molecules. The investigators should try to generate more resources from other sources like drug and pharmaceutical industries, marketing people and other funding agencies.


Dr. J.S. Jadhav, Director, IICT, Hyderabad endorsed the view expressed by Dr. Samathanam and mentioned that this is a very important project in view of current global scenario. It is one of our very big strength and BHU is the ideal place for conducting this project which should lead to establishing a big centre for the tribal medicine in this part of the country.


Dr. Samathanam also informed that more projects having collaboration with pharma industry, university and DST should be send for consideration. He further wanted an assurance from the university for continuation/future development and proper utilization of facilities established by the DST in addition to position of project staff after expiry of 3 years. Then Hon'ble Vice-Chancellor clarified that university will take all measures to continue these facilities after lapse of the project period by developing further research projects, collaboration with drug industries and other funding agencies, consultancy and other resources generation measures. The project staff will be taken care of by the university as per existing practice in the matter in a positive manner.

The Principal Investigator was asked to discuss the finer details of the project and modalities with the visiting team and submit the necessary documents required by DST.

Finally entire team of Investigators and other local experts were introduced to the visiting team and they have also expressed their concern and involvement in the project and expressed their hope for a fruitful outcome.

The meeting concluded with vote of thanks to the Chair.

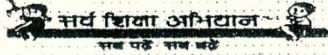

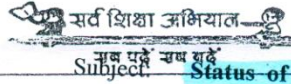

Dear Dr. R.G. Singh,

As you are aware, the above project was sanctioned in January, 2008 with the three years project duration with the main objective to facilitate the ultimate development of drugs on the identified leads / IPR of the tribal area in Central India generated at BHU on Cardiovascular, Type-II diabetes, Neurodegenerative Disorders, Menopause etc. These IPR protected leads are to be taken up in vertical direction by undertaking clinical trials at various phases to complete the regulatory requirement for national/international gains on priority basis. Any undue delay in taking these leads for further progress will loose the IPR commercial value of the patents. At this juncture I request you to inform the actions carried out towards the development / final product of these drugs towards that goal. As per the commitment of the University necessary initiatives may also be taken up for the continuance of the activities supported by DST through this project including the project staff. All these issues were assured by the Vice Chancellor and recorded in the minutes of the meeting at the time of sanction.

I would like to know the activities carried out in this direction. On priority, monitoring meeting of the project has to be conducted. I have tentatively proposed for this meeting on 24th May, 2010 at BHU. All the requirements may be forwarded on urgent basis to evaluate the progress at our end. This Department has been reminding you to forward the progress reports and UC/SE for the years 2007-08, 2008-09 and 2009-2010.

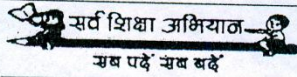





Hon'ble Sir,

At the very outset, I must extend my heartfelt compliments for all round development of the university under your dynamic leadership. Further, Deptt. of Science & Technology, Govt. of India sponsored National Facility for Tribal and Herbal Medicine is a permanent facility and BHU is privileged to be the only university to have this in the country being the no. of university of the country. I want to state following facts for your kind information and necessary action.

1. Department of Science & Technology, Govt. of India had sanctioned a national facility to BHU for establishment of facilities for identification, chemical characterization, standardization and quality control of medicinal plants found in tribal area in central India in January 2008 by granting Rs. 7.56 Crore to BHU for three years. The National Facility for Tribal & Herbal Medicine (NFTHM-IMS-BHU) had been established to a large extent (Anx-1).
2. The Facility has been established for the development of tribal and herbal drugs, taking the leads from ancient concept of Indian System of Medicine, particular to the tribal knowledge indigenous to the Central India. Another chief target of the facility is to work for the protection of IPRs and development of new IPRs for the therapeutic efficacy of tribal formulations having potential to prevent human disorders.
3. Out of several identified formulations, in current phase, the facility is working for clinical trial of four formulations which have been advocated for the prevention and management of cardiovascular, neurodegenerative, menopausal syndrome and obesity. In addition to above more formulations for allergic disorders, Rheumatoid Arthritis, Attention Deficit, Hyperactive Disorders in Children (ADHD) renoprotection etc. are also in process to be standardized by our facility in due course.
4. In process of establishment of this facility in BHU and for its regular services as a centre, before sanctioning the national facility in BHU; DST, Govt. of India needed a commitment/undertaking from the University to the effect that BHU will be taking full responsibility of further maintenance and upkeep of the facility for the objectives it has been established. The DST wanted a commitment of the University for the continuance of the facility including staff after completion of the three year duration of DST support as referred in the letter addressed to the Hon'ble Vice Chancellor dated 23.04.07. (Anx-2, 3 & 4).

After getting assurance from the administration, a sub-committee meeting of DST experts with University authorities was held on 01-06-07. In the meeting the importance of the facility for the drug development, the importance of BHU to act as a nodal centre of such type of establishment in this part of country, the necessary supports of BHU and different funding agencies and the need of active collaboration between different organizations etc. were discussed. The commitment of the University for the future maintenance of the facility as asked by the DST was also discussed in the meeting, where the then Hon'ble Vice-Chancellor provided the commitment of the University for the continuation of the facility including staff after three year duration. In the meeting, the Hon'ble Vice Chancellor assured that the University will extend all possible help for the smooth conduction of the facility and he also clarified that the staff of the facility will be taken care by the University as per existing practice in the matter in a positive manner (Anx-5,6).

6. The regular service of the trained staff in the facility is a mandatory requirement to upkeep the research activities of the facility for which it has been established. In the process of continuance of the facility in University as decided and for the merger/regularization of the staff in the University, the payment of graded salary to the staff is mandatory initiative. In this direction, I have requested to the funding agency vide my letter addressed to Dr. G.J. Samathanam, Head, TDT Div., DST, Govt. of India dated 27-01-2010 duly forwarded by Head of the Dept. of Nephrology; Dean, Faculty of Medicine and Director, IMS, BHU. (Anx-7).

7. In response to the above said request and after understanding the importance of this important establishment, the Department of Science and Technology, Govt. of India have very keen interest to take appropriate action for the graded salary of staff and DST has asked to the Registrar, BHU to submit the official copy of the proposal routed through the Central registry of university for necessary action by the DST. (Anx-8).


Sir, in view of the above mentioned fact, I am humbly requesting you to kindly direct the central registry to send the above proposal for regulation of the payment of graded salary to the appointed staff to the DST for appropriate action at their end. The entire fund will be managed out of DST fund itself and no burden will come on the university during current project duration.

Minutes of the Second Monitoring Committee Meeting on the project entitled, 'Establishment of facility for identification, chemical characterization, standardization and quality control of medicinal plants found in tribal area in Central India' funded under Drugs and Pharmaceuticals Research Programme (DPRP) of DST on 8.10.2010 at 10.00 a.m. at Banaras Hindu University (BHU), Varanasi.



Several Scientists and staff working on the project were also present during the meeting.

Dr. Samathanam gave an overview of the project. The first Monitoring Committee meeting was held on 19.07.2008 under the Chairmanship of Prof. P.K. Seth, Former Director, ITRC, Lucknow. There were several issues discussed in the meeting for follow up by the University to take up the leads developed by the University under the guidance of Prof. G.P. Dubey on areas like Cardiovascular, Neuro-degenerative disorders, anti-aging, management of menopausal syndrome and the various international patents covered for these diseases and disorders were appreciated. Considering the Drugs & Pharmaceuticals Research Programme emphasis on taking the already identified / IPR protected leads for further vertical development it was suggested that the University should work on that direction for preparing the clinical wards, metabolic wards with Good Laboratory Practice (GLP) and Good Clinical Practice (GCP).

The monitoring committee had a formal meeting with Hon'ble Vice-chancellor, Dr. D.P. Singh and Dr. T.M. Mohapatra, Director, Institute of Medical Sciences, Banaras Hindu University. Dr. Samathanam, Advisor & Head, DST brought to the notice of Vice-chancellor on the recommendations of the earlier monitoring committee, the objectives of supporting this project for bringing value addition for the existing leads which are IPR protected. The Department of Science & Technology had provided substantial provisions for creating GLP and GCP infrastructures by modifying existing wards and the laboratories. He brought to the notice, the existing space constrain for the project and the non-utilization of resources for the purpose for which the support was made. He also mentioned on the continuity of this project activities after the expiry of the tenure of the project by March, 2012 (with one year extension from April, 2011). There is an urgent need to encourage the intellectual property protected traditional / ayurvedic leads for its international acceptance by carrying out requisite R&D for commercialization. Dr. S.P. Thyagrajan and Dr. S.K. Sharma, Advisor, Department of AYUSH also emphasized the need for utilizing the governmental support for the University by facilitating GLP and GCP.

Hon'ble Vice Chancellor had kindly agreed to provide the requisite space for the project on priority and also to look into the operational aspects of purchase of equipment, modification of the existing wards to international standards, amicable settlement of IPR issues and other requirements for smooth implementation of the project. He also agreed to find the means and methods for enabling the continuity of this national facility after its completion of duration of DST support.

The Monitoring Committee also visited the clinical lab created at the Hospital building and understood the procedures, records and other steps adopted to qualify for a GLP compliant laboratory. The Committee appreciated the efforts and encouraged the project staff to strictly adopt the higher standards and upkeep of the records / computerized archival records.


Dr. R.G. Singh welcomed the monitoring committee. Dr. S.P. Thyagrajan, Chairman requested to present the progress vis-à-vis the earlier minutes of the meeting. The progress on various disease management was presented by Dr. Aruna Agarwal, Co-PI of the project. She highlighted the role of herbal formulation in management of neuro-degenerative disorders with special reference to Senile Dementia of Alzheimer's Type (SDAT) such as plant description, chemical constituents, extraction procedure, stability study, dose dependent data on experimental model, efficacy of test formulation, clinical study. Similarly, combined ayurvedic formulation in the prevention and management of type-II diabetes mellitus and associated micro-vascular complications. Also a randomized double blind placebo controlled trial of an herbal formulation in the management of menopausal syndrome was also discussed. Several of the leads based on the tribal knowledge traced by the investigators.

The outcome of the project was highlighted as given below:

- Drug related to neuro-degenerative disorders – bioactive molecules have been identified, acting on different targets and its correlation with clinical indication.
- Drug showing the preventive role of vascular complications among type-II diabetes mellitus. Their school of thought and the IPR were confirmed in advanced countries like USA, Australia, Japan etc.
- Identified phyto-hydrogen that can replace the conventional Hormonal Replacement Therapy (HRT) among menopausal women.
- The drug showing the preventive role in Coronary Heart Disease by modifying the risk factors. This has also been confirmed in the publications / IPR published in advanced countries.
- Learning disability including Attention Deficit Hyperactive Disorder (ADHD) among tribal children. Result has shown a significant beneficial role of improving the mental capabilities.

The Monitoring Committee also visited few of the labs infrastructure wherein the project acquired instruments etc. are placed. The Committee made the following recommendations:

- Ethical Committee Composition and the date of ethical clearance for the clinical trials planned may be communicated.
- Advised to register with Clinical Trial Registry India of ICMR and inform the number

assigned.

- Pursue with the university administration for assigning space for the project including the metabolic ward and other wards needed for the project studies.
- Initiatives may be taken up with university administration for the continuity of the national facility as per the earlier commitment received from the university.
- Efforts should be made for mobilizing the industry academia collaborations by attracting leading pharma industries to take advantage of the strength of the university on herbal medicine.
- Equipment proposed for any change from the already sanctioned should have proper relevance for the project activities.
- The budget resources available may be judiciously utilized so that no cost escalation for additional funding support arises. Efforts should be made to meet any contingency for additional resources through industrial collaborations and submission of partnership projects to DPRP of DST.
- Attempt may also be made for validating the results of BHU through accredited other laboratories / medical institutions by adopting approved procedures and norms and controlled clinical trials following the ICMR guidelines.

The Monitoring Committee was appreciative of the efforts taken by the University and the project team. They emphasized that the above suggestions may be taken up more aggressively to enable the project outcome to its objectives. The committee recommended for the release of DST next instalment of grant depending on the pattern of utilization and the statement of expenditure and other inputs. The request for extending the project duration upto March, 2012 was also supported by the Committee and recommended for the consideration by DST on No Cost Escalation Basis.

With regard to regular graded salary of university pattern for project staff, the committee felt, university administration may examine the request in accordance to the procedure adopted in all such cases.

The meeting ended with the vote of thanks to the Chair.
