WHEREAS, on 01 February 2020, the Secretary of National Defense issued Acquisition Decision Memorandum (ADM) No. 2020-005 directing the immediate implementation of the Frigate Acquisition Project Lot 3 (Torpedoes, Chaffs and Acoustic Decoys) of the Philippine Navy (PN) with an Approved Budget for the Contract (ABC) amounting to PhP1,700,000,000, delineated as follows:

WHEREAS, on 27 November 2020, SND approved the recommendations of the DND Bids and Awards Committee 1 ("Committee", for brevity) under DND BAC Resolution No. DND/PN-FAP3B-20-01 dated 03 November 2020, (1) to undertake the project through, Limited Source Bidding pursuant to Section 49 of the RIRR of R.A9184, (2) to approve the Technical Specifications / Bidding Documents for the project, (3) to approve the Criteria for Evaluation of the pre-selected suppliers, and (4) to approve the List of pre-selected suppliers;

WHEREAS, SND issued Department Circular No.12 on 02 July 2020 (DC12 s.2020), with subject "Guidelines in the Conduct of Procurement Activities of Projects with Foreign Bidders/Proponents During a State of Calamity, or Implementation of Community Quarantine of Similar Restrictions";

WHEREAS, the Committee conducted the Submission and Opening of Bid Envelopes (SOBE) on 12 January 2021, which was participated by the lone bidder, Rheinmetall Denel Munitions Pty. Ltd. ("Rheinmetall", for brevity);

WHEREAS, in the same conference, Rheinmetall was found to be compliant with all legal, technical and financial requirements of the project, with a bid price offer in the amount of **PhP348,000,000.00** and was declared as the Single Calculated Bidder (SCB), subject to the conduct of Post-Qualification (PQ);

WHEREAS, pursuant to the guidelines set by DC12 s.2020, the PQ Team conducted the post-qualification on Rheinmetall on 17 March 2021 to 17 April 2021, via video-teleconferencing and determined the responsiveness of the bidder's proposal pursuant to R.A 9184 and RIRR (Rule X on Post Qualification);

WHEREAS, on 06 May 2021, the PQ Team presented the results of the post-qualification on Rheinmetall and recommended that it be declared as post-qualified and the Single Calculated Responsive Bidder (SCRB) for the project, and that the Notice of Award be issued in its favor;

WHEREAS, the Committee after due deliberation, resolved to approve the recommendations of the TWG to declare Rheinmetall as the Single Calculated Responsive Bidder (SCRB) for the project, and to issue the Notice of Award in favor of Rheinmetall Denel Munitions Pty. Ltd.

NOW, THEREFORE, we, the members of the Bids and Awards Committee, resolve, as it is hereby **RESOLVED**, to approve the following:

- a. to declare Rheinmetall Denel Munitions Pty. Ltd. as the Single Calculated Responsive Bidder for the Frigate Acquisition Project Lot 3B (Chaffs) of the Philippine Navy; and
