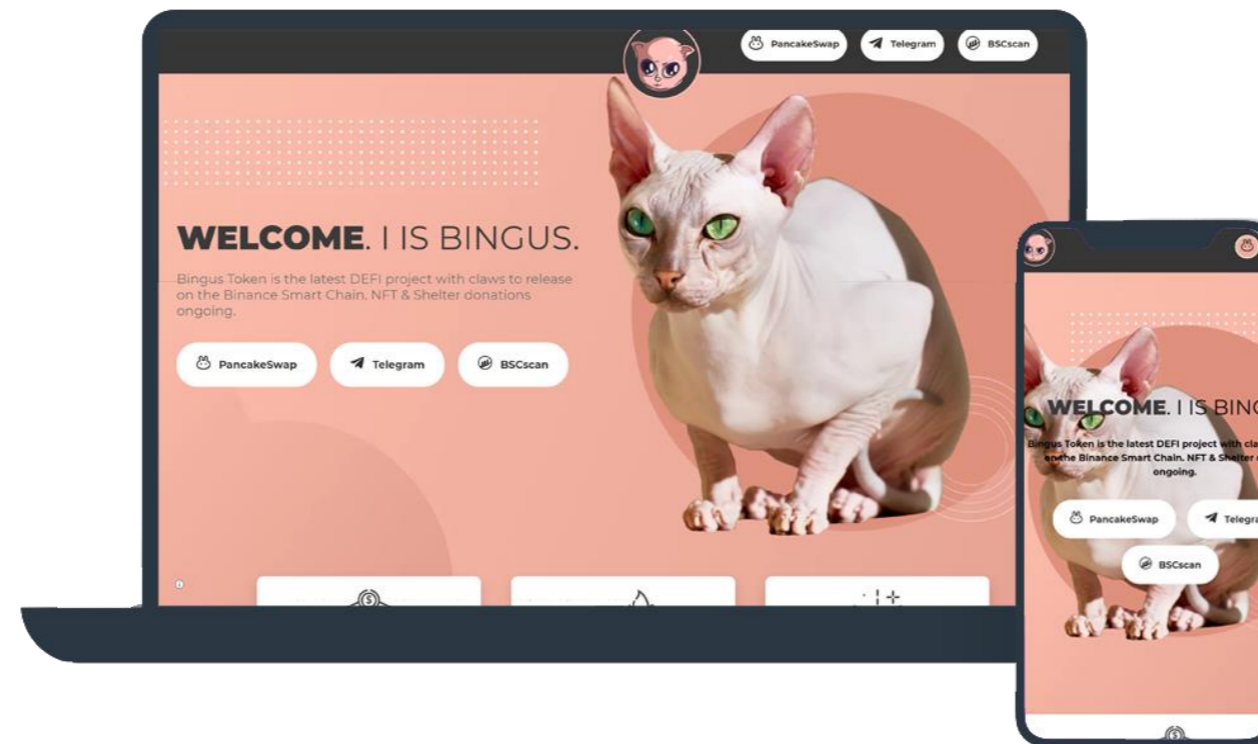

Above images are actual snapshots of the current live website of the project.

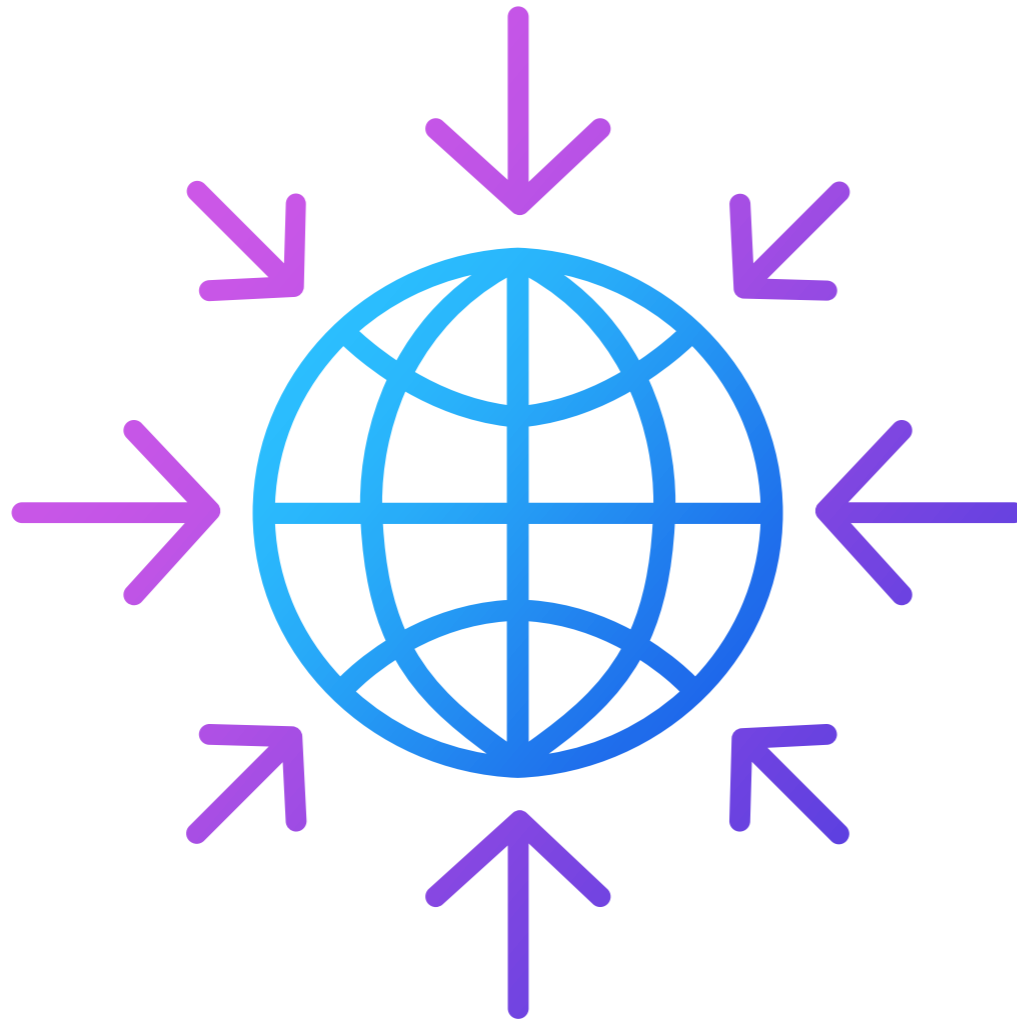
Website was registered on 03/31/2021, registration expires 03/31/2022.

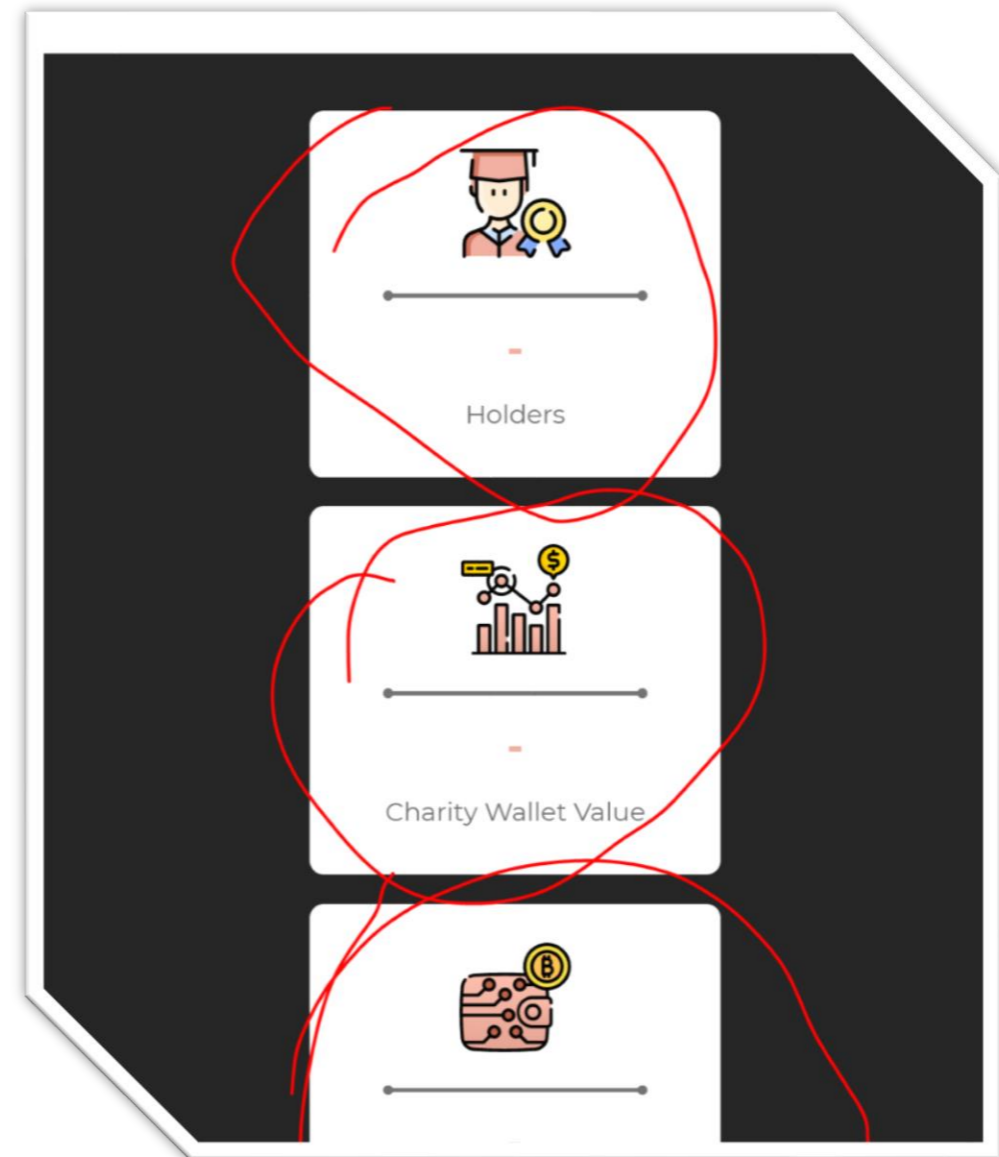

No issues were found on the responsive check for the website. All elements loaded properly and browser resize was not an issue. Bingus Token has put a considerable amount of thought and effort into making sure their website looks great on all screens.

We did encounter a minor issue where numerical values were not being loaded properly in some of the analytics elements as shown to the right.

Console check for any severe JavaScript errors came back clean. No issues with loading elements, code, or stylesheets.

Social Media – Final Thoughts & Suggestions for Improvement

Overall the team seems to be active across multiple social media platforms. We found a healthy amount of activity on Twitter, Reddit, and Telegram.

The team appears to be regularly conducting AMAs on discord, providing for healthy interaction with supporters.

The team appears to be donating money to multiple charities. While we have no reason to believe that the funds are being misused at the moment, in the future we would like to see a proof of origination of donation from one of the charities the project has donated to for further evidence of the flow of charitable contributions.

Suggestions for Improvement

1. Consider hotlinking QR codes on homepage to direct links for proof of donations so it does not have to be scanned.
2. Consider adding a Bingus Token Facebook page
3. Consider reaching out to charities that were donated to for a document detailing confirmation of funds via BTC. This will add to community trust.

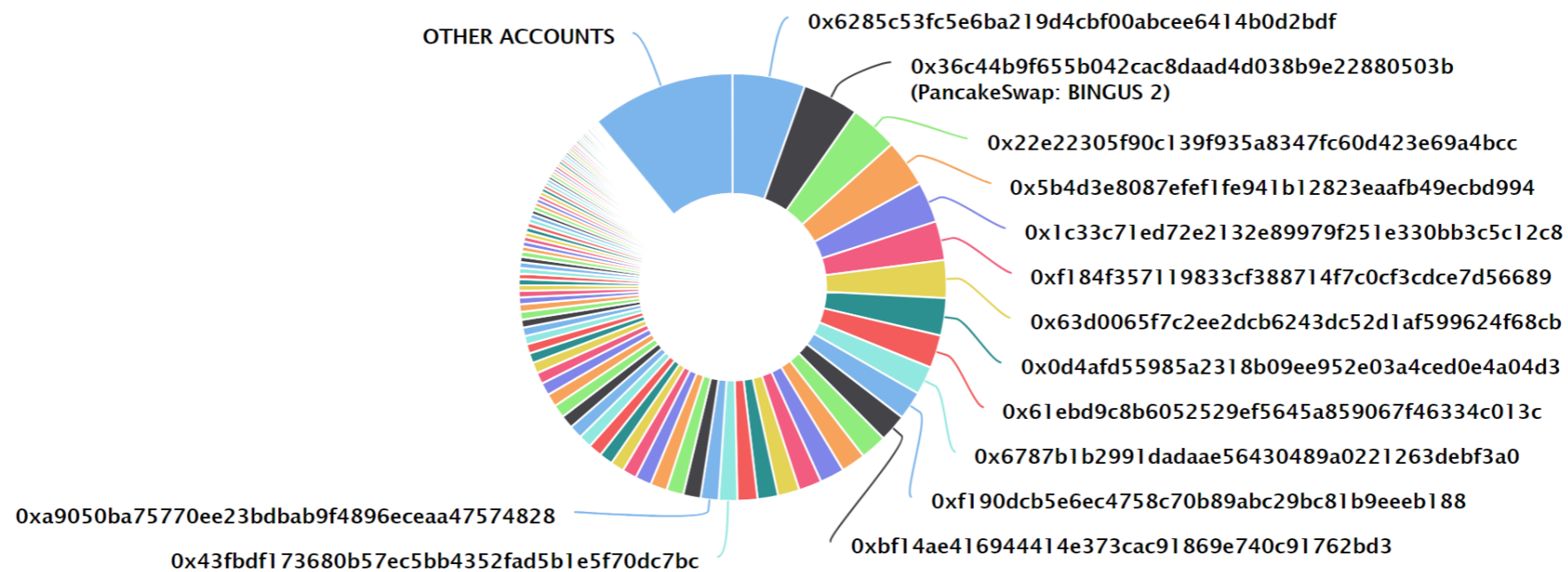


Top Token Holders

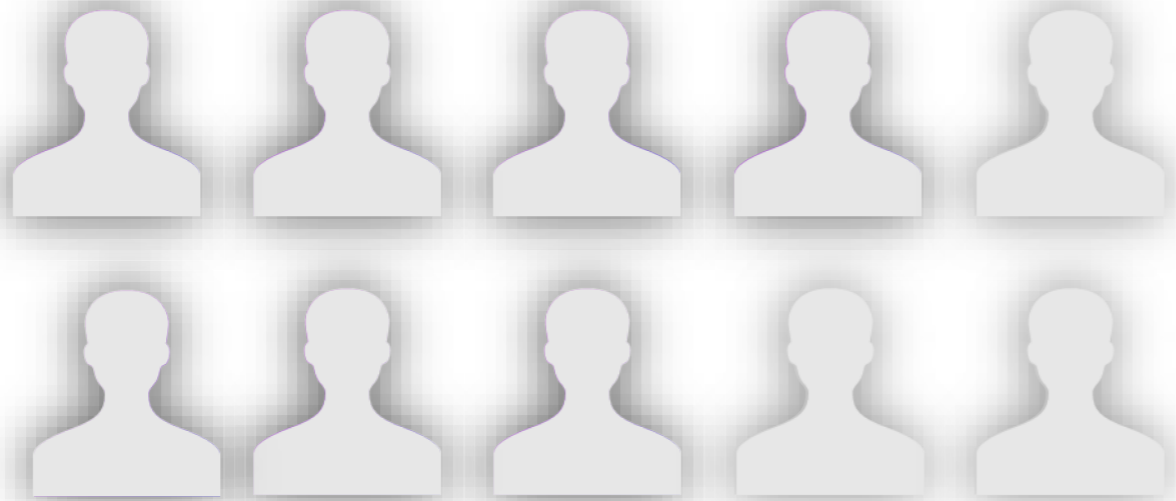

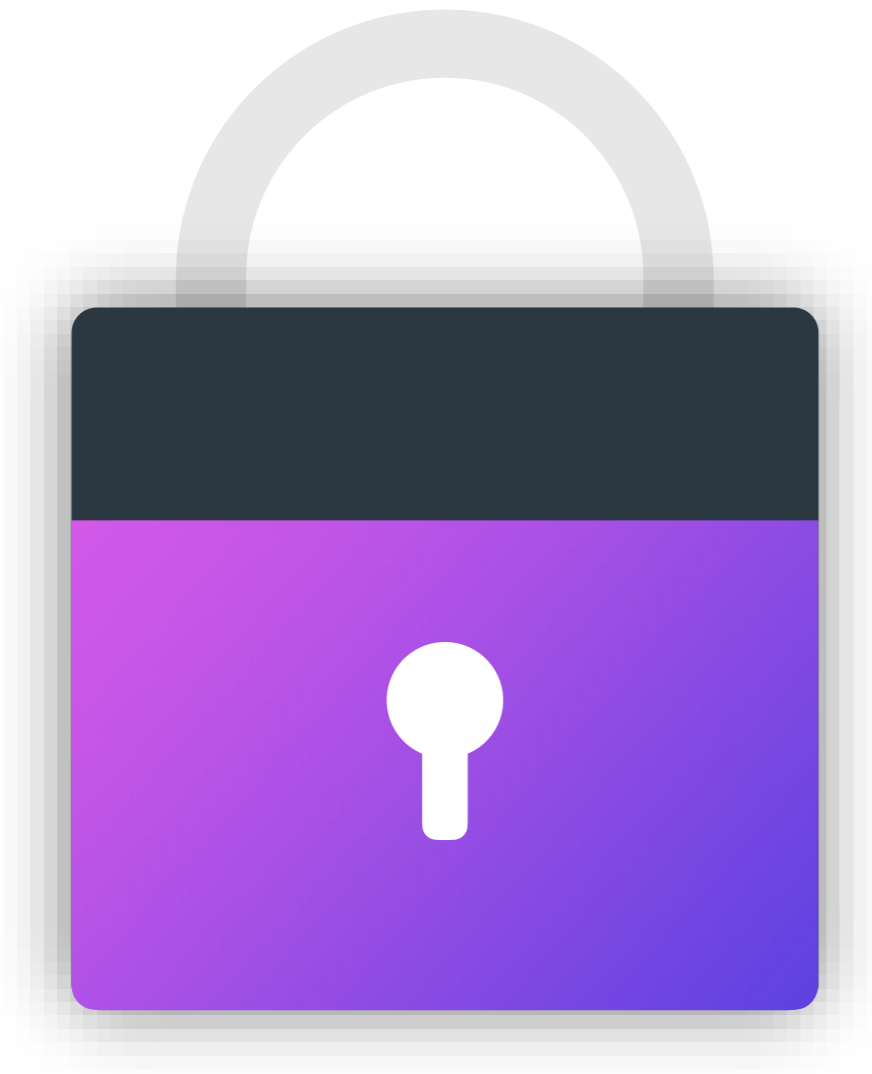
