Silence as the voice of trauma

Silence is the common denominator found among all victims, signifying a state of survival functioning where words fail and verbal recollections may have destroyed a fragile ego. Silence in response to massive trauma constitutes also a self-protective, self-imposed firewall to avoid total psychic fragmentation.





The vicious circle of silence





Lessons to be learned


- Create an atmosphere in which migrants dare to speak
 - Cp. antisemitism
 - Prohibit anti-migrant mobilisation
 - Implement measures against xenophobia and racism (e.g. reporting, education)
- Provide platforms for migrants to make themselves heard
 - Facilitate the publication of their writing in newspapers, magazines
 - Support literature, films etc.
- Listen to what they have to say
 - Learning process
- Spread the word
