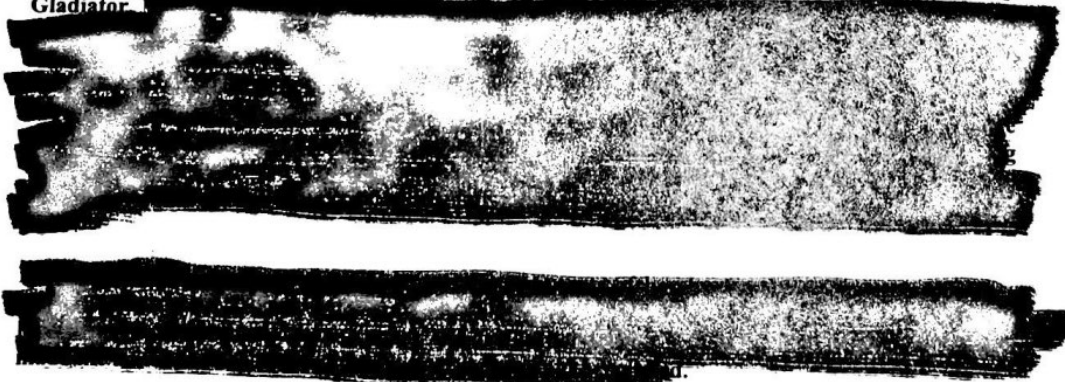

On Monday, April 18th, 2016 at approximately 07:25 hours (7:25am), I, Sergeant Joe M. Fitzgerald #288 was asked to respond to 5401 HWY 287, Midlothian, Ellis County, Texas, 76065. The address is a business known as the Church of Christ. Prior to being requested I learned Midlothian Police were working a death investigation at this location. I was asked to instruct Ellis County Crime Scene Technician Christine Kringen to respond and assist as needed.

At approximately 07:10 hours (7:10am), I received a phone call from Renee Byrd-Jones. Ms. Byrd-Jones is the director of an Ellis County chapter outdoor fitness boot camp known as Camp Gladiator.



At approximately 07:53 hours (7:53am), I arrived on location at the Church of Christ. The church is located on the north side of HWY 287. As I drove onto the property Ellis County Sergeant Adam Sowder and Corporal Jeremy Osteen were blocking incoming traffic from driving up to the crime scene. I briefly spoke with both deputies and parked on the west side of the parking lot. Prior to parking I observed uniformed Midlothian officers standing next to yellow police tape. There was one (1) uniformed patrol standing inside the yellow tape. He was in charge of the crime scene control log. The tape was marking off a south breeze way/entrance for the church. Inside the yellow tape was a four (4) door Ford truck. The truck was positioned facing west underneath an awning. The front passenger door and truck bed lid was open. The truck was bearing [redacted]. I was met by Commander Kevin Johnson. Commander Johnson and I briefly spoke and I was directed to MPD CID Sergeant Tim Scott. Sergeant Tim Scott led Ellis County CST Kringen and I into the church. We walked through the south breezeway doors into the main foyer to the north side of the church. I saw a white female laying on her back. She was wearing workout style clothes. There were large areas of pooled blood and pieces of broken glass scattered all over the floor. After viewing the body we were asked to process the truck under the awning.

CST Kringen took pictures of the vehicles found state. [REDACTED]

I cleared at approximately 09:35 hours (9:35am).

At approximately 13:30 (1:30pm), I was asked to attend a briefing at Midlothian Police. [REDACTED]

On Wednesday, April 20, 2016, I conducted an Etrace search with the ATF on the handgun found at the body site location. [REDACTED]

I have also spoke with Penny Rowley with Wal-Mart Lost Prevention. Ms. Rowley is conducting searches with Wal-Marts in Lancaster, Red Oak, and Waxahachie. Ms. Rowley was asked to search for suspicious sales of ammunition and or guns in the early morning hours of Monday, April 18th, 2016.

On 04.18.16, at approximately 0740 hours, I, Crime Scene Technician (CST) C. Kringen, was requested by Criminal Investigation Division (CID) Sergeant J. Fitzgerald to respond to The Creekside Church of Christ, located at 5401 East Hwy 287, in Midlothian, Texas, in reference to an assist outside agency report; Ellis County Sheriff's Office (ECSO) report # 16-05035.

At approximately 0810 hours, I arrived on scene and met with Sergeant Fitzgerald.

A Crime Scene Entry Log was being maintained, of which I was entered into upon arrival. The weather was cloudy and it had rained on the area prior to my arrival.

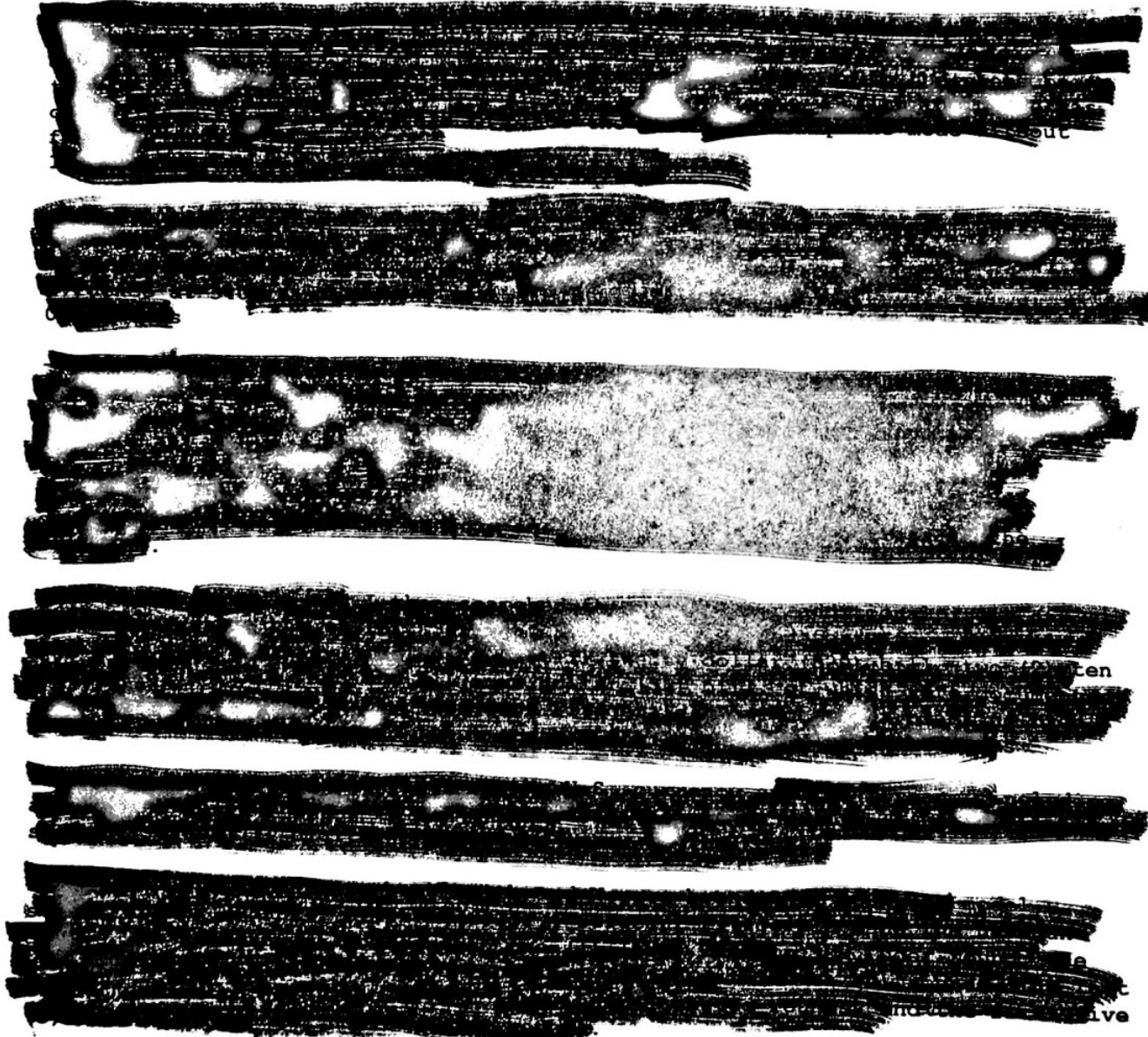
The Creekside Church of Christ, located at 5401 East Highway 287 was westward facing and located on the east side of US Highway 287. The church had a parking lot, which surrounded the church on all four (4) sides. A small driveway was located to the southern side of the business, near the southwest corner which entered under an awning and extended from the building.

I then met with CID Sergeant Tim Scott with Midlothian Police Department (MPD), and along with Sergeant Fitzgerald, completed a walkthrough of the interior crime scene. Entering through the south side doors, we continued into the main hallway through to the north side of the church.

Sergeant Scott then asked Sergeant Fitzgerald and I to process the Ford F-150, of which I was advised belonged to the decedent.

Beneath the awning, I observed a grey colored Ford F-150 [REDACTED] The vehicle was facing westward was unlocked. I observed the front passenger door to be open, which was nearest to the building. I also observed the bed cover, which was extended in the open position, as well as the tailgate of the vehicle to be opened. Multiple items of what appeared to be gym equipment were observed in the back of the vehicle, as well as near the entrance to the building on the southern side of the business. The keys to the vehicle were observed on the tailgate, on the driver side of the vehicle. Through the open front, passenger side door, I observed a black colored wallet located on the front passenger seat, an Apple iPhone located in the dash of the vehicle, just above the radio, and a yellow colored handbag located on the floor in the center of the front seats of the vehicle.

Using a Nikon D800 digital camera and Speedlight external flash unit, I took digital photographs of the vehicle, including overall, mid-range, and close up views.

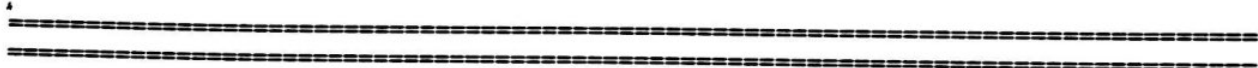


I collected the following item of evidence:
