ON 01-18-08, I RESPONDED 5565 WEST IRLO BRONSON HIGHWAY #508, IN REFERENCE TO A COMPLAINT OF ON GOING DRUG SALES FROM THE ROOM. UPON ARRIVAL, I ALONG WITH D/S BARDIS, MADE CONTACT WITH A BLACK FEMALE, MICHELLE GILLIAM. MICHELLE WAS INFORMED FOR THE REASON OF OUR PRESENCE AND EXPLAINED ON LY HER AND HER DAUGHTER WERE PRESENT. SHE THEN AGREED VERBALLY TO ALLOW US TO SEARCH. WHILE CONDUCTING THE SEARCH, I HEARD NUMEROUS NOISES FROM THE BATHROOM. UPON MAKING CONTACT AT THE BATHROOM WITH A BLACK MALE, PIERRE EVANS, I HEARD THE SOUND OF THE TOILET FLUSHING.

AFTER HE EXITED THE BATHROOM, I EXPLAINED TO HIM ASWELL THE REASON FOR US BEING PRESENT. PIERRE STATED HE HAD NOTHING ILLEGAL ON HIM AND CONSENTED TO A SEARCH OF HIS PERSON. UPON SEARCHING PIERRE, A CUT DOWN CIGAR TUBE WAS LOCATED ON HIM. INSIDE OF THE CIGAR TUBE WERE SEVERAL SMALL TRACE AMOUNTS OF SUSPECTED COCAINE. A PRESUMPTIVE FIELD TEST VERIFIED THE ITEMS TO BE COCAINE. PIERRE WAS PLACED UNDER ARREST FOR POSSESSION OF COCAINE AND POSSESSION OF DRUG PARAPHERNLIA, PURSUANT TO F.S.S 893.13(6)A AND F.S.S893.147(1).

D/S BARDIS CONDUCTED A SUBSEQUENT SEARCH OF THE ROOM, VIA THE VERBAL CONSENT GIVEN EARLIER FROM MICHELLE. IN THE NIGHTSTAND DRAWER HE LOCATED A SINGLE PIECE OF SUSPECTED CRACK COCAINE, ALONG WITH SEVERAL PIPES, COMMONLY USED FOR THE INTRODUCTION OF COCAINE INTO THE BODY VIA INHALATION AND SEVERAL HAND ROLLED CIGARETTES WHICH CONTAINED CANNABIS. THE SUSPECTED CRACK COCAINE WAS TESTED USING A REAGENT TEST, WHICH VERIFIED THE PRESENCE OF COCAINE. A REAGENT TEST ALSO VERIFIED CANNABIS WAS CONTAINED WITHIN THE HAND ROLLED CIGARETTES.

ALL ITEMS WERE ENTERED INTO EVIDENCE AT THE OSCEOLA COUNTY SHERIFFS OFFICE.

ALSO NOTED WERE THE CONDITIONS IN WHICH MICHELLE AND HER 11 YEAR OLD CHILD WERE LIVING IN. AT BEST COULD BE CONSIDERED DEPLORABLE. THERE WAS OLD FOOD LEFT ON THE SINK, WHICH APPEARED TO HAVE BEEN THERE FOR SEVERAL DAYS. THE ROOM HAD A FOUL STENCH, FROM OVERFLOWING GARBAGE AND ROTTEN FOOD. THERE WERE SEVERAL COCKROACHES AND OTHER INSECTS OBSERVED WHILE IN THE ROOM. AN OVER FLOWING PILE OF DIRTY CLOTHESMIXED IN WITH SOMEWHAT CLEAN CLOTHES, ALL WERE STACKED ON THE FLOOR. INSIDE OF THE REFRIDGERATOR WERE NO OBSERVED DRINKS, ONLY MOLDED OVER SPOILED FOOD. THE ONLY FOOD VISIBLE WHICH WAS POSSIBLY OK TO CONSUME WAS A FEW CANS OF SOUP AND ONE CAN OF OATMEAL.

THE JUVENILE WAS RELEASED TO HER FATHER, TONY MCNAMEE, WHO WAS NOT PRESENT AT THE TIME OF THE CONTACT. DCF WAS NOTIFIED VIA FAX.

BASED ON THE ABOVE, MICHELLE WAS ALSO CHARGED WITH CHILD NEGLECT, PURSUANT TO F.S.S 827.03, FOR FAILING TO PROVIDE A RESIDENCE WITH NORMAL LIVING CONDITIONS FOR HER CHILD, WHICH WOULD INCLUDE FOOD, WATER, AND NO SAFETY HAZARDS WHICH WERE CLEARLY PRESENT IE: CRACK COCAINE AND SEVERAL PIECES OF PARAPHERNALIA.

NOTE PIERRE IS CURRENTLY OUT ON BOND, FOR VIOLATION OF PROBATION, RELEASED 01-18-08. HE WAS HELD WITH A NO BOND STATUS*

BOTH WERE TRANSPORTED TO OSCEOLA COUNTY CORRECTIONS.

The children ran up to Mr. Seoane and gave him a hug.

The children immediately asked Mr. Seoane where Stacy was at. Mr. Seoane did not answer

Mr. Seoane did not answer and started to show the children what he brought for the visit.

During the Visit:

Brief description of the activities during the visit:

Mr. Seoane brought toys (mouse trap, nerf gun, coloring books, legos and some painting activities). Mr. Seoane also brought the children McDonalds to eat.

Mr. Seoane asked the children how they've been doing and if they have been going to school.

The children didn't respond to Mr. Seoane.... Mr Seoane asked the children again and once again they did not respond..., Mr. Seoane noticed that the children weren't responding to the questions that he was asking and then asked the children if they was okay or if they was scared to answer any of the questions. Andrew responded with no, and said that "he just didn't remember".

Mr. Seoane asked the children where they have been spending most of their time at and Andrew responded that they have been spending majority of their time at home and that they have been hanging around with Neil and his Kids.

Mr. Seoane asked the children if they have been spending time with Michelle, Andrew responded with no. Mr. Seoane also asked they children if they have been going over to Michelle's house and Andrew responded with no.

Mr. Seoane asked the children who has been taking care of them and the children responded that their mother (Mrs. Seoane) was taking care of them. Mr. Seoane asked if anyone else has been taking care of them and they both responded with no.

Mr. Seoane asked the children if they have been liking school and if everyone is being nice to them, they responded with yes. Mr. Seoane also asked the children if the teachers have been nice to them as well and they said yes.

Mr. Seoane asked the children if they have seen Sophia, both Andrew and Anna said no and that she wasn't allowed to come over anymore. Mr. Seoane asked why and Andrew responded that she wasn't allowed to come over anymore because of the incident that happen the last time they were around her. Mr. Seoane asked Andrew to tell him about the incident (this was documented in the observation report filed on 9/17/2023).

Andrew told him that there was a fight that had happen, but he said that he didn't see the fight or any blood (this version was different than the version documented on 9/17/2023) and that someone had told him about the fight.

Andrew then told Mr. Seoane that he had hurt his back from riding/falling off of his bike and then showed him the bruises/scabs on his lower back. Mr. Seoane asked if he was okay and Andrew said that he was fine. Mr. Seoane also asked Andrew if anyone had told him to show him the bruises on his lower back and Andrew responded with no.

Mr. Seoane then asked Andrew and Anna if they wanted to start painting, Anna responded with yes, and Andrew said no. Mr. Seoane asked if he wanted to make something to hang in his room and then asked Andrew if he had his own room, Andrew responded yes, and said that he has his own room.

Mr. Seoane then asked Andrew if he knew the difference between a lie and the truth. Andrew responded with yes, he does. Mr. Seoane then asked Andrew if the things that he has been telling

Mr. Seoane was the truth and Andrew responded with yes. Mr. Seoane then asked Andrew if he was scared to tell him certain things that goes on at the house. Andrew did not respond verbally but he did nod his head yes. Mr. Seoane then asked Andrew why he was scared. Andrew responded that he didn't want to get in trouble. Mr. Seoane told Andrew that he wouldn't get in trouble if he told him truth. Andrew sat quietly. Mr. Seoane asked the children if they wanted to play outside. While outside, Mr. Seoane tried to give equal time to each child (pushing Anna on the swings and play catch with Andrew). Mr. Seoane then spoke to Andrew and told him that he would not get in trouble if he told him the truth. Mr. Seoane asked Andrew if anything has been going on. Andrew told Mr. Seoane that there have been "Bad things" that have been happening at Michelle's house, Mr. Seoane asked Andrew what has been going on. Andrew said that they have been "smoking weed" at Michelle's house. Mr. Seoane asked Andrew how often they have been at Michelle's house and Andrew responded with "they go over there often." Mr. Seoane asked Andrew if he has been around them while they have been smoking and Andrew said "yes" and that Michelle smokes in the kitchen while he is in the living room and he can see her smoking. Mr. Seoane then asked if Andrew has ever been left alone with Michelle and Andrew responded with no and that Mrs. Seoane has always been around.

Mr. Seoane then asked if anyone other than Michelle smokes and Andrew responded with no. After being outside for a while, Mr Seoane picked up Anna and carried her inside. While holding her, Mr. Seoane asked if anyone else has been picking Anna up or holding her. Anna said no, and that only Mrs. Seoane picks her up.

Once inside, Mr. Seoane asked Anna and Andrew what they wanted to do. Anna said painting and Andrew said play with legos. While playing with legos, Mr. Seoane asked Andrew if he had been sick last week. Andrew said yes, he was sick. Mr. Seoane then asked if Andrew had gone to the doctors. Andrew said no, and that he took medicine that they had at home. Mr Seoane then asked Andrew what was wrong with him, and Andrew said that he had gotten an ear infection.

Mr. Seoane then asked Andrew if he went to school; Andrew said no and that he missed two days. Mr. Seoane asked Andrew who had taken care of him while he was sick. Andrew said Mrs. Seoane. Mr. Seoane then asked if he was telling the truth and Andrew responded with yes. After painting and playing with legos, Mr. Seoane took pictures with the children. While cleaning up, Mr. Seoane asked Anna if she had eaten any breakfast. Anna said yes, she had chocolate pancakes.

At the near end of the visit, Mr. Seoane asked the children to take one more photo together before they leave. While taking the photo, the children noticed that Mr, Seoane didn't have his cell phone and started ask him questions about it. Mr. Seoane just responded that he no longer has a cell phone. While waiting, Mr. Seoane asked the children if they have gotten punished or spanked. Andrew told Mr. Seoane that sometimes he would get put in the corner if he's in trouble and then told Mr. Seoane that sometimes Neil would hit him on the hand if he misbehaves.

Mr. Seoane then asked Anna if she gets hit or get punished and she responded with no.

Mr. Seoane then told the children that everyone misses them and asked if anyone was talking bad About his family, Andrew and Anna both responded with no.

Mr. Seoane noticed that Andrew had money and asked where he had gotten if from, Andrew told

Mr. Seoane that he didn't know. Mr. Seoane then asked Andrew if anyone has given him money and Andrew said yes, He has gotten money from one of Neil's kids. He then asked if Neil's kids has put his hands on Andrew and he responded with no.

Mr. Seoane then asked Andrew where he has gotten the marks on his back again. Andrew told Mr. Seoane that he had hurt his back from the swings (which was different from the first story That was told)
