The International Police Commission (IPC-PHILCOM), is a Global Organization duly recognized by the International Court of Justice (ICJ), International Criminal Court (ICC), and the United Nations- Department Economic Social Affair (UN-DESA) that has an equal separate covenant from its three (3) Departments, that the IPC hereby provides Accreditation/Authority and allow our Special Operative Officers Member of the IPC Global Command to hold an office abroad at the same manner limited base in Argentina, as representative as regular members in our organization are authorized to perform the functions within IPC Mandate, that our primary Objectives of the IPC-Global Command, will show case the International General Mandate & Primary Function as it is being practiced the role of the IPC Globally.

That their works for this organization similar to the Intelligence Network as Paramilitary Functions, which under the Non-governmental Organization to oversee the whole country in Argentina, that their Duties and Responsibilities shall only perform under the bounce of the Law as parallel group and freelancer to work independently in support to the Argentina Government.

The IPC accepts responsibility through the act of voluntarism for the cause of actions and make the necessary role of an Intelligence Standards to include all public outlets and web log entries. That the IPC acknowledges and understands that the Argentina National and/or any Troop Contributing Nation is not responsible nor is liable for any actions of the IPC which result in death, injury or declaration of missing status while embedded with all Friendly Forces in a hostile combat environment. Our IPC Operatives assumes full responsibility by providing his/her own medical, evacuation, life and repatriation insurance coverage while in a hostile combat environment.

The IPC hereby accepts responsibility for providing notification of next of kin and any necessary arrangements that will facilitate the general welfare of our IPC Operatives. Also allowed to conduct Humanitarian services to the community public specially during the time of calamity disaster.

GENERAL MANDATE & PRIMARY FUNCTION OF THE IPC-PHILCOM:

- ★ To ensure peace and order by making certain that all local and international laws, declaration and ordinances relative to the protection of lives and properties are enforced.
- ★ To investigate and prevent the possible crimes, and to guarantee the availability of specializations such as, but not limited to sharing of valuable data and information, fostering international cooperation for joint operations and monitoring international development that they may lead to future needs.

VISION:

To serve as catalyst for a peaceful global environment providing worldwide services essential for private entities, governmental authorities and law enforcement agencies assisting in crimes resolving in crimes against humanity.

MISSION:
