Letter from Marvin Louis Guy:

Minister Nick Gentile,

The problem with this case is they don't want to confront the real issue as to what happened on May 4, 2014 on Circle M. Drive (where Marvin lived) there in Killeen, Texas. To sum it all up in the "Raw," the Killeen Police Department came to my apartment like a "hit squad" to pull me out without an announcement while a friend and I were sleeping. I don't know what to do in a situation like that; I had no idea it was the police and that's what these operations are for; to shock the system/mind. This affadavit never states or gets any information or facts of criminal activity at my apartment or car; something that has to happen for a judge to issue a warrant.

Here's what was being said by officers:

They were doing this raid for one of their fallen brothers, who just 11 months prior was in this type of crossfire, and officers got shot by their own officers.

After that incident, the leadership didn't train these officers. I was targeted for some get back. Since the Sargeant that called the raid, promised me 3 years earlier he would get me one day, this was his day to make good on his promise. Even when you read the statements made by the cops you can see that nothing lines up. The bottom line is that they shot and killed this police officer and shot the rest of these officers in a crossfire, but want to pin it on me. I mean how would it look to the public that the police violated my human rights like they did; it was a brutal attack on our liberty and a long way from lawful. You have seen, as have as I have seen, them serving what I believe to be an invalid warrant. One of the officers stuck a gun in my mouth, calling me "Nigger," saying how much he " ...wants to kill my black ass." Asking the other officers "What do you want me to do with this Nigger?" One of the officers there said "Hold it; you need to get off of him now." I then heard another say, "Look, I don't give a fuck, kill him," and another officer said, "No, shake him down." At that point this officer committed an act of sodomy by putting his finger in my ass and asking me "Where are the drugs?" At that point, the officers got him off of me. I'm standing there believing that this is a dream, with my basketball shorts and underwear around my ankles. One officer came and picked me up from the ground, pulled up my underwear, but left my shorts around my ankles, and walked me to a police car. Everything happened so fast, I didn't know at the time of my arrest what was really going on. Then pops up the same Sargeant, who 3 years prior said he would get me one day, and it was then that I realized that I had been set up by this Sargeant, my apartment was targeted, and these officers were put up to do it. They were played by this Sargeant. Most of the officers on the frontlines were black. In one interview I heard the A.A ask one of the officers how did the black officers end up in the key points when there were better trained officers there. He just said he didn't know why and just that the situation kept changing; but they're telling so many lies. So they shot the two officers in a crossfire. Now they don't want to talk about it.

All of these acts of brutality, savagery, viciousness, and inhumanity are hard for me to understand. Even more it's the fact that they're willing to LIE on the S.W.A.T Team Leader about

what he was told before the raid by the Sargeant that approved this raid; who by the way liked to ride in the back, even though a Sargeants job is to ride in the front. His job is to be the first one there and the last one to leave; however, this Sargeant lacked leadership and the Department was not training the officers properly. Like I said, I haven't shot anyone, but I'm being labeled a drug dealer by these corrupt lawyers in a case that involves no drug sales. In addition to the drugs, I believe my corrupt attorney's asked the D. A. to bring in my case 2 1/2 years later. So I sat down and asked, "Why didn't you object to them bringing drugs into my case?"
