#### NARRATIVE

On October 17th, 2020 at approximately 2342hrs, Officer Kevin Malone, DSN 11092, and I received a radio assignment for a "Flourishing" at 17 North Boyle Avenue. The caller stated she was walking to her vehicle when (3) three unknown black male subjects exited a silver vehicle and pointed guns at her, (Nothing further).

Upon arrival, I was met by Victim **SPECIAL VICTIM** who stated the incident took place at 1937 Park Avenue on the sidewalk in front of Frontenac Cleaners West End.

Victim **SPECIAL VICTIM** stated she left Pop's Restaurant at approximately 2215hrs and was walking west on the north sidewalk of Park Avenue to her vehicle. Victim **SPECIAL VICTIM** stated while stopped waiting for traffic to clear so she could safely cross the street at the intersection of Mississippi Avenue and Park Avenue, a silver (4) four door sedan with no front license plate stopped in the intersection and (3) three unknown black males quickly exited the vehicle.

Victim **SPECIAL VICTIM** stated (2) suspects exited the rear of the vehicle and (1) one suspect exited the front passenger seat. Victim **SPECIAL VICTIM** advised (1) one unknown and undescribed subject remained in the driver's seat of the vehicle for the entirety of the incident.

Victim **SPECIAL VICTIM** said the (3) three suspects ran towards her, at which time all (3) three suspects started pointing handguns at her, and cornered her against a wall. Victim **SPECIAL VICTIM** advised the suspects produced the handguns from inside their waistbands.

Victim **SPECIAL VICTIM** stated she was backed up against the west wall of Frontenac Cleaners West End at gun point. Victim **SPECIAL VICTIM** said the (3) three suspects continued to point their handguns at her and begin to grope her breasts and attempt to grope her buttocks with their hands. Victim **SPECIAL VICTIM** stated the suspects began talking about her breasts and her body in a sexual manner.

Victim **SPECIAL VICTIM** said (1) one suspect asked her why she had her lanyard, to which she replied she is an attorney in St. Louis and they should not harm her because she is not just an average citizen.

Victim **SPECIAL VICTIM** stated (1) one suspect then asked one of the other suspects if they should just leave her alone, to which the suspect said yes we should get out of here now.

Victim **SPECIAL VICTIM** stated the (3) three suspects quickly retreated to their vehicle and fled the scene northbound on Mississippi Avenue until out of sight.

Victim **SPECIAL VICTIM** advised she then went to her vehicle and proceeded to take her boyfriend food at his work before going home and contacting this Department.

Victim **SPECIAL VICTIM** advised she believed the suspects vehicle may have been a Honda Civic or a Chrysler 200 but she was not certain.

Reference is made to the original segment of this report; wherein victim SPECIAL VICTIM reported she was sexually assaulted by three, armed, black male suspects as she was standing in front of the business located at 1937 Park Avenue (Frontenac Cleaners West) after she left a neighboring wine bar (POP, 1915 Park) when they were closing for the night.

With all relevant information contained therein; please be advised of the following:

On Sunday, October 18, 2020, victim **SPECIAL VICTIM** was contacted by St. Louis Metropolitan Police Department (SLMPD) Third District Detective Laz, DSN 0732, who spoke with her via telephone, in an attempt to clarify the details of the incident and gain further knowledge which may assist with this investigation. During this interview, **SPECIAL VICTIM** informed Detective Laz she **SPECIAL VICTIM** was imbibing alcoholic beverages at POP when "last call" was announced. Accordingly, **SPECIAL VICTIM** gathered her belongings, to include a "carry out order" and left the bar. As she was walking to her vehicle she was accosted by the suspects.

SPECIAL VICTIM explained she attempted to contact this department via 911 emergency dispatch but was placed on hold. At this time, she decided she would bring her "carry out" food order to her boyfriend who was working at a nearby hospital (Cardinal Glennon Children`s Hospital). She dropped the food off to him and responded to her residence. Once at her residence, SPECIAL VICTIM continued to drink more alcoholic beverages and eventually contacted this department again, at which time an officer was dispatched and the original report was written.

**SPECIAL VICTIM** recalled being intoxicated when she left the bar, was unable to provide any further information to Detective Laz and believed we were "wasting our time" trying to solve this incident.

On Monday, October 19, 2020, SLMPD Third District Detective Wilmot, DSN 8040, and I responded to the scene of the referenced assault where we conducted an investigation. First, we responded to the Frontenac Cleaners West and inquired of the existence of surveillance cameras. We were informed the business did not, in fact, have any surveillance cameras as the exterior was equipped with bright security lights and the owner did not believe cameras were necessary.

We continued our investigation by searching for building exterior security surveillance cameras and located two on the exterior of the Polite Society Restaurant and Bar (1923 Park). Here, we spoke with staff members, who granted us access to their security system. During our review of the surveillance footage, we observed **SPECIAL VICTIM** exit POP with an unknown male and female. **SPECIAL VICTIM** began walking east on Park, while the unknown couple entered a full size, white, pickup truck. As **SPECIAL VICTIM** walked she was observed passing the cameras (which point east and west) at Polite Society, past the Frontenac Cleaners west and across Mississippi, without stopping. Additionally, she passed a SLMPD Substation wherein a marked unit was parked until moments prior

to when the incident was reported to occur. Further, she crossed Mississippi and continued west on Park without stopping. No oncoming traffic was observed and no assault occurred.

While watching this video, I observed **SPECIAL VICTIM** awkwardly walking, swaying and appeared to be struggling to maintain her balance. As she was walking she was continuously flipping her hair and appeared to be looking at her reflection in the storefront windows of the business on Park. She was carrying what appeared to be a large paper bag, typically used to transport "carryout" restaurant food. She walked directly in front of the camera and her attire was in full view of the camera; she was not wearing any type of lanyard on her person. I noticed busy vehicular and pedestrian traffic, to include individuals recreationally riding motorized scooters in the area. Also, the couple whom exited the bar with **SPECIAL VICTIM** followed the path of **SPECIAL VICTIM** by driving east on Park.

After viewing this footage **SPECIAL VICTIM** was contacted regarding the discrepancies between her statements in the original report, versus, the surveillance camera footage. **SPECIAL VICTIM** explained she was "blackout drunk," had gotten a tattoo earlier in the day, was unable to remember where she parked or how she "got home" and may have misspoke. She elaborated by stating she was concerned she may be terminated should her employer find out she drove in such an intoxicated condition.

Additionally, **SPECIAL VICTIM** explained she could not be sure if she had been in the Soulard, Lafayette Square or Central West End Neighborhoods during the evening as she responded to the location in which she remembered the incident to have occurred and did not recognize anything. Lastly, she was unable to say (with any certainty) where, when or if, the assault actually occurred. **SPECIAL VICTIM** again stated she did not want us to conduct any follow-up investigation.

I suspected this incident may have been fabricated but out of concern for future victims, I contacted victim **SPECIAL VICTIM** asked her to reflect on her report and contact me, one last time, regarding the validity of her report and details of the events of the evening. I attempted to arrange a meeting wherein an audio recorded version of her statement could be produced or, if she preferred, a written version could be sent to me through email via my SLMPD email account. **SPECIAL VICTIM** was provided my email address, SLMPD voicemail and SLMPD Central Patrol Division Station (CPD) phone number. She did not contact me using any of these avenues. I contacted her on two additional occasions and provided the same contact information. As of this writing she has not contacted me or any other officer. All correspondence was done using **SPECIAL VICTIM 566** cellular telephone number per the original report and the number in which **SPECIAL VICTIM 566** used to contact 911 emergency services.

To date, there have been no similar incidents occurring in the reported area.
