SUBJECT: Unalienable Constitutional Rights – Freedom of Religion

References: (a) The Constitution of the United States of America
(b) Department of the Army Form 71
(c) Army Regulation 600-20 P-2 (8) b. (1)

1. I am a living soul, a man, created by God, child of God, called by Mother and Father since born: Mark-Charles; genealogy of Bashaw. I am one of We The People and I stand firmly upon the land. On 08 September 2019, I contracted with the American People (We The People) on a Department of the Army Form 71, where I swore an Oath of Office to defend the Constitution against enemies foreign and domestic as a commissioned executive officer in the United States Army Medical Service Corps, so help me God. The American People have entrusted me to uphold this contract (DA71) as I was appointed a trustee. The American People are the beneficiaries of this contract. A failure to uphold my Oath of Office would result in a breach of contract and a complete loss of trust with the people.

2. As the man that I am, my lord and savior is Jesus Christ. He allows me to walk through the shadow of the valley of death. I do so without faith in medical immunizations, vaccinations, and/or injections. Instead, my faith "*belief*" is in Jesus Christ. As a defender of the Constitution for the United States of America, I have no issues with those who have faith in the aforementioned medical products, and I defend their rights to exercise their freedom of religion.

3. I request that my un-a-lien-able (unable to place a lien upon) freedom of religion rights, which are secured by the Constitution for the United States of America and DA71 (signed 09 September 2019), are not infringed upon by policy requirements/mandates to be immunized, vaccinated, and/or injected with chemical substances. Punitive mandates/requirements for these chemical substances are contrary to my faith in Jesus Christ. Jesus Christ has enabled me to walk through the shadow of the valley of death for 37 years of life since God created me, and I do not wish to be immunized, vaccinated, or injected with any of these so-called vaccines for so-called diseases that may be present in the valley of the shadow of death. These unalienable constitutional rights are my property and the property of all Americans.

4. I request the following from anyone who chooses to infringe, deny, and assign punitive actions based upon my un-a-lien-able religious rights:

a. Show me within my duties and obligations as the trustee of the Office of 1LT MARK CHARLES BASHAW where it states in writing that I, a man, signed away my God-given "unalienable" rights.

b. Show me within these duties and obligations as the trustee of the Office of 1LT MARK CHARLES BASHAW where it states in writing that I, a man, am property of another man.

c. Show me the contract where it states in writing that another man can administer property without right.

d. Show me where it states in writing that Service Members, who are men and women, sign away their constitutional rights upon entry of service and throughout service of protecting our Constitution against enemies foreign and domestic.

Definitions

SUBJECT: Unalienable Constitutional Rights – Freedom of Religion

DEFINITIONS

Man/Wo-Man: created by God. (Genesis 1:26-28 KJV)

Constitutional Rights: This term is given to a right that has been guaranteed by the United States of America Constitution that cannot be violated by laws or by Congress.

Trust Property: which is held in trust by the trustee for the beneficiary (i.e., The Constitution for the United States of America, all rights there in).

Trustee: who holds title to the trust property and is subject to equitable duties to manage it for the benefit of another, according to a set plan (Oath of Office, DA71).

Beneficiary: to whom the trustee owes equitable duties (supporting and defend the Constitution against enemies foreign and domestic) to manage the trust property for his benefit.

Trust: A fiduciary relationship regarding property subjecting the person with title to the property to equitable duties to manage the property for another's benefit (i.e., Constitutional Rights); the confidence placed in a trustee, together with the trustee's obligations towards the property for the benefit of the beneficiary.

Oath of Office: a promise made by an individual they will uphold and fulfill certain requirements, obligations, and duties of a position that they were either elected or appointed to (i.e., DA71 Oath of Office).

Unalienable: incapable of being alienated, that is, sold and transferred." **Black's Law Dictionary, Sixth Edition, page 1523:** You cannot surrender, sell or transfer unalienable rights, they are a gift from the creator to the individual and cannot under any circumstances be surrendered or taken. All individuals have unalienable rights.
