ECC Staff Members,

Thank you for your dedication and service at ECC. As a camp we are registering to be an official camp of the state of Connecticut. Due to this we have a new regulation that we must follow regarding camp staff. Please read this carefully and please feel free to ask any questions that you have. These are new regulations that our camp must abide by.

Each staff member MUST attach to their application:

- A physical examination, including a complete immunization history. Physical must be within thirty-six months prior to the date of arrival at camp.

**Staff member must be immunized against diphtheria, tetanus, pertussis, polio, measles, rubella (These are standard vaccines that you probably already have to attend public school ☺)

The physical examination requirement may be waived where such procedure is contrary to the religious beliefs of the staff member. A statement requesting such exemption shall be submitted annually and shall be kept on file at the camp. This statement shall be signed by a parent or guardian (If under 18 years old), shall include affirmation of church membership by an appropriate church authority (pastor), and shall grant permission to camp authorities to authorize physical examination or other appropriate measures when medical emergencies occur. The parent or guardian (If under 18 years old) shall certify that he/she accepts complete responsibility for the health of the staff member and that to the best of his/her knowledge the staff member is in good health.

CAMP WIDE RULES

- Staff will behave respectfully and always use appropriate language. Gossip will not be tolerated; your humbleness and approachability plays a part in this.
- Staff will not enter the camper or staff cabins of the opposite gender.
- Cell phones will be used only when needed. Campers are not allowed to have cell phones during camp and we must serve as examples of that. Campers are not to use worker phones.
- The camp is not responsible for lost or stolen items.
- There is no pushing in the pool.
- Staff must remain on property at all times unless authorized by camp director.
- Staff will attend morning devotions with counselors and nightly devotions with teen groups.
- Staff curfew is midnight.
- Any guests must be accountable to camp director and stay with designated group during their time on the property after prior approval from camp director.
- Any other rules that the camp director deem appropriate will also apply.

DRESS CODE POLICY: At ECC Summer Camp we desire to be a place free from the distractions of the world, including clothing that draws unnecessary attention to the individual. Modest clothing must be worn at all times. If improper clothing is worn, the staff member will be asked to change.

- We do not permit wearing halters, tank tops, tight clothing, or garments that leave a midriff, cleavage or undergarments exposed, including see-through garments.
- Shorts must be no shorter than fingertip length; skirts and dresses must be no shorter than 3 inches above the knee. Tights, leggings, yoga pants or other types of hosiery must be accompanied by shorts, skirt or dress of appropriate length.
- Clothing with offensive prints is not allowed. This includes writing on improper places, such as pant seats or clothing that is suggestive, has a double meaning or innuendo, or suggests inappropriate ideas.
- Girls must wear shirts over two piece bathing suits. Boys must be wearing shirts when outside of the immediate pool area.

Roles and Responsibilities

Our task as volunteers, first and foremost, is to be an example of Christ to the campers, as well as to each other. We are to exemplify this in front of our campers, in order for them to respond in the same way. We are to speak in love, to act in love, to teach in love, and to discipline in love.

Evening Speaker

The evening speaker's main responsibility is to oversee the spiritual needs of the camp. He will lead evening services and be available to talk to if counselors or campers have questions.

Staff

In addition to the above, your responsibility is to fulfill the tasks given by the cook, Bill, and the director, Alex and camp leader for the week. Workers will set an example to the camp by being punctual, working efficiently, and having positive attitudes in everything that they do. Staff are required to attend devotions every morning and evening. STAFF ARE REQUIRED TO PARTICIPATE IN ALL CAMP ACTIVITIES TIME PERMITTING.

Sports Director

In addition to the above, your responsibility is to lead the campers in a variety of activities which are to be prepared in advance. For the activities to be successful, it is very important that the leader learn how to spark interest and enthusiasm in the campers, as well as the counselors. Sports leader will be responsible for dividing the campers/staff into teams, allotting points through out the week and keeping track of the week totals.

Lifeguard

In addition to the above, your responsibility is to ensure the safety as campers in pool and lake area. It is important to be diligent and attentive. Staff are expected to participate in all camp activities as much as they are able and time permitting.

Music/Worship

The music and worship team will be responsible for leading music lessons for campers during the morning class rotation. Staff are expected to participate in all camp activities as much as they are able and time permitting.

Crafts

Staff working with the crafts teacher will help in set up and clean up of all craft rooms used that day. They are responsible to be present the entire time that crafts are going on and help in any way they are asked. Staff are expected to participate in all camp activities as much as they are able and time permitting.

Counselors / Group Leaders

The primary task of a counselor is to be responsible for the welfare and discipline of the campers. Any discipline issues that arise will go primarily to the counselor, then to the group leaders if necessary, and finally to the leaders of the camp. Counselors will also help group leaders in any way necessary during the Bible lessons/devotional, as well as being active and involved during all camp activities. The primary task of a group leader is to oversee the spiritual growth of the group. Group leaders will be responsible for teaching daily Bible lessons and leading devotionals. The curriculum is to be reviewed before the start of camp, both individually and with all the other group leaders. In addition, group leaders will serve as counselors, being responsible for the welfare of the campers, keeping discipline, being punctual, and following all camp rules. Counselors are expected to participate in all camp activities as much as they are able.
