FEES PAYABLE

Fees are payable to Cornerstone Learning Solutions Inc.

PAYMENT

A credit/debit will be required at the time of sign-up. You will not be charged until the last tutoring session of the week.

LATE PAYMENT

Failure to submit payments on time will incur a late fee of \$10. Please communicate any potential delinquencies to Cornerstone Learning Solutions Administrators, not the Tutor, to avoid a late payment fee.

CANCELLATIONS

Sessions canceled without giving 24 hours prior notice to the Tutor or our Office Staff shall be charged the full hourly rate unless otherwise noted per Admins approval. If the Tutor cancels a session for any reason, you will not be charged.

PREPAYMENT & REFUNDS

We accept prepayments. If you cancel a prepaid session for any reason, the prepaid amount will not be refunded but instead applied as a credit to the next session attended. However, if the Tutor cancels a session, you will have the option to either apply your prepayment to a future session or request a refund for the canceled prepaid session.

FEES PAYABLE
