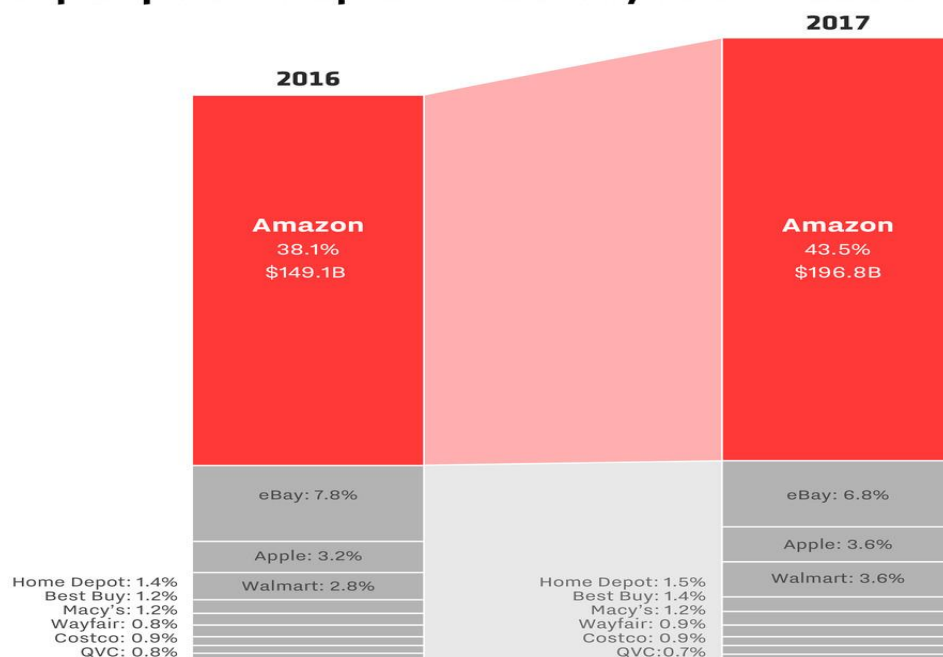
XAOS VISION

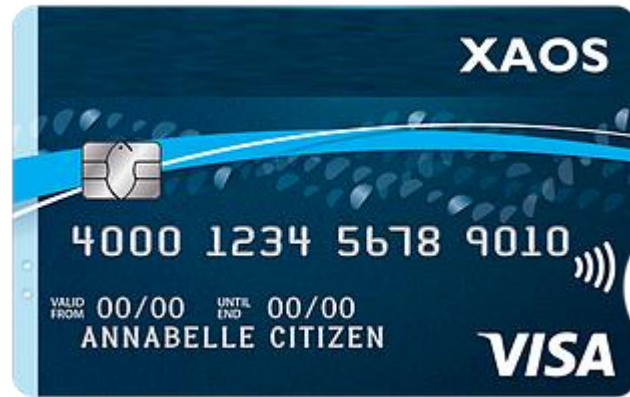
How it works

XAOS enables online transactions in locations out of the reach of the traditional banking industry.

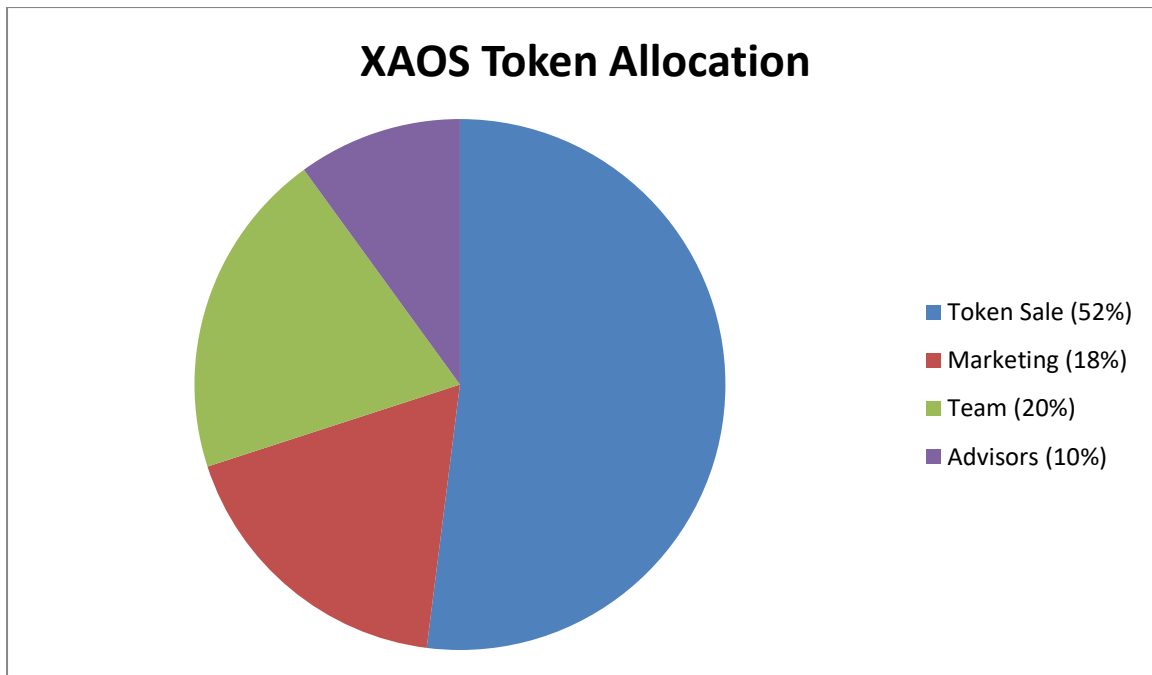

XAOS escrow exchange Affiliate program will be introduced

Spread the XAOS revolution and make money in the process! You will earn XAOS by referring other users to the exchange.

XAOS escrow exchange Affiliate program terms

- You can link to any individual page, such as country listing or payment method listing, or anything else on the XAOS exchange.
- You will earn XAOS from the users who 1) arrive to the exchange through your affiliate link 2) register and 3) make trades.
- A visitor will be considered as your affiliate for 3 months.
- Pay-outs will be paid daily to your exchange wallet as XAOS
- Commissions will be paid for one year from the user's registration. Commission will be based on the income the new user brings for the exchange (trading fees).
- Any foul play, such as misleading advertising will be forbidden.
- Spamming will be forbidden. Spamming includes sending unsubscribed private or public messages on forums/reddit, unsubscribed mass-mail, etc.
- Adding hidden iframes on a website in order to capture affiliates is forbidden. Only affiliate iframes or direct links to the webpage will be allowed.
- XAOS exchange will have the right to disable any affiliate user at any given time. If you breach the terms, your affiliate program will be terminated.

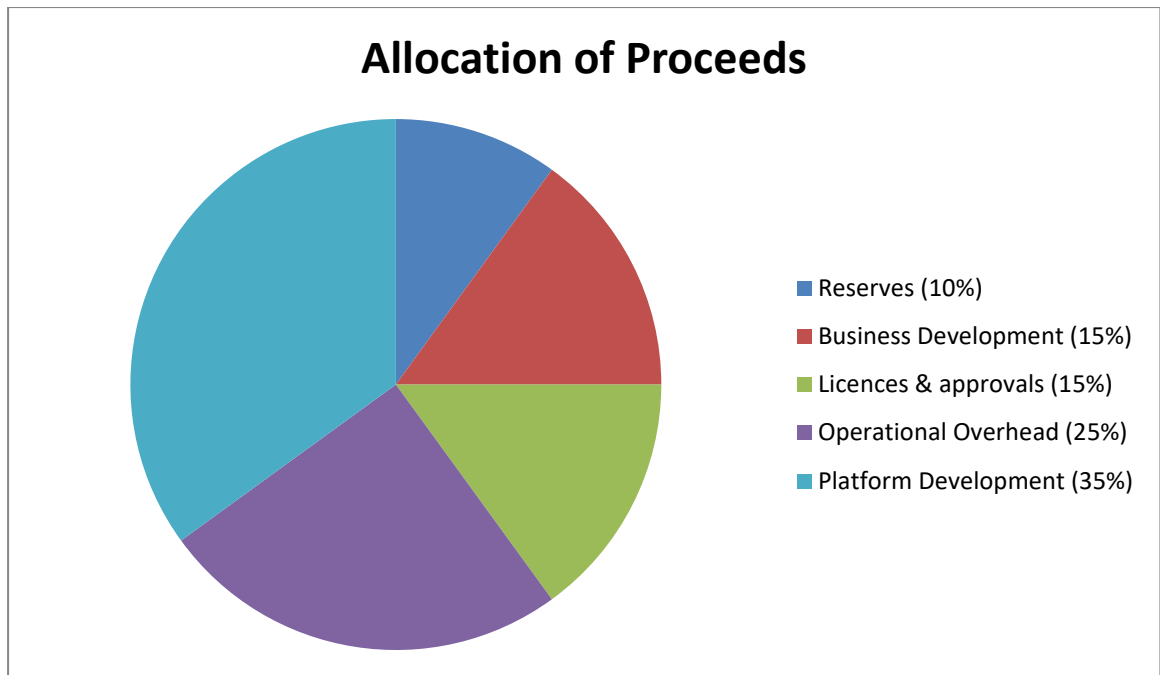


Team - 20% of XAOS tokens will be retained by XAOS and reserved for team, and founders who will continue to enhance the XAOS platform with valuable updates and their use of these tokens will also be time released.

Token Sale - 52% XAOS tokens are allocated for the entire token sale. Token sale will take place in two phases. Pre-Sale (8,000,000 XAOS + 20% Bonus) & phase two Crowd-Sale (10,000,000 XAOS No Bonus Applied).

Marketing – 18% of XAOS tokens will be allocated to market campaign and brand awareness activities including XAOS bounty program.

Advisors - 10% of XAOS tokens will be held by the early contributors and advisors. Advisors will receive tokens for the advisory work they will be doing for XAOS. These tokens cannot be immediately transferred due to time-based restrictions on their use.



Reserves - 10% of proceeds will go into reserve for any unforeseen expenditure.

Business Development - 15% of proceeds will go to further business development pursuits towards partnerships & new market opportunities.

Licences & approvals – 15% of proceeds will be used for obtaining licences & approvals in the appropriate sectors.

Operational Overhead - 25% of proceeds will be used for operational Overhead costs.

Platform Development – 35% of proceeds will be allocated to the Development of our all in one Platform.
