### **Get Pictures And Information**

The accident scene is full of evidence. You should never leave there without collecting as much as proof you can. The three most important things to take from the accident spot are,

1. photographs from every possible angle
2. witness names
3. witness contact numbers

When the time comes, you can give these to your accident lawyer Miami. They will know how to make the best use of the data you provide. Camera feature is ubiquitous in the cell phones today. Thus, clicking pictures immediately remains the last of your problem. Make the best use of technology when you need it the most. Things to photograph at this stage include,

- skid marks
- road conditions
- vehicle damage
- bodily injuries

Police also take required photographs and witness information during the enquiry process. While it also comes in handy for your accident lawyer in Miami, do not rely upon it only.
