

# PRIVACY POLICY

Please read the Privacy Policy carefully. This record is a fundamental element of the agreement between you (also referred to as the "Client") and SureInvest (also referred to as the "Organization").

The Privacy Policy describes the Company's standards of operation with respect to your own information. Personal information includes any information about the User that distinguishes him as an individual. This Policy further explains the use of personal information that we collect when you use our administration by talking to us by phone, email or other means. This Policy explains to you what data we collect, with whom we share it and for what purposes, how we do it, and what rights you need to protect the classification of your data.

SureInvest is not joking when it comes to protecting the personal information of its clients and protecting personal data. To avoid data loss, misuse, changes and unauthorized access to them by unauthorized persons, we agree with everything necessary, both official and specialized.

By accepting the Privacy Policy, the User agrees to the assortment, accumulation, use and disclosure of personal information in accordance with this Privacy Policy and relevant legislation. You can obtain your consent or request to delete your own information by contacting us.

## What personal information does the company collect?

You may provide us with distinctive evidence, contact, budget, and other details when you complete online structures or send us application structures by mail, as well as by phone, email, during approval in the Personal Account, or otherwise. Likewise, any personal information you provide to

situations when:

- use our items or administrations;
- register your entry on our website;
- subscribe to our mailing lists or third party mailing lists, specified with us;
- agree to receive our special materials and newsletters;

- participate in a test, loyalty program, unique achievements or studies;
- leave surveys.

Individual pages of the site may mention individual information that you can provide if you wish (for example, we may require contact details to register for a Personal Account, conduct advertising brochures and warnings from us, and / or you may submit applications to us).

When you visit our site, certain data is naturally sent to us from your gadgets. In some regions, including the European Union, such data may be considered customized under certain information security laws. Some of this data is collected using cookies. How may the Company use your own information?

- Sending you booklets;
- Proper organization of our administrations;
- Analyzing and understanding our crowd to improve the Service;
- Investigate violations of this Privacy Policy to ensure consistency and to protect our inclinations and rights.

We may send you promotional emails with information about our Services, which are of interest to us.

**Reasons why we will use your own information:**

1. To provide you with customer support. Information type: distinctive data (name, surname, country of residence, address and other comparative data), contact data (email address, telephone number, website page, courier number, etc.), archives of public identifiers (identification, identifier record, permission to accommodation, etc.), budget data (ledger number, bank card number and name of its owner, reports showing the starting point of cash, etc.), political

significance (reports and failures); descriptive data (duplicate records confirming data given away).

2. Risk administration, tax evasion, response to administrative and legal prerequisites. Type of information: valuable, monetary, personal.
3. Marketing. Type of information: contact, consent and correspondence. Reason: promotional exercises and the introduction of data and news about products and administrations. Legal basis: performance of a contract with you.

### **What data can an organization disclose to outsiders?**

We do not share data with organizations, associations or people outside the Company, unless one of the accompanying conditions applies: we will share your own information with organizations, associations or people outside the Company in the event that we firmly believe that the receipt, the use, storage or disclosure of personal information is essential to:

- Compliance with any significant laws, guidelines, requirements or government enforcement requirements;
- application of existing regulations, including verification possible violations;
- detecting, preventing misrepresentation, ensuring security or resolving specialized issues;
- protect the rights, property, or safety of the Company, our clients or people in general as vital or within legal borders.

We may share recognizable data openly and with our associates. For example, we may distribute data in broad daylight to show patterns in the general use of our site.

In the event that the Company is involved in consolidating, procuring or offering resources, we will continue to ensure the secrecy of any close to home information and advice to Users prior to individual information being moved or subject to a different security strategy.

We will not share your name, email address or other data other clients.

Under certain conditions, we may transfer your own

information to a third party in another country for further processing in accordance with the purposes set out in this Policy. Sometimes this may include exchanging information with countries that do not provide the same level of coverage as the laws in your country of residence. In such cases, subject to lawful conditions, we ensure that your security rights are adequately secured.

### **What rights does the client have?**

- You reserve the right to obtain a duplicate of the personal information we hold about you.
- You reserve the right to request that we correct incorrect data and/or complete inadequate personal information. We will refer to our records and notify outsiders to whom such close-to-home data may be moved, as described previously.
- You reserve the right to move in with someone else or request a copy of all information close to home that you have provided to us, after which we will transfer this information to another information controller at your discretion.
- You can use this privilege by clicking on the interface “revoke” or “recall” in promotional emails we send you.
- You reserve the right to request that we stop processing your own information. If this is not too much of an issue, please note that this may prevent you from using certain administrations for which preparing your own information is vital.
- You can withdraw your consent to the preparation of your own information at any time. This will not affect the lawfulness of the processing of information to which you have recently consented. If this is not too much of a problem, please note that in case you give your consent, this may  
  
prevent you from using some of the highlights of our  
  
administration that require the processing of your own information.
- You reserve the right to request that we permanently delete your information, and we will do so if there is no genuine motivation not to do this.

- You reserve the right to document objections to your supervisor.

### **Programmed dynamics**

From time to time, our use of your own information may result in the creation of programmed choices (including profiling) that legitimately affect you or that have an alternative type of significant influence on you. A programmed choice is your choice, made naturally based on the number of computers (using software calculations), without human control. When we apply a programmed choice that bothers you, you reserve the right to challenge that choice, communicate your point of view, and ask the person to reevaluate their choice.
