DRAFT RESOLUTION LEVYING PROPERTY RATES FOR THE FINANCIAL YEAR 1 JULY 2020 TO 30 JUNE 2021

Notice is hereby given in terms of section 14(1) and (2) of the Local Government: Municipal Property Rates Act, 2004, that the Council propose by way of a draft Council item number 4.1 that was tabled at a Special Council Meeting held on 28 May 2020 to levy the rates on properties reflected in the schedule below with effect from 1 July 2020.

*Rates levies will increase by 6%

The first R150 000 (R15 000 impermissible plus R135 000 reduction in valuation) for residential properties is deducted from the total valuation before rates are levied.

1 ELECTRICITY AND WATER TARIFFS

Increased electricity estimated (6.22%) and water (6%) tariffs will be effective from 1 July 2020.

Increased tariffs for sanitation (6.5%), refuse removal (6.5%) and other services (5%) rendered, or supplied will be effective from 1 July 2020.
